Freedom of Information (FOI) request - Access Decision

On 14 August 2019, the Department of Home Affairs (the Department) received a request for access to document under the *Freedom of Information Act 1982* (the FOI Act).

The purpose of this letter is to provide you with a decision on your request for access under the FOI Act.

1 Scope of request

You have requested access to the following document:

"I'm seeking two numbers as stated below as a and b. a. the number of candidates who submitted EOI for 189 visa on skill select meeting all of the following factors as at 29 April 2019.: 1. EOI submitted for accountant (ANZSCO Code: 221111), and 2. living in NSW; and 3. claiming points for skilled employment; and 4. total points above 85 b. the number of accountant (ANZSCO Code: 221111 EOI whose points are above 85 as at 29 April 2019."

2 Authority to make decision

I am an officer authorised under section 23 of the FOI Act to make decisions in respect of requests to access document or to amend or annotate records.
