**Freedom of Information (FOI) request - Access Decision**

On 14 August 2019, the Department of Home Affairs (the Department) received a request for access to document under the *Freedom of Information Act 1982* (the FOI Act).

The purpose of this letter is to provide you with a decision on your request for access under the FOI Act.

**1 Scope of request**

You have requested access to the following document:

1) *The total amount of 190 visa EOIs with 70, 75, 80, and 85 points in the SkillSelect system that were in "submitted" status and in "NSW" for the question "In which State or Territory would the client be interested in seeking nomination" for pro-rata occupation codes 261111 and 261112 meaning ICT Business and System analysts.*

2) *The total amount of 190 visa EOIs with 70, 75, 80 and 85 that were in "submitted" status and "Any" for the question "In which State or Territory would the client be interested in seeking nomination" for pro-rata occupation codes 261111 and 261112 meaning ICT Business and System analysts.*

**2 Authority to make decision**

I am an officer authorised under section 23 of the FOI Act to make decisions in respect of requests to access document or to amend or annotate records.
