**Freedom of Information (FOI) request - Access Decision**

On 19 August 2019, the Department of Home Affairs (the Department) received a request for access to document under the *Freedom of Information Act 1982* (the FOI Act).

The purpose of this letter is to provide you with a decision on your request for access under the FOI Act.

**1 Scope of request**

You have requested access to the following document:

*Total number of EOI (express of interest) submitted for 189 visa under the occupation civil engineering professionals ANZSCO code 233211 as single applicants that have not yet been invited.*

On 9 September 2019 you specified 19 August 2019 as the date of the data sought.

On 19 September 2019 you clarified your request to include all single applicants, that is, with the relationship status divorced, engaged, never married or widowed.

**2 Authority to make decision**

I am an officer authorised under section 23 of the FOI Act to make decisions in respect of requests to access document or to amend or annotate records.
