## Freedom of Information (FOI) request - Access Decision

On 22 August 2019, the Department of Home Affairs (the Department) received a request for access to documents under the *Freedom of Information Act 1982* (the FOI Act).

The purpose of this letter is to provide you with a decision on your request for access under the FOI Act.

## 1 Scope of request

You have requested access to the following documents:

"...I am looking for statistical data which shows total number of submitted EOIs on 65 points and above for all job occupations especially non pro-rata occupations .."

After consultation with you, your scope was revised as is as follows:

- As at 08 March 2019 (after 2:15am), number of subclass 189 EOIs in 'submitted' status for each 4-digit ANZSCO occupation with 65, 70, 75, 80, 85 points
- 2. As at 28 August 2019, number of subclass 189 EOIs in 'submitted' status for each 4-digit ANZSCO occupation with 65, 70, 75, 80, 85 points

## 2 Authority to make decision

I am an officer authorised under section 23 of the FOI Act to make decisions in respect of requests to access document or to amend or annotate records.

In reaching my decision I referred to the following:

- the terms of your request
