Freedom of Information (FOI) request - Access Decision

On 25 August 2019, the Department of Home Affairs (the Department) received a request for access to documents under the *Freedom of Information Act 1982* (the FOI Act).

The purpose of this letter is to provide you with a decision on your request for access under the FOI Act.

1 Scope of request

You have requested access to the following documents:

In the 3-year reporting period immediately preceding date of this FOI request:

1.1 Total number of subclass 600 visa applications made by an applicant, under the tourist stream only, presenting a passport from Thailand. Including the total number of applications granted, and total number of applications refused.

1.2 Total number of subclass 600 visa applications made by an applicant, under the tourist stream only, presenting a passport from Laos, Including the total number of applications granted, and total number of applications refused.

2.0 For the same reporting period. Total number of subclass 600 visa holders from Thailand and Laos, under the tourist stream only, identified by the Department for any level of non-compliance (breach, overstay etc).

On 30 August you agreed to change the scope as above and remove 'tourist stream only'.

On 4 September you agreed to limit your scope to statistics relating to the period of 01/07/2016 - 30/06/2019.

2 Authority to make decision

I am an officer authorised under section 23 of the FOI Act to make decisions in respect of requests to access documents or to amend or annotate records.

3 Relevant material

In reaching my decision I referred to the following:

- the terms of your request
- the documents relevant to the request
- the FOI Act
- Guidelines published by the Office of the Information Commissioner under section 93A of the FOI Act (the FOI Guidelines)
- advice from Departmental officers with responsibility for matters relating to the documents to which you sought access.

The Department has identified two documents as falling within the scope of your request. These documents were in the possession of the Department on 25 August 2019 when your request was received.
