**Freedom of Information (FOI) request - Access Decision**

On 02 September 2019, the Department of Home Affairs (the Department) received a request for access to documents under the *Freedom of Information Act 1982* (the FOI Act).

The purpose of this letter is to provide you with a decision on your request for access under the FOI Act.

**1 Scope of request**

You have requested access to the following documents:

*Total of EOI's in submitted status for 2339 Other Engineering Professionals with '75 points' and 'never married status' as of the following dates. 13th of March 2019 2nd of September 2019*

After consultation with you, your scope was revised as follows:

*Total number of subclass 189 EOI's in submitted status for occupation code 2339 with '75 points' and a 'never married status' as at 13th of March 2019 and 2 September 2019*

**2 Authority to make decision**

I am an officer authorised under section 23 of the FOI Act to make decisions in respect of requests to access document or to amend or annotate records.
