Freedom of Information (FOI) request - Access Decision

On 07 September 2019, the Department of Home Affairs (the Department) received a request for access to documents under the *Freedom of Information Act 1982* (the FOI Act).

The purpose of this letter is to provide you with a decision on your request for access under the FOI Act.

1 Scope of request

You have requested access to the following documents: What is the total staff turnover across the organisation for 15-16, 16-17, 17-18? What is the breakdown of staff turnover (for each capital city major airport and seaport) by work area and APS level? What is the breakdown by APS level for staff leaving i.e. other job, dismissed, resigned, contract expired etc.?

2 Authority to make decision

I am an officer authorised under section 23 of the FOI Act to make decisions in respect of requests to access document or to amend or annotate records.
