As requested here is an explanation of the Regional Occupation List.

Under the Temporary Skill Shortage (subclass 482) visa, employers in regional areas can access a total of 508 occupations, including 77 occupations which are available to regional employers only through the Regional Occupation List (ROL).

The ROL was introduced in March 2018 to provide regional employers with access to a greater number of skilled occupations. The ROL recognises that skills needs in regional Australia are unique and distinct from those required metropolitan cities. The ROL consists of 77 occupations ranging from skill levels 1 to 3.

The ROL is also available to the following visa subclasses:

- The medium term stream of the Temporary Skill Shortage (subclass 482) visa;
- The Skilled Regional (subclass 489) visa; and

- The Training (subclass 407) visa.
- Regional employers also have access to 673 occupations under the Regional Sponsored Migration Scheme, the largest number of regional occupations available for skilled migration.

In the March 2019 occupation list review, the number of additional occupations regional employers could access through the ROL increased:

- The lists are used to qualify potential migrants for various skilled migration visas.
- These lists underpin a range of employer-sponsored, points-tested and state-nominated visa programs.
- The purpose of the MLTSSL is to ensure the supply-driven component of Australia's skilled migration program is well targeted to highly-skilled migrants.

- These lists are mutually exclusive meaning that an occupation can only be on one of either MLTSSL, STSOL, or ROL at a point in time.
- For example, if an occupation is moved from the STSOL to the ROL, it would remove access to the occupation in certain metropolitan locations for both employers and state and territory government sponsors.
- The occupation lists are reviewed regularly based on the labour market analysis by the Department of Employment, Skills, Small and Family Business.

- The suitability of occupations for inclusion on the MLTSSL is assessed in a two-step process.
- First step considers the labour market analysis, which involves assessing the medium to long-term skill needs of the economy for each identified occupation to determine if it would benefit from skilled migration. Second step is a public consultation process and feedback from a range of industry stakeholders.
- For the Regional Sponsored Migration Scheme (RSMS) there are 673 eligible occupations. It is currently not subject to any labour market analysis?
