Freedom of Information (FOI) request - Access Decision

On 16 September 2019, the Department of Home Affairs (the Department) received a request for access to document under the *Freedom of Information Act 1982* (the FOI Act).

The purpose of this letter is to provide you with a decision on your request for access under the FOI Act.

1 Scope of request

You have requested access to the following document:

The number of EOIs in the 189 Skillselect system for each of the pro-rata ANZSCO grouping 2335 and the subgroup 233511 (Industrial Engineering) that have:

1- added their partners to their application and couldn't claim points because partners are not skilled

2- added their partners and claimed points for partner's skills

both at 65, 70,75, 80, 85 points and not have been invited as of 16 September 2019.

2 Authority to make decision

I am an officer authorised under section 23 of the FOI Act to make decisions in respect of requests to access document or to amend or annotate records.
