Freedom of Information (FOI) request - Access Decision

On 15 September 2019, the Department of Home Affairs (the Department) received a request for access to document under the *Freedom of Information Act 1982* (the FOI Act).

The purpose of this letter is to provide you with a decision on your request for access under the FOI Act.

1 Scope of request

You have requested access to the following document:

1. *Skill select, 189 visa EOIs Submitted, both Pro-Rata and Non-Pro Rata occupations at 65, 70, 75, 80, 85, 90, 95 & 100 points as at 11th September 2019*
2. *2211 Accountants 189 visa EOIs, submitted based on relationship status. At 80 points Never Married. At 80 points with Partner/Spouse. At 85 points Never Married with Work Experience points. & At 85 points with Skilled Spouse points*
3. *189 visa application undecided cases, both 189 point test stream & New Zealand stream as at 11 September 2019 with visa grants from 1st July 2019 to 11th September 2019*
4. *489 visas application undecided cases as at 11th September 2019 with visa grants from 1st July 2019 to 11th September 2019*
5. *190 visas application undecided cases as at 11th September 2019 with visa grants from 1st July 2019 to 11th September 2019*
6. *Employer-Sponsored and Regional Skilled Employer-Sponsored visa application undecided cases as at 11th September 2019 with visa grants from 1st July 2019 to 11th September 2019.*

On 25 September 2019 you clarified the dates of data sought as:

All visa grants I mentioned in the points from 01/07/2019 to 31/08/2019. In undecided cases I mentioned in the points as at 13/09/2019.

2 Authority to make decision

I am an officer authorised under section 23 of the FOI Act to make decisions in respect of requests to access documents or to amend or annotate records.

3 Relevant material
