Freedom of Information (FOI) request - Access Decision

On 9 October 2019, the Department of Home Affairs (the Department) received a request for access to document under the *Freedom of Information Act 1982* (the FOI Act).

The purpose of this letter is to provide you with a decision on your request for access under the FOI Act.

1 Scope of request

You have requested access to the following document:

For the 2018-19 period:

- 1) *Subclass 100, 300, 309, 801 and 820 visas granted by gender and broken down by primary and secondary applicants.*

E.g. primary applicants male; secondary applicants male; primary applicants female; secondary applicants female - for each of the visa classes listed above

- 2) *Subclass 482 (Temporary Skilled Shortage) visas granted by gender and broken down by primary and secondary applicants*

E.g. primary applicants male; secondary applicants male; primary applicants female; secondary applicants female. Also, the number of children that arrived as secondary applicants and

- 3) *Tourist Stream (apply in Australia) - broken down by gender (i.e. male/female). Tourist Stream (apply outside Australia) - broken down by gender (i.e. male/female).*

2 Authority to make decision

I am an officer authorised under section 23 of the FOI Act to make decisions in respect of requests to access document or to amend or annotate records.

3 Relevant material

In reaching my decision I referred to the following:

- the terms of your request
- the document relevant to the request
- the FOI Act
- Guidelines published by the Office of the Information Commissioner under section 93A of the FOI Act (the FOI Guidelines)
- advice from Departmental officers with responsibility for matters relating to the document to which you sought access
