**Freedom of Information (FOI) request - Access Decision**

On 14 October 2019, the Department of Home Affairs (the Department) received a request for access to a document under the *Freedom of Information Act 1982* (the FOI Act).

The purpose of this letter is to provide you with a decision on your request for access under the FOI Act.

**1 Scope of request**

You have requested access to the following document:

*Number of EOIs (Expressions of Interest) submitted for ANZSCO 263212 ICT support engineer for subclass 190 NSW visa on 75,80,85,90 points.*

On 11 November 2019 specified the date of the data should be for the date of your request, that is, 14 October 2019.

**2 Authority to make decision**
