**Freedom of Information (FOI) request - Access Decision**

On 21 October 2019, the Department of Home Affairs (the Department) received a request for access to document under the *Freedom of Information Act 1982* (the FOI Act).

*Number of EOIs which are in skill select system (Submitted) as at 21 October 2019 under NSW 190 category, ticked as preferred state "NSW or ANY", for below mentioned occupation codes. 2211 General Accountant 2212 Auditors Company Secretaries and Corporate Treasures and 132211 Finance Manager.*

*Please show three columns of 95 points, 100 points and above 100 points (Including state sponsorship points) for all three occupation codes and not just an aggregate EOIs totals.*
