Freedom of Information (FOI) request - Access Decision

On 23 October 2019 the Department of Home Affairs (the Department) received a request for access to a document under the *Freedom of Information Act 1982* (the FOI Act).

On 24 October 2019 the Department received a duplicate request which was initially registered as FA 19/10/01448. This was deregistered when it was discovered to be the same as FA 19/10/01357.

The purpose of this letter is to provide you with a decision on your request for access under the FOI Act.

1 Scope of request

You have requested access to the following document:

Information for 189 visa category with EOI application status as submitted for each of the below 3 scenarios:

1) No of Applicants with EOI in submitted status who are Single (Married and have No Partner Points) with 75 or 80 points (as per points system prior to new rules of Nov 16th 2019) with DOE less than 6th June 2019 for 2613 job code of 189 visa category.

2) No of Applicants with EOI in submitted status who are Single (Unmarried or Never Married) with 75 or 80 points (as per points system prior to new rules of Nov 16th 2019) with DOE less than 6th June 2019 for 2613 job code of 189 visa category.

3) No of Applicants with EOI in submitted status who have 80 points (as per points system prior to new rules of Nov 16th 2019) for 2613 Job code for 189 visa category and have DOE less than 6th June 2019.

On 20 November 2019 you specified that you requested data as at 24 October 2019.

2 Authority to make decision

I am an officer authorised under section 23 of the FOI Act to make decisions in respect of requests to access documents or to amend or annotate records.
