# Freedom of Information (FOI) request - Access Decision

On 28 October 2019, the Department of Home Affairs (the Department) received a request for access to a document under the *Freedom of Information Act 1982* (the FOI Act).

The purpose of this letter is to provide you with a decision on your request for access under the FOI Act.

### 1 Scope of request

You have requested access to the following document:

Visa category : 190 Skilled Migration Job category : 2339 Other Engineering Professionals Time : 01 July 2019 - 24 Oct 2019 Required Contents (for all 2339 invites) : Total points (including state nomination points), Date of invitation, English Proficiency Level.
