Freedom of Information (FOI) request - Access Decision

On 18 November 2019, the Department of Home Affairs (the Department) received a request for access to document under the *Freedom of Information Act 1982* (the FOI Act).

The purpose of this letter is to provide you with a decision on your request for access under the FOI Act.

1 Scope of request

You have requested access to the following document:

I would like to request access to the following information, Number of Expression of interests (EOI) in "Skill Select" system for visa subclass 189 in "Submitted" status, classified by point's category for occupation "Software Engineer", ANZSCO code 261313, as of yesterday ie 17/11/2019. So for example a summary of, say the below, as of 17/11/2019 for ANZSCO code 261313, in Skill select system for EOIs in SUBMITTED status, 75 points - x 80 points - y 85 points - z 90 points - a 95 points - b 100 points - c 105 points - d.

2 Authority to make decision

I am an officer authorised under section 23 of the FOI Act to make decisions in respect of requests to access document or to amend or annotate records.
