Freedom of Information (FOI) request - Access Decision

On 18 November 2019, the Department of Home Affairs (the Department) received a request for access to document under the *Freedom of Information Act 1982* (the FOI Act).

So for example a summary of, say the below, as of 17/11/2019 for ANZSCO code 261313 , in Skill select system for EOIs in SUBMITTED status, 75 points - x 80 points - y 85 points - z 90 points - a 95 points - b 100 points - c 105 points - d.

2 Authority to make decision
