### Freedom of Information (FOI) request - Access Decision

- 2) Total number of student visa applications received, approved, and refused in the FY2015/2016, FY2016/2017, and FY2017/2018 appointing a migration agent.
- 3) Total number of student visa applications received, approved, and refused in the FY2015/2016, FY2016/2017, and FY2017/2018 appointing an education agent.
- 4) Total number of student visa applications received, approved, and refused in the FY2015/2016, FY2016/2017, and FY2017/2018 appointing someone other than either a migration agent or an education agent.
- 5) Total number of student visa applications received, approved, and refused in the FY2015/2016, FY2016/2017 and FY2017/2018 without appointing any other person as agent/authorised recipient.

6) Total number of Subclass 600 visa applications received, approved, and refused in the FY2015/2016, FY2016/2017, and FY2017 /2018 as divided by points 2, 3, and 5 above, and divided by country of passport holder, and divided by stream.
