Freedom of Information (FOI) request - Access Decision

On 5 November 2018, the Department of Home Affairs (the Department) received a request for access to document under the *Freedom of Information Act 1982* (the FOI Act).

The purpose of this letter is to provide you with a decision on your request for access under the FOI Act.

1 Scope of request

You have requested access to the following document:

For Chinese passport holders, applying for subclass 600 visitor visa:

- 1) The total number of applications for Visitor visa (Subclass 600) which submitted by Chinese Passport holders and the applicants are in China by the time of visa application from 01/01/2017 to 31/12/2017;
- 2) The total number of refusal for a Visitor visa (Subclass 600) which submitted by Chinese Passport holders and the applicants are in China by the time of visa application from 01/01/2017 to 31/12/2017; and
- 3) The total number of applications for a Visitor visa (Subclass 600) which submitted by Chinese Passport holder and the applicants are in China by the time of visa application from 01/01/2018 to 31/10/2018; and
- 4) The total number of refusal for a Visitor visa (Subclass 600) which submitted by Chinese Passport holder and the applicants are in China by the time of visa application from 01/01/2018 to 31/10/2018.

2 Authority to make decision

I am an officer authorised under section 23 of the FOI Act to make decisions in respect of requests to access document or to amend or annotate records.

3 Relevant material

In reaching my decision I referred to the following:

- the terms of your request
- the document relevant to the request
- the FOI Act
- Guidelines published by the Office of the Information Commissioner under section 93A of the FOI Act (the FOI Guidelines) and
