MIGRATION REGULATIONS 1994 – JULY 2018 – INDEXATION OF VISA APPLICATION CHARGES – ITEM 2091

1. Please find attached the drafting instructions for item 2091 – indexation of visa application charges at Attachment A.
2. We propose to amend the *Migration Regulations 1994* (the Migration Regulations) to increase first instalment visa application charges (VACs), as decided by Government.
3. It is proposed that VACs will increase in accordance with the 2018-19 forecast consumer price index (CPI) as published in *Budget Paper No.1 2018-19*. This figure is expected to be included in the Budget Papers which will be tabled in Parliament on Budget night on 8 May. We will provide you with further drafting instructions relating to the required amendments to the VAC pricing once this information is available. It is currently anticipated that this information will be available in early May. In the interim, we have attached a list of the provisions of the Migration Regulations we anticipate will be affected by these amendments (see Attachment B).
4. We aim to have a settled draft of this item by 28 May 2018, for consideration at the Federal Executive Council on 21 June 2018. The amendments would commence on 1 July 2018. It is not intended that these amendments will be consolidated with other amendments.

MIGRATION REGULATIONS 1994 – JULY 2018 – INDEXATION OF VISA APPLICATION CHARGES – ITEM 2091

PURPOSE

1. The purpose of the proposed amendments to the *Migration Regulations 1994* (Migration Regulations) is to adjust first instalment visa application charges (VACs) from 1 July 2018.

BACKGROUND

The current situation and why we want to change it

2. Section 5 of the *Migration (Visa Application) Charge Act 1997* (the VAC Act) sets out a charge limit for visas (other than a contributory parent visa). Section 6 of the VAC Act sets out the charge limit for contributory parent visas.
3. Government has decided to index the first instalment VAC for the visas identified in Attachment B in accordance with the 2018-19 forecast consumer price index (CPI) as published in *Budget Paper No.1 2018-19*. The adjusted VACs need to be within limits provided for by the VAC Act.
4. In addition to the above, it will be necessary to index the second instalment VACs for the Subclass 189 (Skilled – Independent) visa in the New Zealand stream. This is because the visa was designed so that the total VAC payable by applicants in the New Zealand stream would be equivalent to the VAC payable by applicants in the Points Tested stream, but split between the first and second instalment VACs on a 20/80 basis (effectively a first instalment VAC split in two).
5. From 2017, the indexation of VACs became an annual measure, and similar amendments were therefore made in July 2017 by the *Migration Amendment (Visa Application Charges) Regulations 2017*. A copy of the amending regulations is attached for your information.

6. There are no constitutional, criminal, privacy, administrative law, merits review, judicial review or human rights issues associated with this amendment.

I have turned to the Policy intent narrative which has the following to say about the VAC:

Visa application charge

In line with the 2016 Government announcement, the Skilled Independent (subclass 189) (New Zealand stream) visa pathway was created within the Skilled Independent category of the General Skilled Migration (GSM) component of Australia's annual Migration Programme. The pathway is directly aimed at New Zealand citizens who have made, and continue to make, a demonstrated economic contribution to Australia, which is consistent with the GSM parameters.

The visa application charge (VAC) imposed on the New Zealand stream under the Skilled Independent (subclass 189), is the lowest of the range of skilled visas. Other pathways to permanent residence for New Zealand citizens under other skilled or family streams attract a higher VAC.

Further, in recognition of the special bilateral relationship, concessional arrangements to the VAC were introduced solely for the New Zealand stream. Applicants need only pay 20 per cent of the overall VAC at the time of application (as the first instalment of the VAC). The remaining 80 per cent of the overall VAC is charged as the second instalment of the VAC, which is only payable by the applicant before the visa is granted.

Visa application charges are considered taxes, there is not necessarily any nexus between the cost of providing the service and the setting of the charge. As such, the price of applying for a

visa is set by government. The amount of the VAC does not exceed the applicable charge limit set out in the *Migration (Visa Application) Charge Act 1997*.

I think the Policy Intent supports what is in your attachment that special arrangements were put in place to split the VAC 20% as the first VAC and 80% as a second VAC.


