## Freedom of Information (FOI) request - Access Decision

On 8 January 2019, the Department of Home Affairs (the Department) received a request for access to document under the *Freedom of Information Act 1982* (the FOI Act).

The purpose of this letter is to provide you with a decision on your request for access under the FOI Act.

#### 1 Scope of request

You have requested access to the following document:

For the period 14 August 2018 to 31 December 2018, Subclass 482 TSS - broken down by 1 year, 2 year, 3 year, 4 year nomination:

- 1) Number of Refused TSS Nominations where Sponsor applicant had less than \$10 Million turnover;
- 2) Number of Refused TSS Nominations where Sponsor applicant had greater than \$10 Million turnover;
- 3) Number of Withdrawn TSS Nominations where Sponsor applicant had less than \$10 Million turnover;
- 4) Number of Withdrawn TSS Nominations where Sponsor applicant had greater than \$10 Million turnover.

# 2 Authority to make decision

I am an officer authorised under section 23 of the FOI Act to make decisions in respect of requests to access document or to amend or annotate records.

## 3 Relevant material

In reaching my decision I referred to the following:

- the terms of your request
- the document relevant to the request
- the FOI Act
- Guidelines published by the Office of the Information Commissioner under section 93A of the FOI Act (the FOI Guidelines)
- advice from Departmental officers with responsibility for matters relating to the document to which you sought access

#### 4 Document in scope of request

In accordance with section 17 of the FOI Act, the Department has used its computer system to produce one document that contain[s] information that falls within the scope of your request. The data produced in the document existed in the possession of the Department on 8 January 2019 when your FOI request was received.

#### 5 Decision

The decision in relation to the document in the possession of the Department which falls within the scope of your request is to release one document in full.

## 7 Your Review Rights

#### Internal Review

The internal review will be carried out by an officer other than the original decision maker and the Department must make a review decision within 30 days.
