Summary of Victorian youth gang associates under cancellation consideration (as at 31 August 2018)

- Victoria Police have referred **58** non-citizens linked to Victorian youth gangs to the Department (**one POI has since been identified as being an Australian citizen**). These referrals were received between April 2016 and **August** 2018.
- The Department has identified another **six** non-citizens linked to Victorian youth gangs through media reporting and confirmed their links with Victoria Police.
- Of the **64** non-citizens linked to Victorian youth gangs:
 - 17** have been cancelled
 - 16** are under active cancellation consideration
 - 31** are not under active cancellation consideration (please see **Attachment A** for further information)
- The Department is reviewing cancellation processes in relation to minors, in discussion with Legal and Child Wellbeing.

- Victoria Police have referred 72 non-citizens linked to Victorian youth gangs to the Department.
These referrals were received between April 2016 and November 2018.
- The Department has identified another six non-citizens linked to Victorian youth gangs through media reporting and confirmed their links with Victoria Police.
- Of the 78 non-citizens linked to Victorian youth gangs:
 - 18 have been cancelled
 - 21 are under active cancellation consideration
 - 39 are not under active cancellation consideration (please see **Attachment A** for further information)
- The Department is reviewing cancellation processes in relation to minors, in discussion with Legal Division and Child Wellbeing Branch.

Summary of Victorian youth gang associates under cancellation consideration (as at 31 December 2018)

- Victoria Police have referred **75** non-citizens linked to Victorian youth gangs to the Department.
These referrals were received between April 2016 and **December** 2018.
- The Department has identified another **six** non-citizens linked to Victorian youth gangs through media reporting and confirmed their links with Victoria Police.
- Of the **81** non-citizens linked to Victorian youth gangs:
 - 20** have been cancelled
 - 19** are under active cancellation consideration
 - 42** are not under active cancellation consideration (please see **Attachment A** for further information)
- The Department is reviewing cancellation processes in relation to minors, in discussion with Legal Division and Child Wellbeing Branch.
