Freedom of Information (FOI) request - Access Decision

On 5 February 2019, the Department of Home Affairs (the Department) received a request for access to document under the *Freedom of Information Act 1982* (the FOI Act).

1 Scope of request

You have requested access to the following document:

How many invitation have been issued to each occupation under subclass 489, 190, 189 in 2018-2019 Financial Year.

After consultation with you, your scope was amended to:

The data which is required is for all the rounds held in from January 2018 till date. All the occupations for which the invitations were issued for taking from January 2018 till date.

2 Authority to make decision

I am an officer authorised under section 23 of the FOI Act to make decisions in respect of requests to access document or to amend or annotate records.
