The Department has received a consultation request from the University of NSW (UNSW) for a application for access to information under the *Government Information (Public Access) Act 2009* ('GIPA Act') that they are processing.

The UNSW has advised a summary of 21 research contracts between UNSW and the Department of Home Affairs was identified as being relevant to the request. The information within the scope of request has been attached. Please note that the FOI Section would like draw your attention to mainly to lines 8 and 10 of the summary and will advise the UNSW to consult with the DSS and the AGDs for the remained of lines on the summary.
