**Freedom of Information (FOI) request - Access Decision**

On 8 February 2019, the Department of Home Affairs (the Department) received a request for access to document under the *Freedom of Information Act 1982* (the FOI Act).

**1 Scope of request**

- 2) *Processing times for 189 applications.*
