Freedom of Information (FOI) request - Access Decision

On 8 March 2019, the Department of Home Affairs (the Department) received a request for access to document under the *Freedom of Information Act 1982* (the FOI Act).

1 Scope of request

You have requested access to the following document:

Documents containing information about the Illicit Tobacco Taskforce, including (a) any monthly progress reports for the taskforce from January 2018 until February 2019 and/or (b) yearly progress reports for the 2018 calendar year and (c) any requests or needs for additional funding for the taskforce.

2 Authority to make decision
