**Freedom of Information (FOI) request - Access Decision**

On 6 May 2019, the Department of Home Affairs (the Department) received a request for access to document under the *Freedom of Information Act 1982* (the FOI Act).

The purpose of this letter is to provide you with a decision on your request for access under the FOI Act.

**1 Scope of request**

You have requested access to the following document:

- 1) *Number of visa applications (subclass 188, business innovation and investment program stream), which countries they come from and how many have been granted since the entrepreneur visa was introduced in September 2016, broken down by year.*
- 2) *Number of entrepreneur visa applications there have been for the new entrepreneur visa being trialled in South Australia, which does not have the \$200,000 funding stipulation.*

**2 Authority to make decision**

I am an officer authorised under section 23 of the FOI Act to make decisions in respect of requests to access document or to amend or annotate records.
