**Freedom of Information (FOI) request - Access Decision**

On 27 May 2019, the Department of Home Affairs (the Department) received a request for access to document under the *Freedom of Information Act 1982* (the FOI Act).

The purpose of this letter is to provide you with a decision on your request for access under the FOI Act.

**1 Scope of request**

You requested access to the following document:

1. *Total number of New Zealand applicants (both primary and secondary) lodging 189 visa from 1/07/2018 to 27/05/2019.*
2. *Number of 189 visa lodged for occupation code 2211 (Accountants) and 2212 (Auditors, Company Secretaries and Corporate Treasurers) both primary and secondary applicants from 1/07/2018 to 27/05/2019.*

On 31 May 2019 you agreed to the revised scope:

1. *Total number of New Zealand applicants (both primary and secondary) lodging 189 visa (New Zealand pathway stream) from 1 July 2018 to 30 April 2019.*
2. *Number of 189 visa (points tested stream) lodged for occupation code 2211 (Accountants) and 2212 (Auditors, Company Secretaries and Corporate Treasurers) primary applicants only (unable to report on occupation data for secondary applicants) from 1 July 2018 to 30 April 2019.*

## 2 Authority to make decision

I am an officer authorised under section 23 of the FOI Act to make decisions in respect of requests to access document or to amend or annotate records.
