Data Notes:

- This information is provided by the Department of Home Affairs and was extracted from departmental systems on 07 January 2019. As data has been drawn from a dynamic system environment, the information is correct at the time of publication and figures may differ slightly from previous or future reporting.
- Visas counted include subclass 200 (Refugee), 201 (In–Country Special Humanitarian Program), 202 (Global Special Humanitarian Program), 203 (Emergency Rescue) 204 (Woman at Risk), 866 (Permanent Protection), 785 (Temporary Protection) and 790 (Safe Haven Enterprise).
- Subclasses 451 (Secondary Movement Relocation Visa) and 447 (Secondary Movement off-shore Entry Visa) were repealed in 2008. Data Division do not hold data indicating any applications since then.
- Statistics for the offshore component up to 2018–19 are based on country of birth. From 2019–20 they are based on citizenship. The Country of Birth or Citizenship of the principal visa applicants is applied to secondary visa applicants.
- The onshore component reports on an applicant's citizenship.
- For the offshore component, the religion of principal visa applicants is applied to secondary visa applicants. Religion is self-identified and as declared on application and may include generic responses.
