Of the Temporary protection (subclass 785) and Safe Haven Enterprise (790) visa outcomes of either grant or refusal made between 1 July 2017 and 30 June 2018, 84 percent were represented by a migration agent pursuant to a Form 956. In the following year (1 July 2018 – 30 June 2019), 79 percent were represented by a migration agent pursuant to a Form 956
