Questions

I request access to documents providing statistics and information on Partner processing times for applications decided in program year 2019/2020.

Specifically, but not confined to the following:

- 1. Subclass 309 applications:
- a. Breakdown in time frames from application to grant of subclass 309 visas, for example number and percentage less than 6 months, number and percentage in 6-12 month time frame, number and percentage in 12-18 month time frame, number and percentage in 18-24 month time frame, number and percentage in 24 plus time frame.
- b. Shortest processing time frame in which a subclass 309 visa application was decided in the 2019/2020 migration program year; together with distinguishing details such as country of passport and age.
- c. Longest processing time frame for a subclass 309 visa application to be decided in the 2019/2020 migration program year; together with distinguishing details such as country of passport and age.

2. Subclass 820 applications:

- a. Breakdown in time frames from application to grant of subclass 820 visas, for example percentage less than 6 months, percentage in 6-12 month time frame, percentage in 12-18 month time frame, percentage in 18-24 month time frame, percentage in 24 plus time frame.
- b. Shortest processing time frame in which a subclass 820 visa application was decided in the 2019/2020 migration program year; together with distinguishing details such as country of passport and age.
- c. Longest processing time frame for subclass 820 visa application to be decided in the 2019/2020 migration program year; together with distinguishing details such as country of passport and age.
