On 24 November 2020, the Department received the following FOI request:

- 1) The number of refugee and humanitarian visas granted in each year since 2013 to applicants residing in Indonesia where the primary applicant registered with the UNHCR in Indonesia on or after 1/07/14.
- 2) A breakdown of what their country of citizenship was.
- 3) A breakdown of which visa subclasses were granted.

The date an applicant registered with UNHCR is not captured in departmental systems in a reportable format. Manual interrogation of departmental records would be required to provide this information. It would not be reasonably practical for the Department to provide statistics where the primary applicant registered with the UNHCR in Indonesia on or after 1/07/14.

The statistics provided in the below tables includes all applicants located in Indonesia that were granted visas, regardless of if or when they registered with UNHCR.
