Freedom of Information Request FA 21/02/00709

- Visa applications lodged for subclass 601 for each month between 01 July 2020 and 11 Feb 2021 via AustralianETA mobile app or otherwise:
 - 4083 ETA applications were received between 1 July 2020 and 31 January 2021. Refer to table below for a breakdown of applications by lodgement channel, month and outcome.
- Visa applications automatically determined (grant/refusal) for subclass 601 for each month between
 01 July 2020 and 11 Feb 2021 via AustralianETA mobile app or otherwise:
 - 2098 ETA applications were automatically granted (2092 through the AustralianETA mobile app, and 6 otherwise) between 1 July 2020 and 31 January 2021. Refer to table below for a breakdown of applications by lodgement channel, month and outcome.
 - Note that there is no automatic refusal process for an ETA. Any decision to refuse an ETA is made by a visa delegate on a case by case basis. If an ETA is unable to be granted automatically, the traveller may receive an error outcome (for example, passport is ineligible for an ETA) or a 'referred to visa office' outcome.
- Visa applications referred for review for subclass 601 for each month between 01 July 2020 and 11 February 2021 via AustralianETA mobile app or otherwise
 - o 1767 ETA applications were referred to visa office (153 through the AustralianETA mobile app, and 1614 otherwise) between 1 July 2020 and 31 January 2021.
 - Note that the referral process is not automatic, and there is no 'review' involved. If a traveller receives a "referred to visa office" outcome, the traveller is advised to contact their nearest Australian mission (visa office) to provide further information. It is up to the applicant to contact the visa office and provide further information should they wish to continue their ETA application. Alternatively, they may decide to apply for a different visa type, or discontinue their application.
- Visa applications determined (grant/refusal) from review referral for subclass 601 for each month between 01 July 2020 and 11 February 2021 via AustralianETA mobile app or otherwise
 - 191 ETA applications were manually processed by Australian visa offices between 1 July 2020 and 31 January 2021. Refer to table below for a breakdown of applications by month outcome.
