# **Character Case Prioritisation Matrix**

# **Programme Objectives**

- To protect the Australian community from the risk of harm posed by non-citizens of character concern, in line with community and government expectations; and
- To maintain integrity and public confidence in the character assessment process.

# **Caseload priorities**

#### Community cases and short-term prisoners\*

- Dr Sullivan's Caseload Prioritisation Tool is being applied. Those cases with offences and a higher serious likelihood of re-offending (resulting in high scores) are prioritised first.
- Refers to those not liable for mandatory cancellation. Visa holders offshore with imminent travel - to be treated in accordance with Dr Sullivan's tool.

# Visa applicants

- Onshore applicants in detention/prison by a) 90 day rule applies or BVE will be granted b) EDOR for prison and c) other.
- Offshore applicants with strong reasons for urgent processing (business or compassionate reasons).
- Visa holders in community with ongoing applications (to be treated as per community cases).
- Other offshore applicants by a) date of travel and b) date of lodgement.

#### Mandatory Cancellations

Expected date of release (EDOR), with a focus on facilitating prison plane to removal outcomes/avoiding need for immigration detention\*

\* Aim is to cancel well before EDOR where possible so that any revocation process can be finalised while in prison.

#### Revocations

- Detention or prison cases where there are serious physical, behavioural or mental health issues, which require or will require Tier 4 accommodation or otherwise pose a serious risk to the good order of the detention centre.
- 2 Other detention cases. As far as possible within operational requirements, priority will be given to cases with independent evidence of urgent family responsibilities towards children long term residents. and Otherwise, cases will generally be processed in order of date of detention.
- 3. Prison cases, in order of expected date of release
- 4. Offshore cases.
