How many caseworkers are working on processing 190 visa grants?

The Department allocates resources flexibly to manage demand and on-hand levels for all visa types processed, as well as non-processing activities for which a business unit may be responsible. In addition, processing staff work across a range of skilled visas and are not allocated to processing a single visa subclass.

How many caseworkers across the whole Department of Immigration are employed?

On 31 March 2021, there were 2,017 FTE in Immigration Programs Division who were all directly or indirectly involved in visa processing or travel exemption processing in relation to the non-humanitarian visa program. Some visa processing work is also undertaken outside Immigration Programs Division.
