QUESTION: Home Affairs' response to Myanmar coup **KEY TALKING POINTS:**

- On 5 May 2021, I [Minister Hawke], announced that Myanmar nationals, who are in Australia on temporary visas, may apply to extend their stay until it is safe for them to return home.
- These arrangements will support Myanmar nationals who are affected by the ongoing unrest in Myanmar, consistent with Australia's international obligations.
- The Department of Home Affairs has commenced writing to Myanmar nationals in Australia holding temporary visas, inviting them to apply for a new visa if their current visa is approaching expiry.
- Applicants will need to fulfill all relevant visa criteria including health, character and security requirements that apply to all Australian visas; each case will be considered on its individual merits.

If asked: Is Australia providing additional places in the Offshore Humanitarian Program for Myanmar's refugees?

- Australia has for many years provided an allocation of places for Myanmarese in Thailand (and other countries) in the Offshore Humanitarian Program.
- Prior to the recent political crisis in Myanmar, refugees from the country featured heavily in Australia's Offshore Humanitarian Program.
 - More than 18,000 Myanmarese (mostly ethnic Chin, Karen and Karenni) resettled in Australia over the past 10 years.
 - This year (1 July 2020 to 31 March 2021), more than 430 humanitarian visas have been granted to Myanmarese.

If asked: Is the Department Home Affairs (Home Affairs) investigating relatives of Myanmar military in Australia? tment

- I / Home Affairs will not comment on individual cases.
- All non-citizens who wish to enter or remain in Australia must satisfy the requirements of Freed the Migration Act 1958 (the Act) and Migration Regulations 1994, including the character test at section 501 of the Act.
- Generally, there are no legal reasons that would otherwise prevent people with a lawful immigration status from being in Australia.

VISA ARRANGEMENTS TO SUPPORT MYANMAR NATIONALS IN AUSTRALIA

5 May 2021

The Morrison Government today announced that owing to the ongoing unrest in Myanmar, Myanmar nationals currently in Australia on temporary visas may apply to extend their stay until it is safe to return home. The Australian Government will be writing to all Myanmar citizens temporarily in Australia with further advice on how to remain lawful in Australia.

The Government has expressed Australia's condemnation of the ongoing violence in Myanmar. Today's announcement of support is consistent with Australia's international obligations.

A range of options may be available to suit individual circumstances, including the grant of new visas

Minister for Immigration, Citizenship, Migrant Services and Multicultural Affairs Alex Hawke MP said today's announcement would enable affected individuals to remain in Australia until the situation in Myanmar improves.

"This measure provides a means for Myanmar citizens in Australia to remain here until it is safe for them to return home," Minister Hawke said.

"These arrangements will support Myanmar nationals in Australia who are affected by the ongoing unrest in Myanmar, consistent with Australia's international obligations," he said. "Australia continues to strongly urge the Myanmar security forces to exercise restraint and refrain from violence against civilians, release those detained arbitrarily and engage in dialogue," he said.

Australia provides protection to individuals consistent with its obligations set out in the 1951 Convention Relating to the Status of Refugees, its 1967 Protocol and other international human rights conventions.

Visa arrangements to support Myanmar citizens in Australia

- The Australian Government is supporting Myanmar citizens who are currently in Australia on a temporary visa and wish to extend their stay.
- While the Australian Government is unable to extend timeframes on currently held visas, there are a range of visa options, both permanent and temporary, that Myanmar citizens in Australia may wish to consider.
- The Department has commenced writing to Myanmar citizens on a temporary visa in Australia, inviting them to submit a new visa application if their visa expires shortly.
- Myanmar citizens seeking to stay beyond the term of their current temporary visa can check their visa options using the Department's visa finder tool at https://immi.homeaffairs.gov.au/visas/getting-avisa/visa-finder.
- Visa holders may also seek professional assistance from a migration agent registered with the Office of the Migration Agents Registration Authority (OMARA).
 - A list of registered migration agents is available at https://portal.mara.gov.au/search-the- register-of-migration-agents/.
- Visa holders can check their visa details and expiry through the Department's Visa Entitlement Verification Online system (VEVO) at https://immi.homeaffairs.gov.au/visas/already-have-avisa/check-visa-details-and-conditions/check-conditions-online.
- Myanmar citizens holding a temporary visa in Australia can also contact the Department of Home Affairs on 131 881 or via the Home Affairs website at www.homeaffairs.gov.au.
- The Department's Translating and Interpreting Service (TIS National) is available to assist those who may require support.
 - This credentialed and secure interpreting service is available in 24 hours a day, seven days a week.
 - o Non-English speakers can access immediate telephone interpreters through TIS National by calling 131 450. Sartmel
- Individuals applying for further visas will need to fulfil all relevant visa criteria including health, character and security requirements that apply to all Australian visas. Each case will be considered the Department on its individual merits.

Visa assessments

Australia carefully takes into consideration international developments such as those in Myanmar w making operational decisions.

- All non-citizens who wish to enter or remain in Australia must satisfy the requirements of the Migration
 Act 1958 (the Act) and Migration Regulations 1994, including the character test at section 501 of the
 Act.
- There are a range of provisions under the Act that allow the Department of Home Affairs to cancel or refuse visas. Among other reasons, a visa may be cancelled or refused as a result of a non-citizen providing incorrect information, failing to abide by visa conditions, presenting a significant risk to the community or engaging in criminal conduct.

Background (not for public release)

- As at 2 May 2021, there are 3,429 Myanmar citizens holding a temporary visa in Australia. A large majority of this cohort are International Students (1,508).
