1. c) The number of exemption requests approved for Prospective Marriage (subclass 300) visa holders since the Department of Home Affairs deemed PMV holders eligible to travel to Australia on 18 August 2021.

Between 18 August and 13 September 2021, 1,168 requests\* for a travel exemption were approved\*\* where the person declared they had applied for or held a Prospective Marriage (subclass 300) visa\*\*\*.

Of these:

- 1,156 exemptions were approved by a decision maker on the grounds of having lodged a subclass 300 visa at least 12 months before submitting their travel exemption request, or other compassionate & compelling grounds
- 12 requests were either found to be immediate family members of an Australian citizen or permanent resident, or approved on other compassionate grounds.

*ii.* \*\* Excludes otherwise finalised (withdrawn requests, or requests that did not contain sufficient information for referral to a decision maker)

*iii.* \*\*\* Based on client declarations. It is not possible to accurately disaggregate visa holders from visa applicants in travel exemption data.

*iv.* The Department's current policy is to mask numbers which are less than five as <5, noting that we are reviewing the confidentiality method for the future.
