The Visa Applicant Character Consideration Unit (VACCU) manages the character consideration of visa applicants. The VACCU is a unit within the National Character Consideration Centre (NCCC).

Determining whether a section 501 assessment is appropriate

The conduct of a non-citizen may fall within the scope of the 'character test' however, due to the serious consequences for the non-citizen, visa refusal under s501 should only be considered where all other possible grounds for refusal have been ruled out.

A visa application should be assessed according to all Schedule 2 criteria before refusal under s501 is considered. Visa integrity concerns, for example where a visa applicant provides fraudulent documentation in relation to a visa application, should be refused on the basis that they are unable to demonstrate that they pass the relevant visa criteria, rather than under s501. PIC4020 provides grounds to refuse the visa based on false or misleading information such as when a person fails to declare their criminal history on their visa application.

How to refer a visa applicant to VACCU

- 1. Assess whether the visa applicant should be referred to VACCU according to the current VACCU Character Referral Guidelines (s. 22(1)(a)(ii)). Note that:
 - Separate guidelines and a referral form for Bridging E visa applicants are currently under review contact a Status Resolution Manager or VACCU for further advice if required.

 Different policy settings for Resident Return Visa (RRV) applicants are outlined in the Character Procedural Instruction in LECEND, and Section 501. The character test visa refusal and visa cancellation.
 - in LEGEND, see Section 501: The character test, visa refusal and visa cancellation.
- 2. Complete the relevant VACCU referral form (links in the table below). A separate referral to VACCU is required for each individual visa application.

- 3. Seek relevant information from the visa applicant including:
 - o overseas penal certificates, good conduct certificates and military certificates
 - o a detailed personal statement outlining the nature and circumstances of the offending behaviour
 - independent documents to support the s501 assessment for example, copies of court documents such as sentencing remarks and court orders
 - independent information relating to the applicant's rehabilitation such as prison/parole reports, psychological assessments and evidence of completion of rehabilitation courses
 - other relevant information such as character references and documentation to support reasons for travel or other case sensitivities.

Suggested wording to use in a s56 request for information is available at s56 wording - preparing character cases for referral to VACCU s. 22(1)(a)(ii)). If you have requested that the applicant completes a Form 80 or the Character Statutory Declaration consider applying regulation 2.03AA if the applicant fails to provide the requested documents.

Where there is any doubt about whether an applicant meets the character requirements, penal clearances should be requested from places of residence beyond the last 10 years s. 47E(d)

- 5. Ensure that all other Schedule 2 requirements continue to be met and that there are no outstanding matte s. 47E(d)
- 6. The applicant's penal certificate and other relevant information that has been received by mail or fax should be scanned or digitised. Attach all relevant documents as TRIM links where possible, along with the completed VACCU referral formation

7. VACCU will triage the referral and will send an acknowledgement if the case has been accepted or return the referral if not. It is recommended that you send the applicant standard wording to advise them that they have been referred to the VACCU for character assessment however, this may not be appropriate in all circumstances, such as sensitive cases.

8. Once VACCU has accepted the case, create a Stream 3 referra s. 47E(d)

Note: should the applicant's circumstances change and they no longer meet Schedule 2, or seek to withdraw their application, you will need to notify VACCU as soon as possible. We will return the case for your further action or finalise the Stream 3 referral as no longer required.

Who to refer

A visa applicant should be referred to VACCU if the following circumstances are present.

Applicant circumstance

Action required

Substantial Criminal Record: Section 501(6)(a)

Refer to Section 501: The character test, visa refusal and visa

a substantial criminal record as defined by s501(7):

- the person has been sentenced to death
- the person has been sentenced to imprisonment for life
- the person has been sentenced to a term of imprisonment of 12 months or more (a suspended sentence is considered a prison sentence)
- the person has been sentenced to 2 or more terms of imprisonment, where the total of those terms is 12 months or more
- the person has been acquitted of an offence on the grounds of unsoundness of mind or insanity, and as a result the person has been detained in a facility or institution.
- the person has:
 - been found by a court to not be fit to plead, in relation to an offence
 - the court has nonetheless found that on the evidence available the person committed the offence, and
 - as a result, the person has been detained in a facility or institution.

VACCU has created a tip sheet and sample of the VACCU referral form to use as a guide when completing the form.

Why is VACCU changing the referral form?

The VACCU is introducing a new referral form to address some of the persistent issues presented by relevant stakeholders, and to promote best practice in:

- safeguarding applicant's personal and private information
- complying with the Department's record keeping policy
- removing size limitations, which eliminates the need to send multiple emails per referral.

What is the best way to fill in the form?

The form is designed using MS Word. Where drop-down menus are available, select the most appropriate option from that menu. You can also add notes or create narrative in the free text box. Make sure you are entering information within the designated brackets. It is important to follow the correct format when placing dates and attaching **TRIM links** only for mandatory and supporting documents in the referral form.

What can I do if I have broadband or bandwidth issues that prevent staff from creating TRIM Links?

VACCU recognises that some offshore locations have limited Internet bandwidth and issues with internet connections that prevent staff from creating TRIM Links. To support these offshore locations, VACCU will accept records using TRIM Reference (e.g. s. 22(1)(a)(ii)). To be exempt from sending the TRIM links, overseas posts must meet the following criteria:

- The overseas post must have limited data capacity due to persistent problems with internet connections.
- The overseas post must have an agreement with VACCU to use a TRIM reference in lieu of a TRIM link. We encourage overseas posts with limited bandwidth and internet issues to reach out to VACCU to discuss solutions.
- Staff are to copy and paste the TRIM reference and refrain from hand typing the TRIM reference into the referral form. Experience informs us that manual typing often results in typo errors which can lead to the referrals being returned to business referring areas.

Note: An exemption must be agreed upon with VACCU prior to this process being implemented in your processing area.

On average, how long will it take VACCU to process a referral?

The length of time taken to complete a character assessment will depend on the complexity and circumstances of the case. Incomplete referrals and not providing TRIM links to supporting documents may contribute to further delays in the assessment of a referral. Please ensure the referral form is fully completed before emailing VACCU to avoid the referral being returned to you.

How can I check that the referral was received?

You will receive an auto-generated response as soon as a referral is sent to the VACCU mailbox. This is your record and reference that your referral has been received by VACCU.

Can I send applicant's supporting documents as separate attachments in an email to VACCU?

VACCU will send back supporting documents that are not attached to the referral form. The new referral form is designed to drag and drop TRIM links into up to 4.5MB of data without the need to send a separate email.

Where can I find information on how to refer an application to VACCU for character assessment?

There are two ways in referring an applicant for character assessment, this can done by:

- using the VACCU referral form template with trim links to mandatory and other supporting documents
- contacting the Cancellation Support Helpdesk for assistance a s. 22(1)(a)(ii) @homeaffairs.gov.au

Why do we need to create a TRIM link?

Trim links are important to safely transmit information and documentation and eliminates the risk of security breaches. They also allow for the information required for the purposes of s501 character assessment to be directly provided to VACCU.

Is there a maximum limit on number of TRIM links that can be attached to each relevant section?

NO, you can attach as many TRIM links as you need to. The only caveat is that TRIM links must be attached directly to the form in the designated section.

Overseas post use DFAT email gateway which limits attachment size to maximum of 5MB per email, will the number of TRIM links included be limited by this?

A single TRIM link is normally 4KB in size, in principle you can attach up to 4.5MB of data to the form. Please refer to the VACCU referral form tip sheet on how to create a TRIM link for information.

On the 'For Bridging Visa applicant only' section, will be it acceptable to leave this unfilled if the case being referred is a non-Bridging visa applicant?

YES, you can skip and leave the BVE section unfilled if this is not relevant to your referral.

What if I cannot provide the mandatory documents?

If mandatory documents cannot be provided, it is important to fill in the relevant field on the referral form as to why the document cannot be provided. Please note that referral will be sent back if information/reason is not adequately provided. If documents have been requested and you are waiting for a response from the applicant or their representative, please ensure you have the documents available prior to referring to VACCU.

Am I able to send a referral to VACCU if the applicant has pending court matters?

If an applicant has pending court matters to be heard, please wait until an outcome becomes available prior to submitting a referral to VACCU. VACCU will consider your referral incomplete if there are pending matters waiting to be sed by Department of Home Affairs the Freedom of Information Act 198 settled. Your referral will be returned if it is incomplete.

What do I do if a field on the form is not applicable?

If a section is not applicable, please leave the field blank or type "not applicable" if this is an option to choose. Please ensure no fields on the form are deleted.

What are drop down menus?

Dropdown menus are options given where it is available in the form. This will allow you to select the most relevant information to choose instead of manually typing the information required. Please note that some Dropdown menus have a "not applicable field" for sections that may not potentially apply.

What must I provide in the referral email?

A referral email will need to have the VACCU referral form attached to it. No further attachments are required in your email as mandatory and other supporting documents must be placed in the referral form as TRIM links.

To save time, can I submit the missing document or information only as advised by VACCU without completing a new referral form?

VACCU will not keep and accept an incomplete referral form. If a referral has been returned or rejected because the form has not been properly completed and or mandatory documentations were not initially provided, you must submit a new referral form to VACCU.

Further assistance

The VACCU does not provide pre-referral assessments however, will provide advice on any submitted referrals following full triage and assessment based on the documents you have provided.
