Security of Critical Infrastructure Amendment (LIN 24/002) Rules 2024

#### 1 Name

This instrument is the Security of Critical Infrastructure Amendment (LIN 24/002) Rules 2024.

#### 2 Commencement

This instrument commences on the day after registration.

#### **3** Authority

This instrument is made under the Security of Critical Infrastructure Act 2018.

#### 4 Schedules

Each instrument that is specified in a Schedule to this instrument is amended or repealed as set out in the applicable items in the Schedule concerned, and any other item in a Schedule to this instrument has effect according to its terms.

### Schedule 1—Amendments

#### Security of Critical Infrastructure (Application) Rules (LIN 22/026) 2022

#### 1 Section 3 (definition of designated airport)

Repeal the definition, substitute:

*designated airport*: a reference in these rules to a designated airport is a reference to a security controlled airport that is assigned to the category of designated airport by the Secretary under subsection 28(6) of the Aviation Transport Security Act.

Note: See regulation 3.01B of the Aviation Transport Security Regulations for the categories of security controlled airports prescribed for the purposes of section 28A of the Aviation Transport Security Act.

#### 2 Section 3 (definition of regulated air cargo agent)

Repeal the definition, substitute:

*regulated air cargo agent* has the meaning given by section 9 of the Aviation Transport Security Act.

#### 3 Section 3

Insert:

*security controlled airport* has the meaning given by subsection 28(2) of the Aviation Transport Security Act.

#### 4 Subsection 4(1)

Omit ", other than an asset mentioned in subsection (2),".

#### 5 Paragraph 4(1)(d)

Repeal the paragraph, substitute:

(d) a critical financial market infrastructure asset that is covered by paragraph 12D(1)(i) of the Act;

#### 6 Paragraph 4(1)(f)

Repeal the paragraph, substitute:

(f) a critical hospital that is mentioned in the table in Schedule 1;

#### 7 At the end of subsection 4(1)

Add:

- ; (n) a critical port asset that was not a critical infrastructure asset immediately before the commencement of section 18A of the Act;
  - (o) a critical water asset that was not a critical infrastructure asset immediately before the commencement of section 18A of the Act.

#### 8 Subsection 4(2)

Repeal the subsection.

#### 9 Subsection 5(1)

Omit "(3) and".

#### 10 Paragraph 5(1)(i)

Repeal the paragraph, substitute:

(i) a critical hospital that is mentioned in the table in Schedule 1;

#### 11 Subsection 5(2)

Omit "A critical aviation asset that", substitute "For paragraph 5(1)(p), a critical aviation asset".

#### 12 Subsection 5(3)

Repeal the subsection.

#### 13 At the end of the instrument

### Security of Critical Infrastructure (Definitions) Rules (LIN 21/039) 2021

#### 17 Subsection 10(5)

Repeal the subsection (not including the heading), substitute:

- (5) For the purposes of paragraph 12D(1)(i) of the Act, the payment system specified in column 1 of an item in the table in subsection (7) is prescribed.
  - Note: Paragraph 12D(6)(a) of the Act provides that, for the purposes of paragraph 12D(1)(i) of the Act, the rules may prescribe specified payment systems that are critical to the security and reliability of the financial services and markets sector. Paragraph 12D(1)(i) provides that an asset that is used in connection with the operation of a prescribed payment system is a critical financial market infrastructure asset.
- (6) For the purposes of paragraph 12L(8)(i) of the Act, the responsible entity for a critical financial market infrastructure asset that is used in connection with the operation of a payment system specified in column 1 of an item in the table in subsection (7) is the entity mentioned in column 2 of that item.
  - Note: Paragraph 12L(8)(i) of the Act provides that the responsible entity for a critical financial market infrastructure asset covered by paragraph 12D(1)(i) of the Act is the entity prescribed by the rules.
