# **Control Orders**

## **Annual Report 2020-21**

The Australian Federal Police (AFP) Minister is required under section 104.29 of the *Criminal Code Act 1995* (the Criminal Code) to provide a report in respect of control orders during the year ending on 30 June 2021.

The provisions of this section of the legislation require the report to include:

- a) (i) the number of ordinary interim control orders made
  - (ii) the number of urgent interim control orders made by electronic means
  - (iii) the number of urgent interim control orders made in person
- b) the number of interim control orders that the AFP elected not to confirm
- c) the number of control orders confirmed at a confirmation hearing
- d) the number of control orders declared void at a confirmation hearing
- **e)** the number of control orders revoked at a confirmation hearing or upon application by the subject or the AFP Commissioner
- f) the number of control orders varied at a confirmation hearing or upon application by the subject or the AFP Commissioner
- g) particulars of:
  - (i) any complaints made or referred to the Commonwealth Ombudsman that related to control orders
  - (ii) any information given under section 40SA of the *Australian Federal Police Act 1979* that related to control orders and raised an AFP conduct or practices issue (within the meaning of that Act)
- h) the number of monitoring warrants issued in relation to a control order
- i) the number of monitoring warrants executed in relation to a control order
- j) the report prepared by the Commonwealth Ombudsman detailing the results of any inspections of AFP records in relation to monitoring warrants
- **k)** for control orders relating to people who are 14 to 17 years of age the matters referred to in (a) to (j) in so far as those matters specifically relate to those control orders

# **Commonwealth Ombudsman Report – Monitoring Control Orders** 2020-21

Under section 3ZZUB of the *Crimes Act 1914* (the Act) the Commonwealth Ombudsman (the Ombudsman) may inspect the records of the AFP to determine the extent of compliance with the provisions of Part IAAB of the Act, relating to monitoring of compliance with control orders. Under section 3ZZUH, the Ombudsman must report to the Minister for Home Affairs the results of any such inspection.

From 22-25 June 2021, the Ombudsman inspected the AFP's Part IAAB records relating to eight premises warrants which expired between 1 July 2019 and 30 June 2020.

The Ombudsman did not identify significant compliance issues during this inspection; however, 11 contraventions of the provisions of Part IAAB were identified (see below) and the below feedback was given:

- 10 suggestions regarding minor compliance issues, and
- 10 better practice suggestions to further support the AFP to maintain its compliance and mitigate compliance risks.

These contraventions did not indicate significant compliance issues by the AFP, and the AFP advised no prosecutions were affected.

The AFP Minister is required by section 105.47 of the Criminal Code to provide a report in respect of preventative detention orders during the year ending on 30 June 2021.

The provisions of this section of the legislation require the report to include:

- a) the number of initial preventative detention orders made
- b) the number of continued preventative detention orders made
- c) (i) whether a person was taken into custody under each order
  - (ii) if so, how long the person was detained for
- d) particulars of:
  - (i) any complaints made or referred to the Commonwealth Ombudsman that related to the detention of a person under a preventative detention order
  - (ii) any information given under section 40SA of the *Australian Federal Police Act* 1979 during the year that related to the detention of a person under a preventative detention order and raised an AFP conduct or practices issue (within the meaning of that Act)
- e) the number of prohibited contact orders made
- f) the number of preventative detention orders and prohibited contact orders that a court has found not to have been validly made or that the Administrative Appeals Tribunal has declared to be void

# Powers in Relation to Terrorist Acts and Terrorism Offences

# **Annual Report 2020-21**

The AFP Minister is required under section 3UJB of the *Crimes Act 1914* to provide a report in respect of powers exercised under Division 3A of the Act in relation to terrorist acts and terrorism offences during the year ending on 30 June 2021.

The provisions of this section of the legislation require the report to include:

- a) the number of instances when an AFP police officer or officers exercised a power to:
  - (i) seize terrorism related items or serious offence related items, and give a notice in relation to the seizure
  - (ii) enter a premises without a search warrant in order to prevent a thing from being used in connection with a terrorism offence because there is a serious and imminent threat to a person's life, health or safety
- b) the number of incidents when an AFP police officer or officers exercised a power to:
  - (i) require a person to provide their name and personal details, or
  - (ii) stop and search a person
- c) the number of applications made for declarations that Commonwealth places are prescribed security zones
- d) the number of declarations made that Commonwealth places are prescribed security zones
