Explanatory Notes:

- Note 1** All numbers have been rounded to the nearest 10 and salaries to the nearest \$100. Therefore the sum of individual items in a table may not exactly match the total. Where a number in a table is between 1 and 4, the number has been masked with < 5 for privacy reasons.
-
- Note 2** This report is based on visa grant data recorded for visa subclass 457 in the current financial year and provides a comparison with the SAME PERIOD IN THE PREVIOUS YEAR. It excludes a small number of visa grants made to Independent Executives, who also used to enter on subclass 457 visa but are now included in the Business Skills categories.
-
- Note 3** The principal data collected on 457 visa holders comes from the visa application and grant process. The applicant and their sponsor provide a range of information to enable DIAC to assess the eligibility of the sponsor and the applicant for the visa. This is the most accurate and verifiable data that DIAC collects on 457 visa holders. It includes such information as the location of the nominated position, the nominated occupation, the nominated base salary and the citizenship country.
-
- Note 4** Unless otherwise stated, the tables in this report relate to primary applicants only.
-
- Note 5** Unless otherwise stated, the occupation shown in tables in this report is the nominated occupation. That is, the position that is being filled rather than the previous or usual occupation of the visa applicant.
-
- Note 6** Sponsors self-identify with an industry classification when lodging a nomination or sponsorship. The industry classification shown is based on what the sponsor has recorded. If a sponsor has notified more than one industry over time, the most recently recorded industry classification has been used in this report.
-
- Note 7** Up until 1 April 2005, medical practitioners applied for a visa in Visa Subclass 422 Medical Practitioner. From that date, medical practitioners have been encouraged to apply for a Subclass 457 visa.
-
- Note 8** In tables showing the top 15 citizenship countries, the figure for 'Unknown' is included in the total only.
-
- Note 9** In some tables, 'Not recorded' or 'Not specified' appears. This mainly relates to visa applications processed in the IRIS system. IRIS does not have the capacity to record comprehensive information about sponsors and nominations. Since 1 November 2003, the ICSE system has largely replaced IRIS for processing subclass 457 visas, but a small number of visas are still processed in IRIS.
-
- Note 10** From 14 September 2009, subclass 457 visa holders changing sponsor or nominated occupation do not need to lodge a new visa application if they held a valid subclass 457 visa. DIAC estimates that the number of visa applications lodged since 14 September 2009 has been reduced by on average 7.2% below the level that would have occurred without the change.

Definition of Terms:

ANZSIC:	Australian and New Zealand Standard Industry Classification 2006 Edition produced by the Australian Bureau of Statistics (ABS). Prior to November 2008, ANZSIC 1993 was used to record industry. Data recorded using ANZSIC 1993 has been converted to ANZSIC 2006 using concordance tables provided by the ABS.
Applicant Type:	Under the Migration Regulations, there are two types of applicants. These are primary applicants (the client who must satisfy the primary criteria) and secondary applicants. Secondary applicants are more commonly referred to as dependants.
ASCO Major Group:	Australian Standard Classification of Occupations 2nd Edition produced by the Australian Bureau of Statistics (ABS). Major Group is the highest level in the classification hierarchy and commonly referred to as ASCO 1.
Independent Executive:	Formerly, a group within subclass 457 who did not require a sponsor. They are now included in the Business Skills categories. A small number of visa applications for Independent Executives were finalised in the current year.
Last Visa Held:	Unless otherwise specified, refers to the last substantive visa held by a visa holder prior to a point in time. That is, bridging visas are ignored when determining the last visa held. The last visa held may have expired or still be in effect.
Nominated Base Salary:	Represents the gross annual salary based on a 38 hour week that the employer has indicated they will pay to the primary visa holder. These amounts do not include the value of salary packaged items, bonuses, commissions or other payments listed in the schedule to the legislative instrument specifying Minimum Salary Levels for the Subclass 457 program.
Nominated Occupation:	The occupation of the nominated position that the primary visa holder will be filling in Australia while holding the Subclass 457 visa based on the Australian Standard Classification of Occupations (ASCO) 2nd Edition.
Nominated Position Location:	The State or Territory where the visa holder will be working. This may be different from the business address of the sponsor and/or the visa processing office.
Nominated Total Remuneration:	The total value of the salary package including base salary, allowances, bonuses and superannuation.
Pathway:	A visa holder moving from one type of visa to another type of visa. Most commonly used in relation to visa applicants moving from a temporary visa to a permanent/provisional visa. The original visa is determined by the last visa held prior to permanent/provisional visa grant and the visa applicant may be onshore or offshore.
Permanent/provisional visa:	A visa subclass which is countable for the purposes of the migration program.
Primary Applicant:	The applicant who must satisfy the primary criteria for the grant of a visa under the Migration Regulations. Where dependant(s) subsequently apply to join a primary applicant who is already in Australia, the dependant applicant is not regarded as a primary applicant in visa grant data.
Primary Application:	A visa application lodged by a primary applicant.
Secondary Applicant:	The applicant who must satisfy the secondary criteria for the grant of a visa under the Migration Regulations.
Secondary Application:	A visa application lodged by a secondary applicant.
Sponsor Industry:	The industry identified by the sponsoring client based on the Australian and New Zealand Standard Industry Classification (ANZSIC) 2006 edition.

Trends in the Subclass 457 Business (Long Stay) Visa Program to June 2010

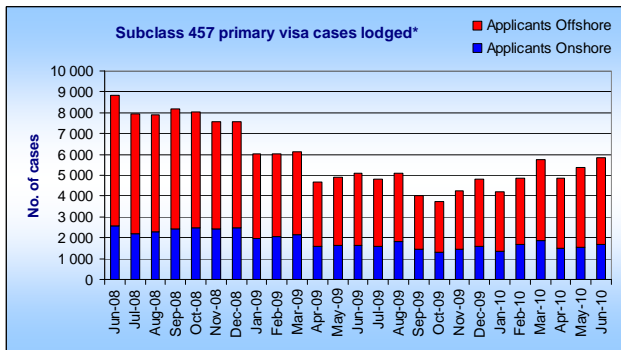
Key Points

- June 2010 recorded the highest number of primary Subclass 457 visa applications lodged this program year.
- Primary visa grants in June 2010 were 12 per cent higher than May 2010 and 8 per cent higher than June 2009.
- Primary visa grants for 2009-10 were 31 per cent lower than 2008-09.
- There were 68 400 primary visa holders in Australia at the end of June 2010, 12 per cent lower than the same time last year.

Visa application trends

The number of Subclass 457 primary visa applications lodged in June 2010 was 9 per cent higher than May 2010. June was the highest month for applications lodged this financial year and since the impacts of the global financial crisis. Following the drop in application rates immediately after the introduction of the Migration Legislation Amendment (Worker Protection) Act 2008 on 14 September 2009, application rates have been trending upwards. Improved business conditions and a fall in unemployment rates are important factors for the increase in application rates in the last few months.¹

However, year to date, the total number of primary Subclass 457 visa applications lodged is 29 per cent lower than last program year.

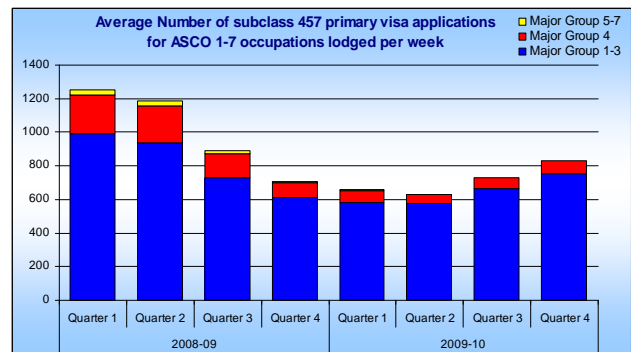

The number of applications lodged offshore was greater than onshore lodgements for the fourth consecutive month. In June 2010, 60 per cent of applications were lodged by applicants who were offshore. This program year, 52 per cent of applications have been made by applicants who were offshore.

¹ Since 14 September 2009, Subclass 457 visa holders who wish to change employer or position (within the validity of their current visa) are not required to apply for a new Subclass 457 visa. This will affect comparisons between this program year and the previous program year. Also see Note 10 in the Explanatory Notes.

The average number of ASCO 1-3 applications lodged each week was 13 per cent higher in the June quarter of 2009-10 compared to the March quarter. The average number of ASCO 4 (trade occupation) applications lodged per week was 17 per cent higher in the June quarter compared to the March quarter. However, the proportion of ASCO 4 applications remains low.



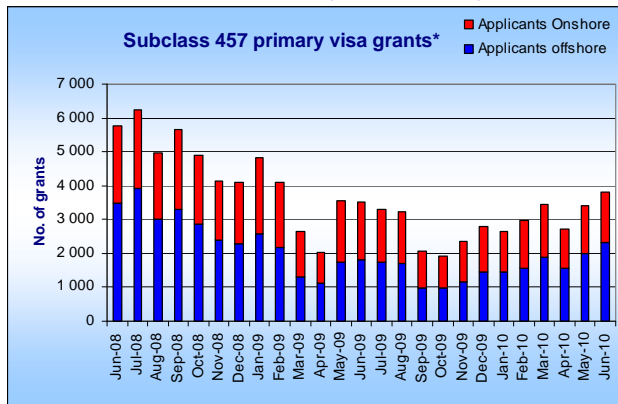
Visa grant trends²

The number of Subclass 457 primary visa grants in June 2010 was 12 per cent higher than May 2010, but 8 per cent higher than June 2009.

The total number of primary visa grants for the 2009-10 year was 31 per cent lower than the 2008-09 program year.

² The rate at which visa applications are processed is subject to a number of variables including: the number of working days in a month, the number of public holidays and the occurrence of school holidays.

In the 2009-10 program year, 91 per cent of primary visa grants were to Managers and Administrators, Professionals and Associate Professionals and 9 per cent were to Tradespeople. By comparison, in the 2008-09 program year, 82 per cent of grants were to applicants in these occupation groups and 18 per cent were to Tradespeople.

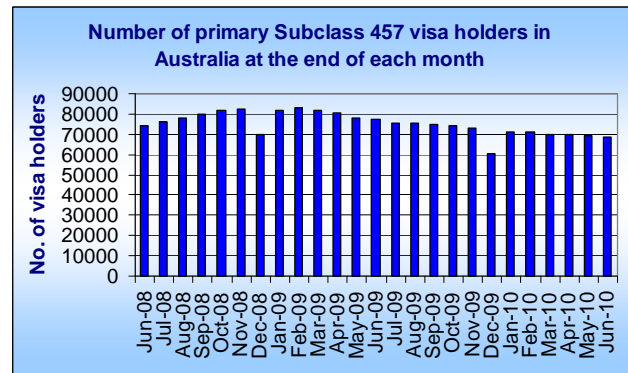
The three top industries for primary visa grants in 2009-10 were Health Care and Social Assistance (19 per cent of grants), Information, Media and Telecommunications (11 per cent) and Construction (10 per cent). In 2008-09, the top three industries were Health Care and Social Assistance (19 per cent), and Rental, Hiring and Real Estate Services (9 per cent).

The majority of primary Subclass 457 visa grants during 2009-10 were for positions in New South Wales (36 per cent), followed by Victoria (24 per cent). In the three month period to 30 June 2010, both New South Wales and Western Australia experienced strong growth in visa grants, increasing 15 per cent and 21 per cent respectively during this period.

The top three citizenship countries for primary visa grants during 2009-10 were the United Kingdom (25 per cent), India (17 per cent) and the United States of America (9 per cent). By comparison, the top three citizenship countries during 2008-09 were the United Kingdom (23 per cent), India (15 per cent) and the Philippines (9 per cent).

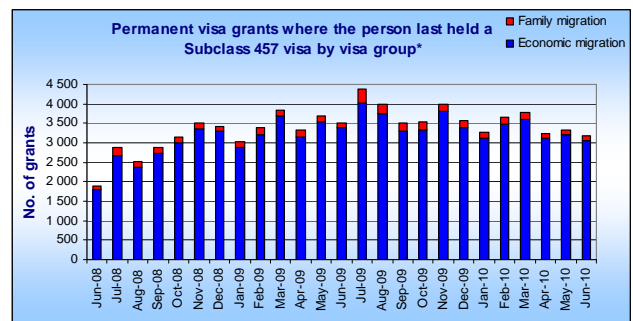
Number of primary Subclass 457 visa holders in Australia

The number of Subclass 457 visa holders in Australia is steady. At the end of June 2010, there were 68 400 primary visa holders in Australia. This is 12 per cent lower than at the end of June 2009.



Flow of Subclass 457 visa holders to permanent residence

The number of Subclass 457 visa holders granted a permanent residence visa in June 2010 was 10 per cent lower than June 2009. The number of Subclass 457 visa holders granted permanent residence in 2009-10 was 11 per cent higher than 2008-09.



Sanctions of sponsors

Employers who are approved as sponsors are monitored to ensure they are complying with the sponsorship obligations applicable from 14 September 2009 and, prior to 14 September 2009, the sponsorship undertakings.

If the sponsor does not comply with these obligations or undertakings, the department may take enforcement action. This may include imposing administrative sanctions, issuing infringement notices or applying for a civil penalty order through the federal court.

The department imposed 164 sanctions in the 2009-10 program year. This is 14 per cent lower than the same period last program year.

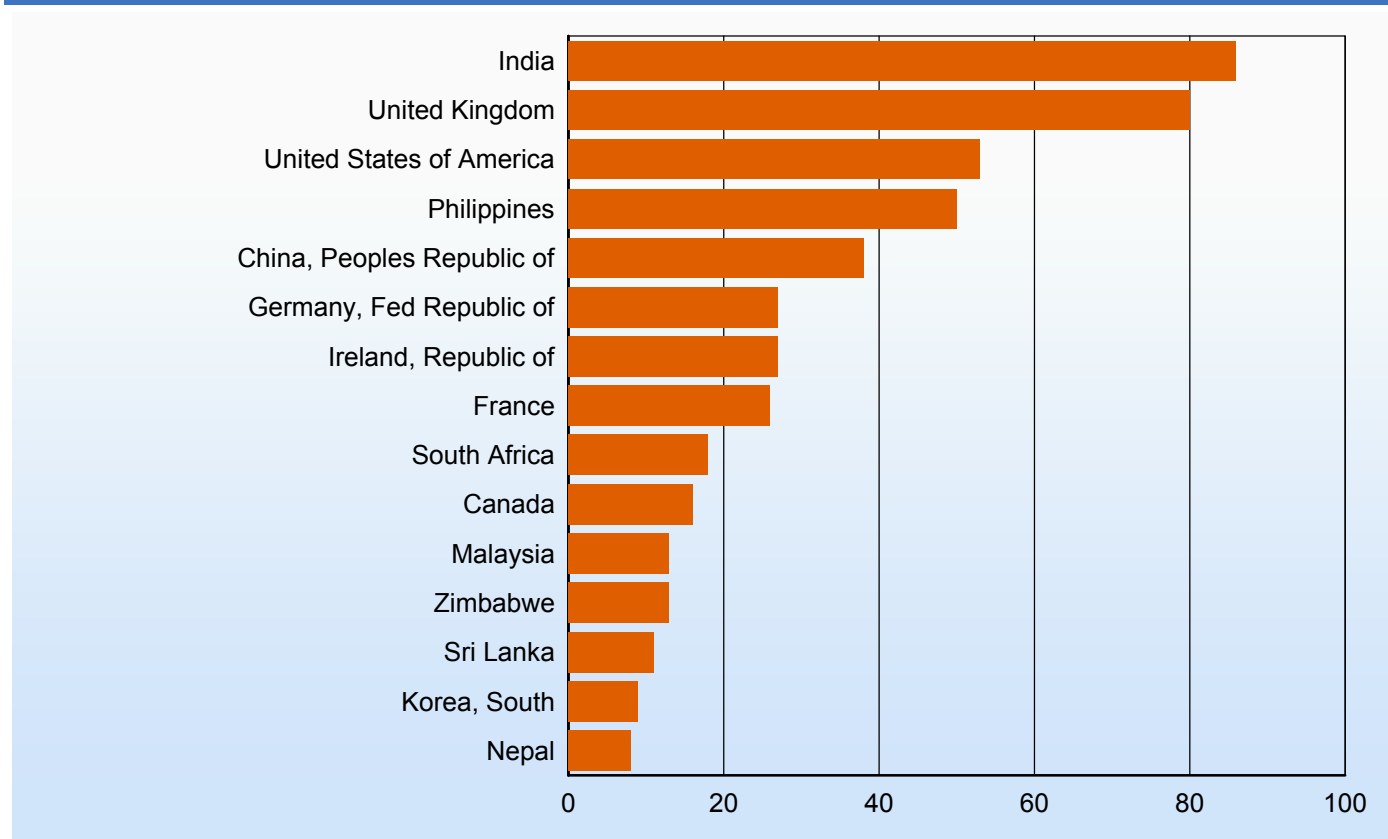

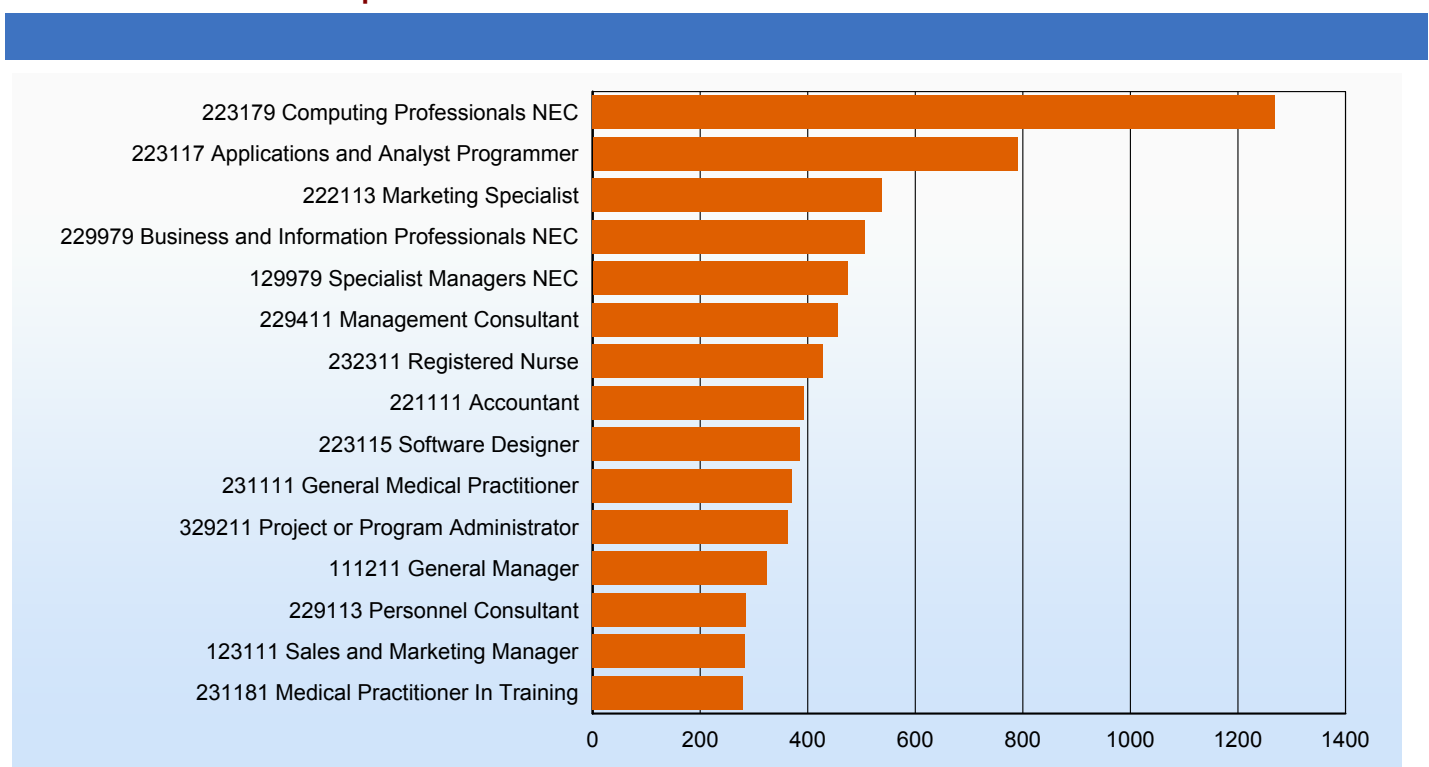
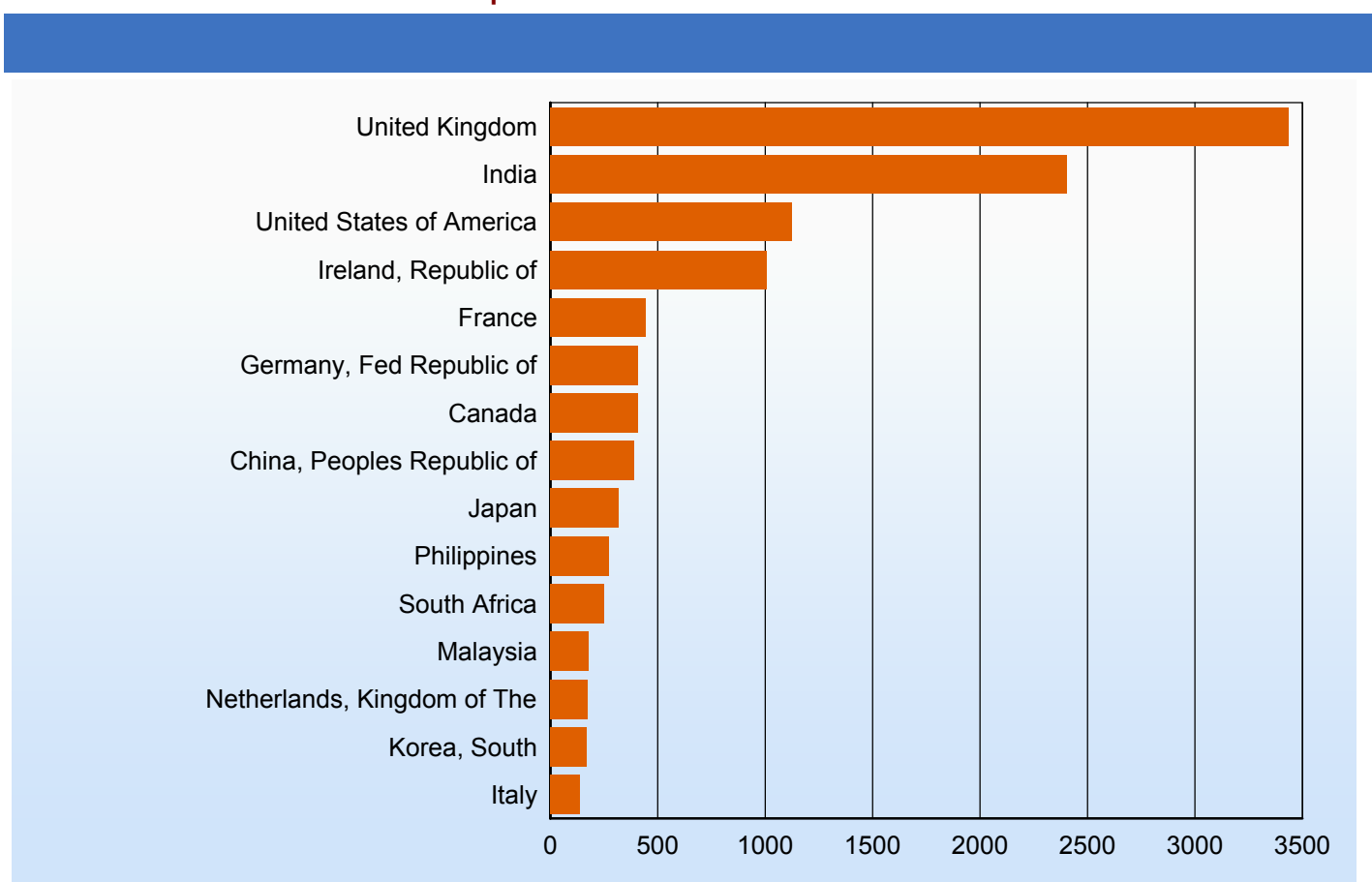
Graph 3.04 Top 15 Nominated occupations for primary applications granted in 2009-10 to 30 June 2010 - nominated positions located in New South Wales

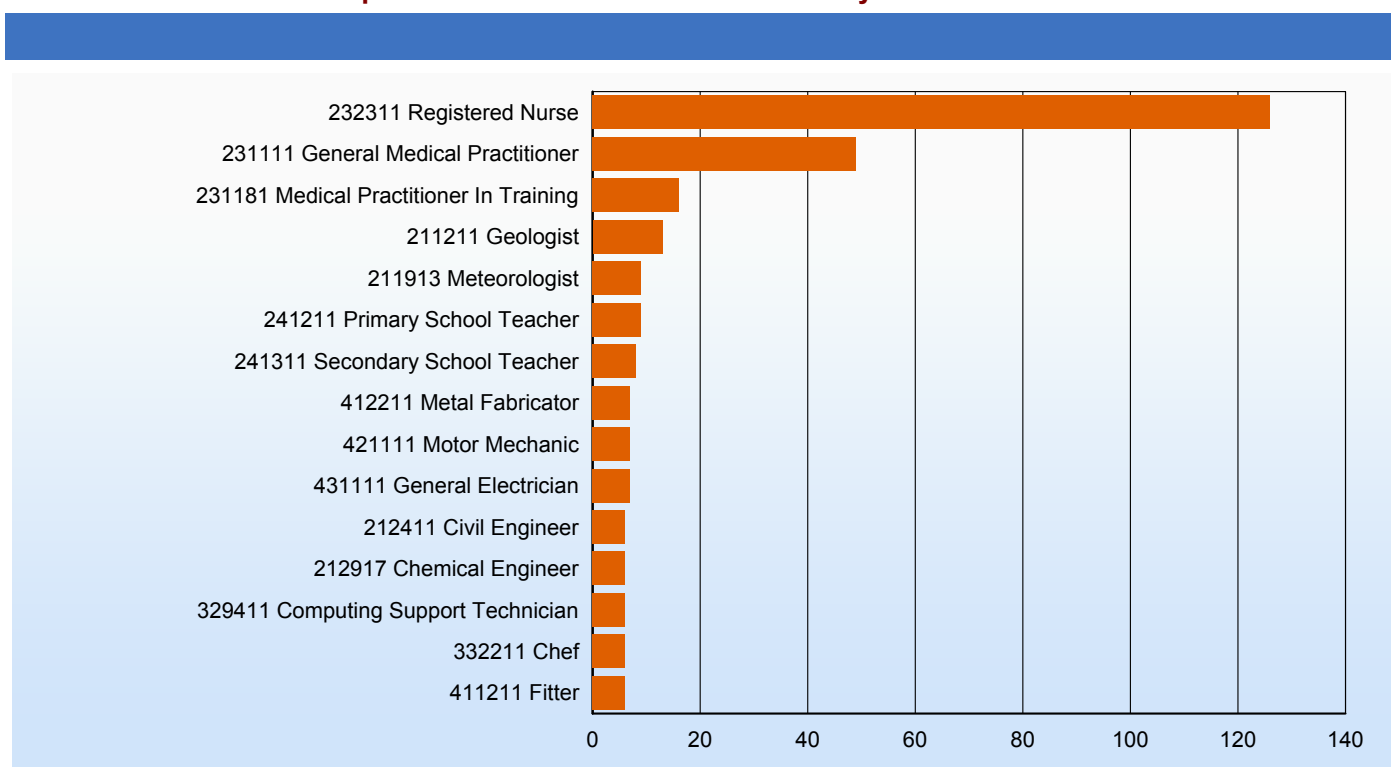
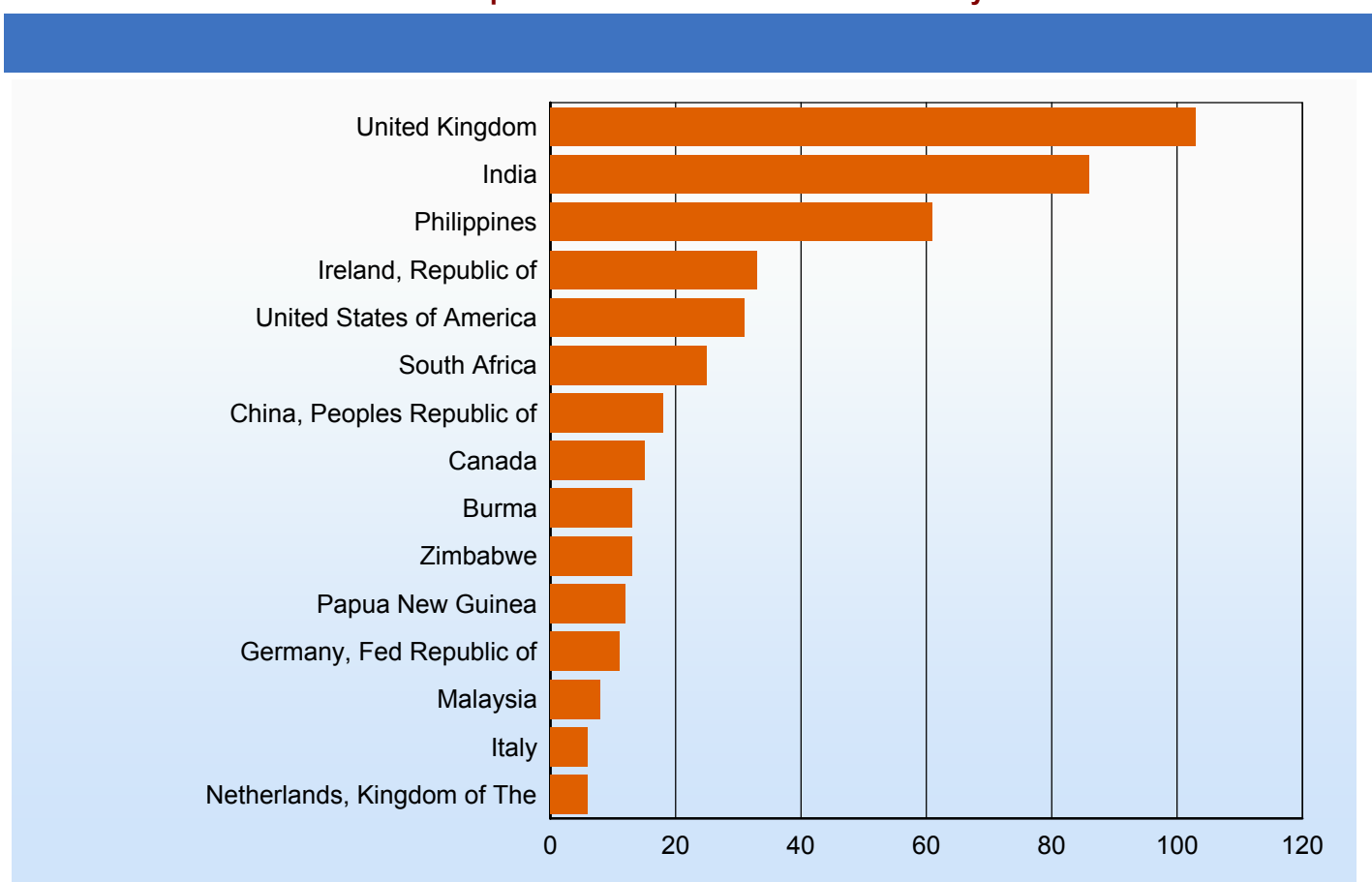
Graph 4.04 Top 15 Nominated occupations for primary applications granted in 2009-10 to 30 June 2010 - nominated positions located in Northern Territory

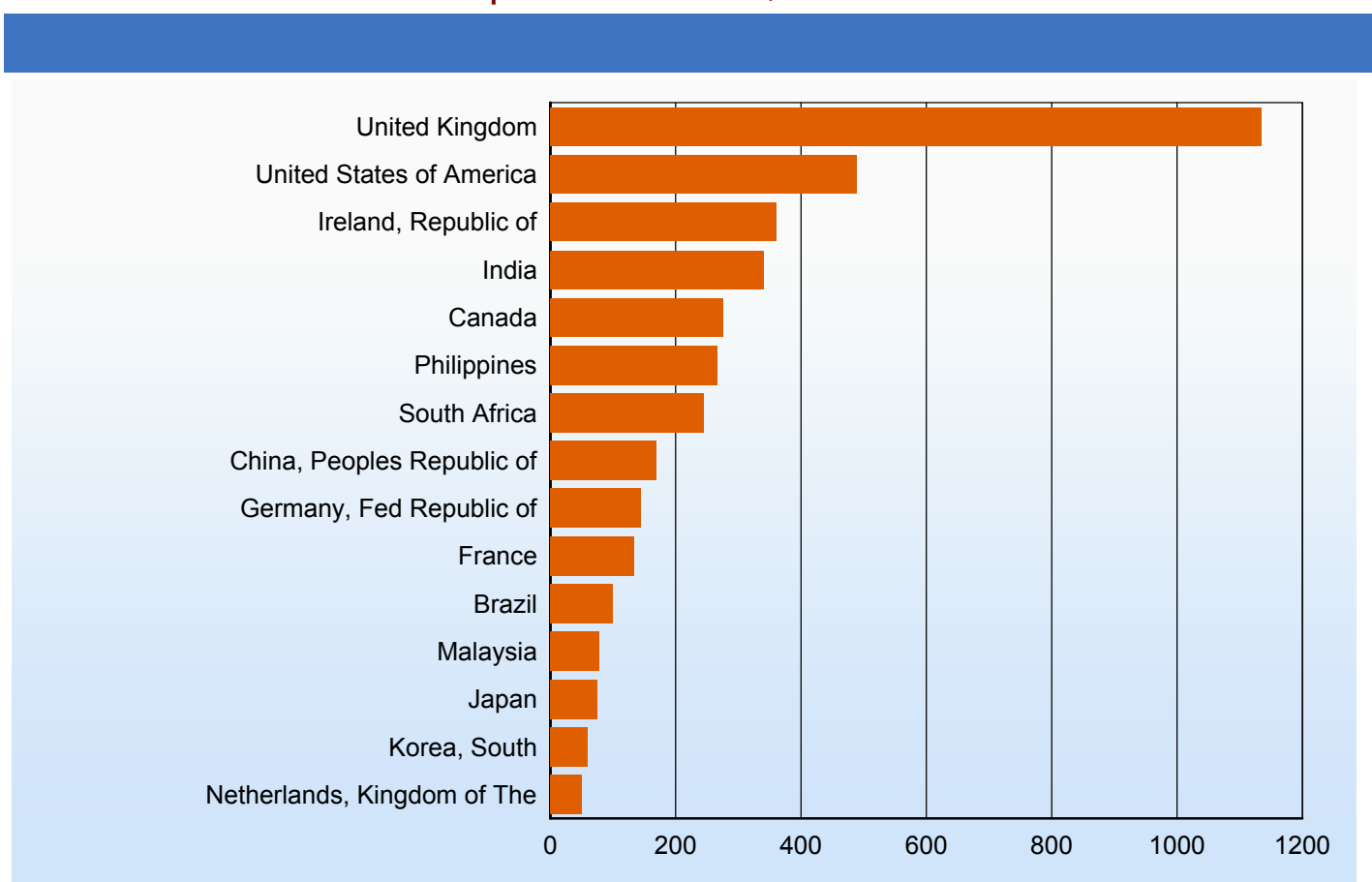

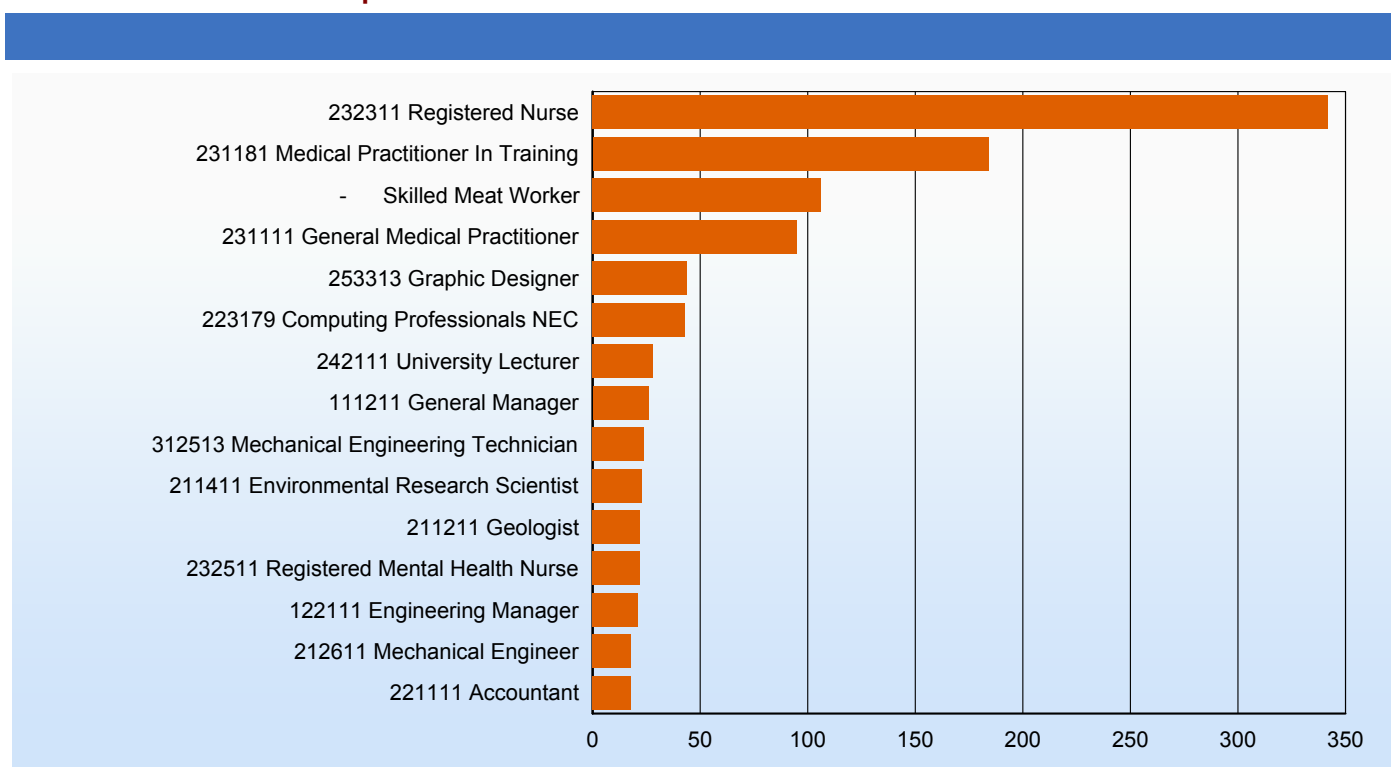
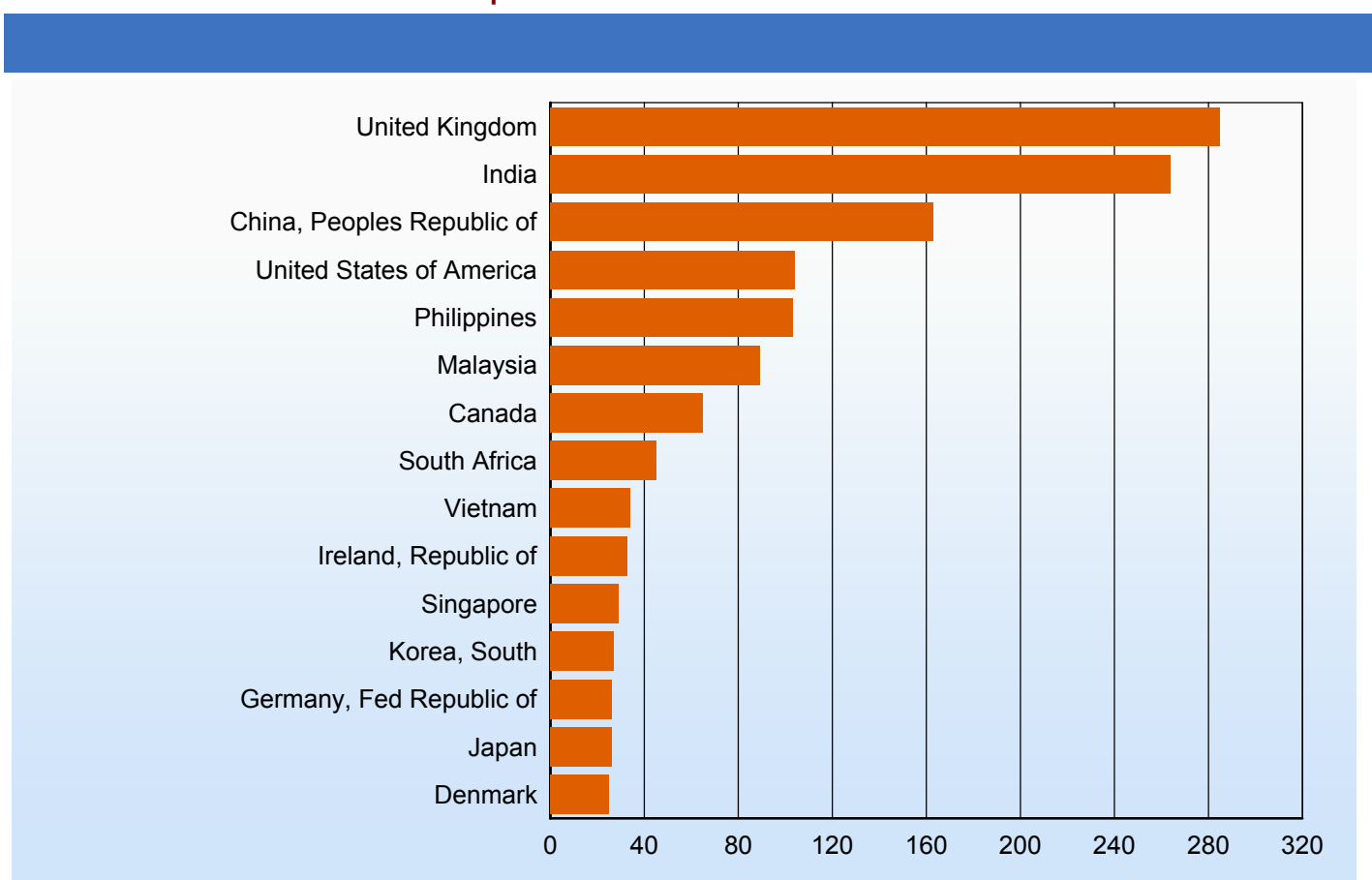
Graph 6.04 Top 15 Nominated occupations for primary applications granted in 2009-10 to 30 June 2010 - nominated positions located in South Australia

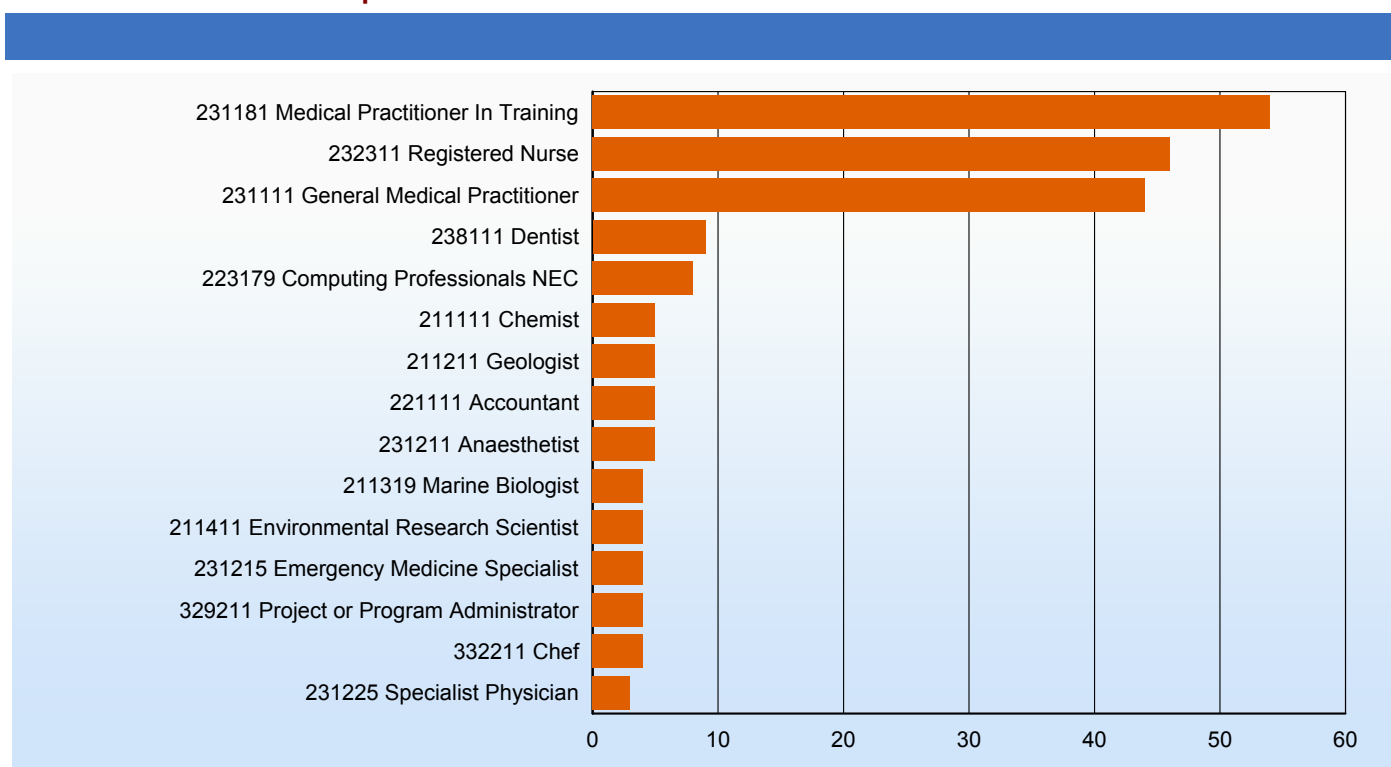
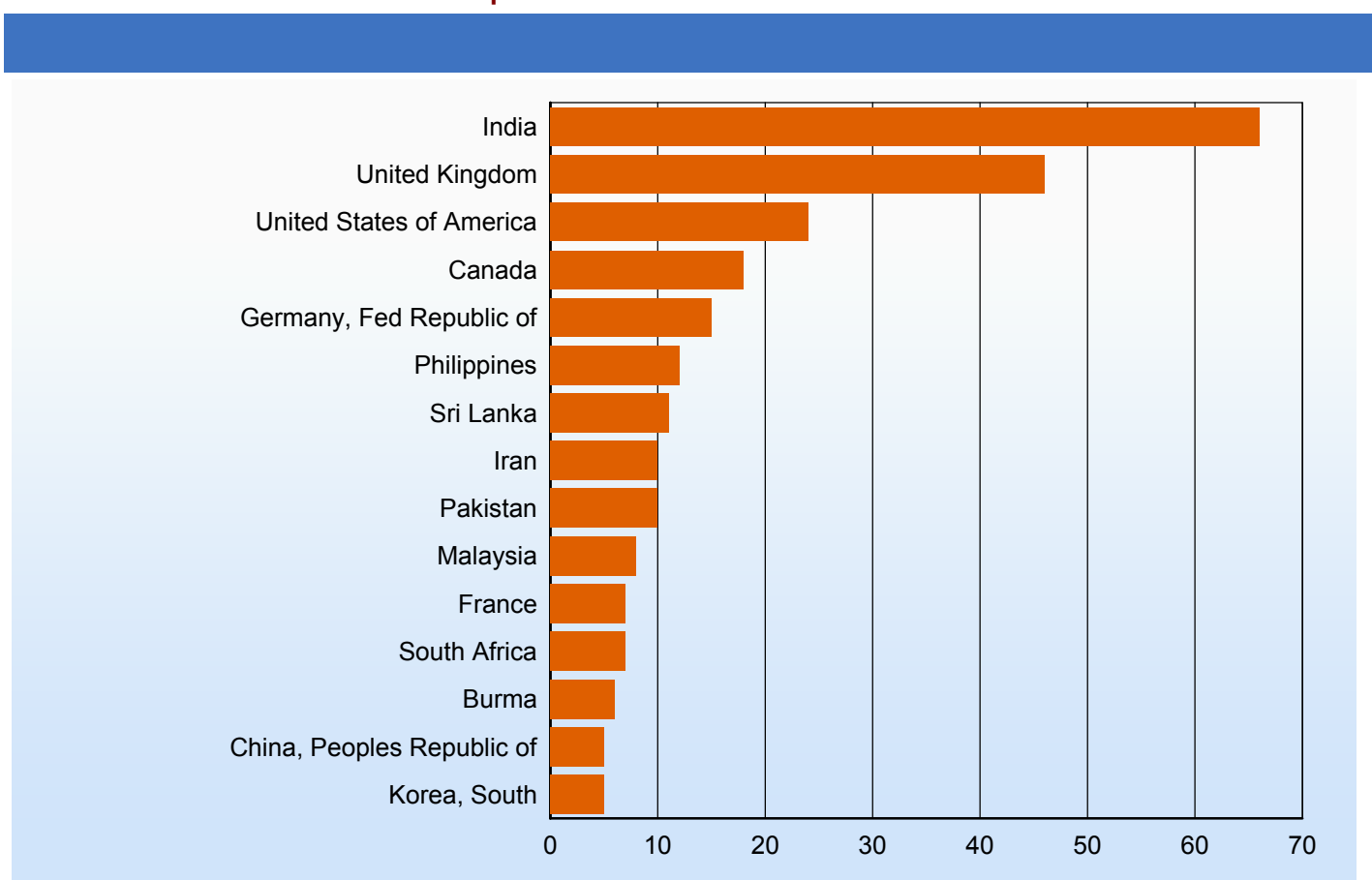
Graph 7.04 Top 15 Nominated occupations for primary applications granted in 2009-10 to 30 June 2010 - nominated positions located in Tasmania

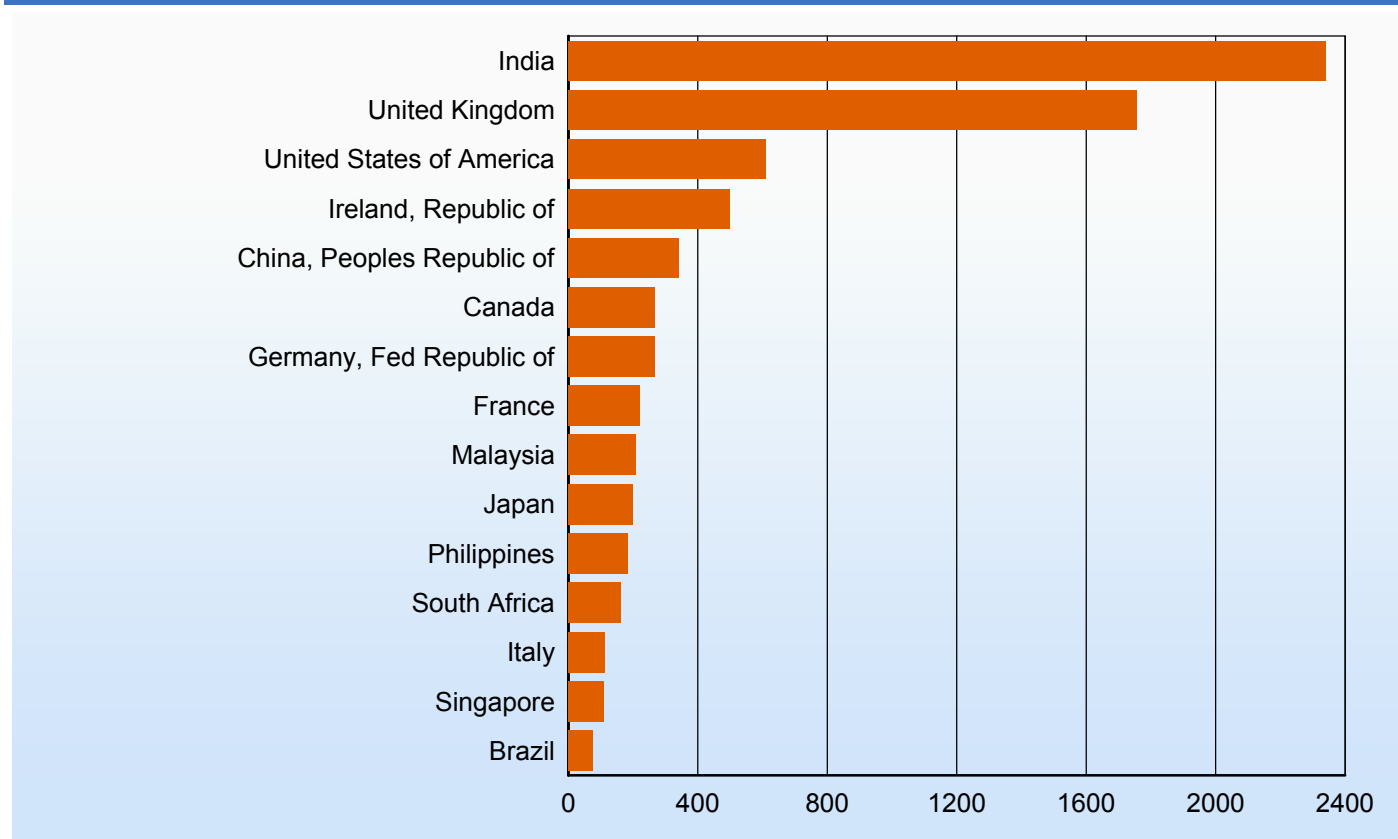

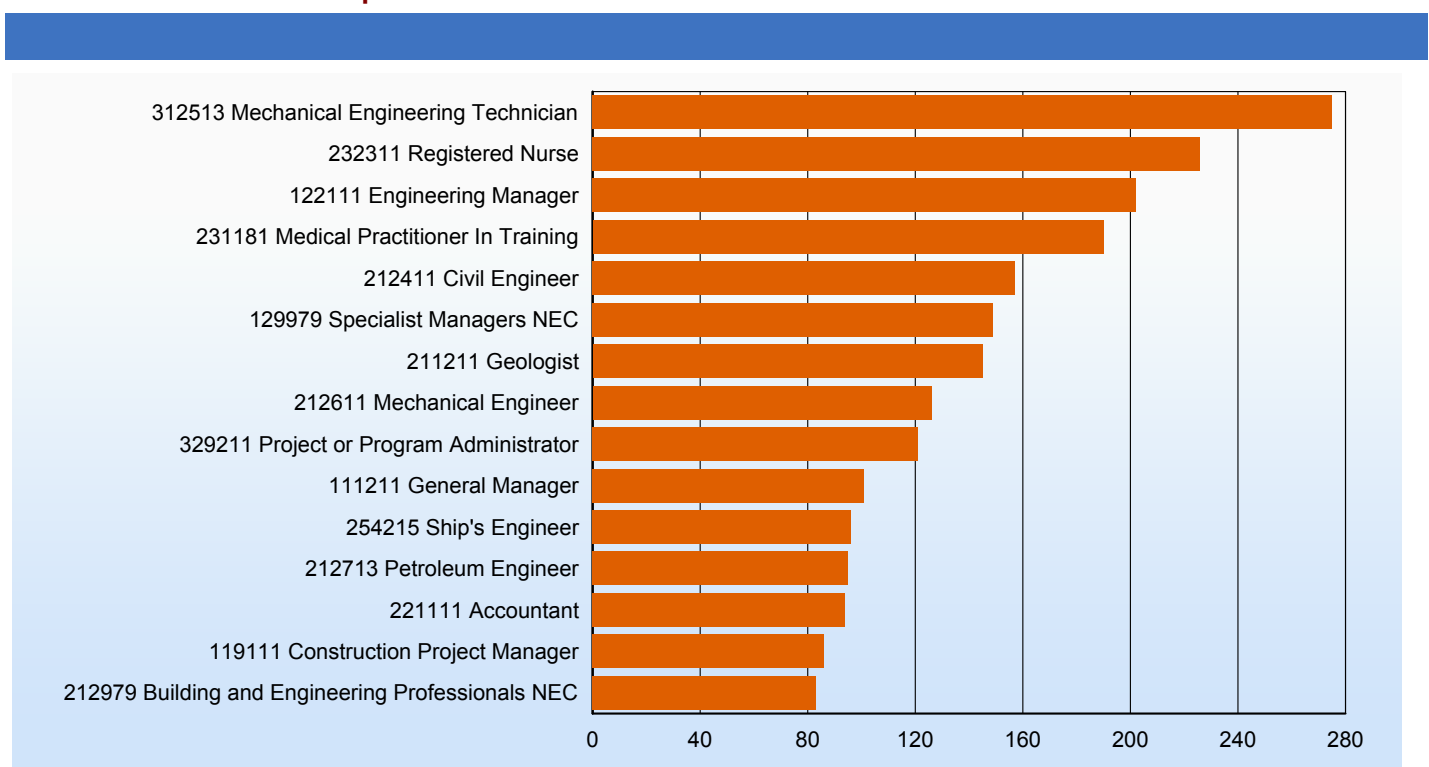
Graph 9.04 Top 15 Nominated occupations for primary applications granted in 2009-10 to 30 June 2010 - nominated positions located in Western Australia
