## Explanatory notes:

- Note 1** All numbers have been rounded to the nearest 10 and salaries to the nearest \$100. Therefore the sum of individual items in a table may not exactly match the total. Where a number in a table is between 1 and 4, the number has been masked with < 5 for privacy reasons.
- Note 2** This report is based on visa grant data recorded for visa subclass 457 in the current financial year and provides a comparison with the SAME PERIOD IN THE PREVIOUS YEAR. It excludes a small number of visa grants made to Independent Executives, who also used to enter on subclass 457 visa but are now included in the Business Skills categories.
- Note 3** The principal data collected on 457 visa holders comes from the visa application and grant process. The applicant and their sponsor provide a range of information to enable DIAC to assess the eligibility of the sponsor and the applicant for the visa. This is the most accurate and verifiable data that DIAC collects on 457 visa holders. It includes such information as the location of the nominated position, the nominated occupation, the nominated base salary and the citizenship country.
- Note 4** Unless otherwise stated, the tables in this report relate to primary applicants only.
- Note 5** Unless otherwise stated, the occupation shown in tables in this report is the nominated occupation. That is, the position that is being filled rather than the previous or usual occupation of the visa applicant.
- Note 6** Sponsors self-identify with an industry classification when lodging a nomination or sponsorship. The industry classification shown is based on what the sponsor has recorded. If a sponsor has notified more than one industry over time, the most recently recorded industry classification has been used in this report.
- Note 7** Up until 1 April 2005, medical practitioners applied for a visa in Visa Subclass 422 Medical Practitioner. From that date, medical practitioners have been encouraged to apply for a Subclass 457 visa.
- Note 8** In tables showing the top 15 citizenship countries, the figure for 'Unknown' is included in the total only.
- Note 9** In some tables, 'Not recorded' or 'Not specified' appears. This mainly relates to visa applications processed in the IRIS system. IRIS does not have the capacity to record comprehensive information about sponsors and nominations. Since 1 November 2003, the ICSE system has largely replaced IRIS for processing subclass 457 visas, but a small number of visas are still processed in IRIS.
- Note 10** From 14 September 2009, subclass 457 visa holders changing sponsor or nominated occupation do not need to lodge a new visa application if they held a valid subclass 457 visa. DIAC estimates that the number of visa applications lodged since 14 September 2009 has been reduced by 8 to 9 per cent below the level that would have occurred without the change.

## Definition of Terms:

ANZSCO Major Group:	Major Group is the highest level in the Australian and New Zealand Standard Classification of Occupations (ANZSCO) 1st Edition produced by the Australian Bureau of Statistics (ABS).
ANZSIC:	Australian and New Zealand Standard Industry Classification 2006 Edition produced by the Australian Bureau of Statistics (ABS). Prior to November 2008, ANZSIC 1993 was used to record industry. Data recorded using ANZSIC 1993 has been converted to ANZSIC 2006 using concordance tables provided by the ABS.
Applicant Type:	<p>Under the Migration Regulations 1994 (the Regulations), there are two types of applicants. These are primary applicants and secondary applicants. These terms are defined below.</p> <p>If the table or graph heading includes the word 'primary', such as 'primary applications' or 'primary visa holders', dependants are not included.</p>
Independent Executive:	Formerly, a group within subclass 457 who did not require a sponsor. They are now included in the Business Skills categories. A small number of visa applications for Independent Executives were finalised in the current year.
Last Visa Held:	This refers to the last substantive visa held by a visa holder (that is, the last visa other than a bridging visa) prior to a point in time. The last visa held may have expired or still be in effect.
Nominated Base Salary:	Represents the gross annual salary based on a 38 hour week that the employer has indicated they will pay to the primary visa holder. These amounts do not include the value of salary packaged items, bonuses, commissions or other payments listed in the schedule to the legislative instrument specifying Minimum Salary Levels for the Subclass 457 program.
Nominated Occupation:	The occupation of the nominated position that the primary visa holder will be filling in Australia while holding the Subclass 457 visa based on the Australian Standard Classification of Occupations (ANZSCO) 1st Edition.
Nominated Position Location:	The State or Territory where the visa holder will be working. This may be different from the business address of the sponsor and/or the visa processing office.
Nominated Total Remuneration:	The total value of the salary package including base salary, allowances, bonuses and superannuation.
Pathway:	A visa holder moving from one type of visa to another type of visa. Most commonly used in relation to visa applicants moving from a temporary visa to a permanent/provisional visa. The original visa is determined by the last visa held prior to permanent/provisional visa grant and the visa applicant may be onshore or offshore.
Permanent/provisional visa:	A visa subclass which is countable for the purposes of the migration program.
Primary Applicant:	The primary applicant is the person who must satisfy the primary criteria for the grant of a visa under the Migration Regulations.
Primary Application:	An application lodged by a primary applicant.
Secondary Applicant:	Secondary applicants must satisfy the secondary criteria for the grant of a visa under the Regulations. In this case, a secondary applicant is generally a dependant of the primary applicant.
Secondary Application:	A visa application lodged by a secondary applicant.
Sponsor Industry:	The industry self-identified by the sponsoring client using the Australian and New Zealand Standard Industry Classification (ANZSIC) 2006 edition.

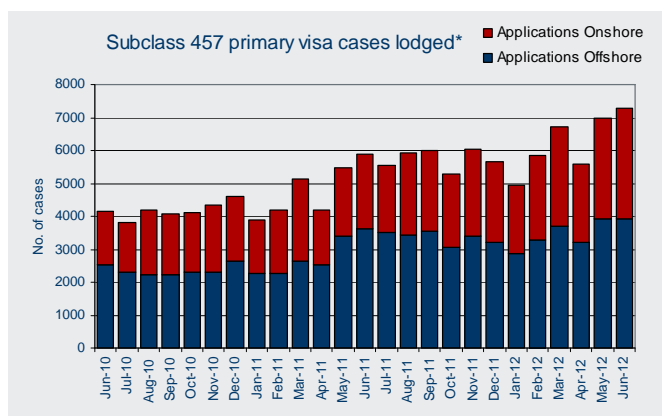
# Trends in the subclass 457 Business (Long Stay) visa program in the 2011-12 program year<sup>1</sup>

## Key points

- The number of subclass 457 primary visa applications lodged in 2011-12 (July to June) was 33.4 per cent higher than the same period last program year.
- The number of subclass 457 primary visas granted in 2011-12 was 42.1 per cent higher than the same period last program year.
- The number of primary visa holders in Australia at 30 June 2012 was 91 050 and reflected an increase of 26.4 per cent in comparison with the same date in the previous year.
- Offshore primary visa lodgements in 2011-12 were 33.6 per cent higher than the same period last program year, reflecting continued strong employer demand for temporary skilled workers.

## Visa application trends

The number of subclass 457 primary visa applications lodged in 2011-12 was 33.4 per cent higher than the same period last program year. Compared with the previous month, the number of primary applications lodged in June 2012 was 4.2 per cent higher.



In 2011-12, primary applications offshore were 33.6 per cent higher than the same period last program year. The number of primary applications offshore for June 2012 was steady compared with their level in May 2012.

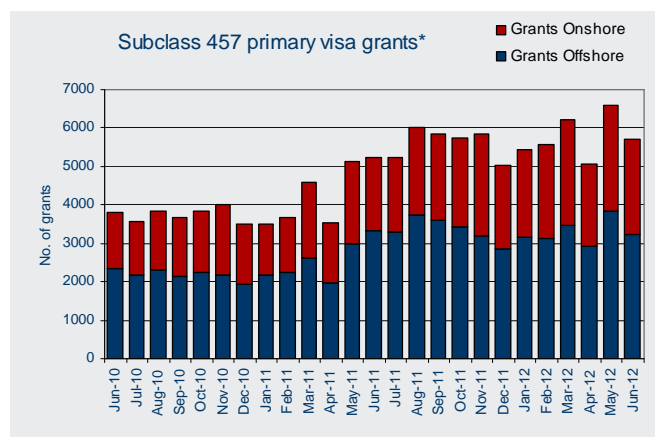
The number of onshore primary applications in the 2011-12 program year was 33.2 per cent higher than the same period in the last program year. Primary applications onshore for June 2012 were 9.8 per cent higher than in May 2012.

The number of ANZSCO Major Group 3 (Technicians and Trades workers) primary applications grew strongly and was 79.5 per cent higher in 2011-12, compared with the same period last program year. During the same period, the number of ANZSCO Major Group 1 (Managers) and Group 2 (Professionals) primary applications increased by 28.2 per cent and 17.1 per cent respectively.

## Visa grant trends<sup>2</sup>

The number of subclass 457 primary visas granted in 2011-12 was 42.1 per cent higher than the same period last program year. Compared with the previous month, the number of primary visas granted in June 2012 was 13.4 per cent lower.



In 2011-12, offshore primary visa grants were 41.2 per cent higher than the same period last program year. Compared with May 2012, the number of offshore primary visa grants was 15.7 per cent lower in June 2012. Offshore primary grants reflect additions to the Australian labour force.

In 2011-12, onshore primary visa grants were 43.3 per cent higher than the same period last program year. The number of onshore primary visa grants in June 2012 was 10.1 per cent lower than in May 2012.

In 2011-12, 69.2 per cent of primary visa grants were to Managers and Professionals and 24.2 per cent were to Technicians and Trades Workers.<sup>3</sup>

<sup>2</sup> The rate at which visa applications are processed is subject to a number of variables including: the number of working days in a month, the number of public holidays and the occurrence of school holidays.

<sup>3</sup> The Department of Immigration and Citizenship replaced the Australian Standard Classification of Occupations (ASCO) with the Australian and New Zealand Standard Classification of Occupations (ANZSCO) from 1 July 2010. This will affect comparisons between the earlier period and the subsequent program years.

The majority of primary subclass 457 visa grants in 2011-12 were for positions in New South Wales (33.0 per cent), Western Australia (23.8 per cent) and Victoria (20.0 per cent). These states were also the top three nominated locations for primary subclass 457 visa grants in the previous program year. In 2011-12, the number of primary subclass 457 visa grants for Western Australia increased by 75.6 per cent, compared with the last program year. During the same period, the primary grants for New South Wales increased by 65.3 per cent.

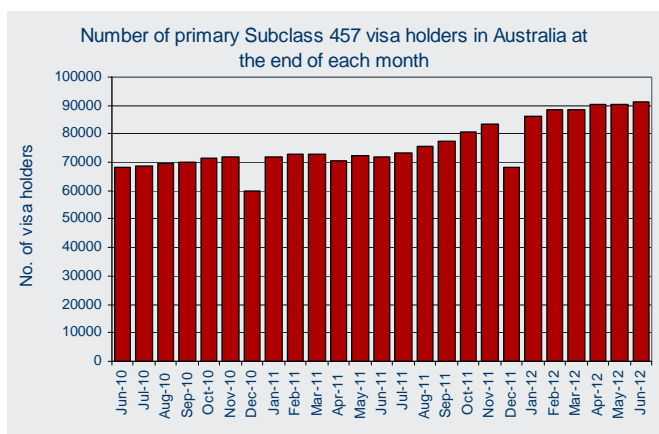
The top three industries for primary visa grants in 2011-12 were Construction (13.4 per cent), Other Services (11.6 per cent) and Health Care and Social Assistance (11.5 per cent).

Subclass 457 visa grants for Program or Project Administrators, which was at the top of the table for occupations in demand, increased by 3.2 per cent in 2011-12 compared with the same period last program year. This was followed by Developer Programmer which increased by 3.0 per cent. Specialist Managers nec (not elsewhere classified) ranked third in the list of occupations in demand and registered a growth of 2.4 per cent during the same period.

The top three citizenship countries for primary visa grants 2011-12 were the United Kingdom (23.1 per cent), India (17.5 per cent) and Republic of Ireland (9.2 per cent).

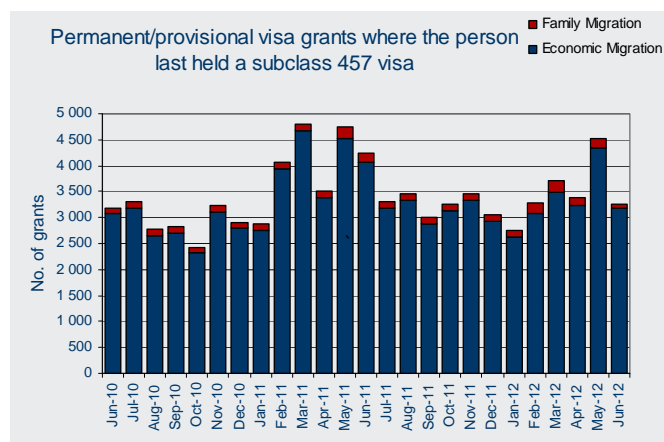
### Number of primary subclass 457 visa holders in Australia

The number of primary visa holders in Australia on 30 June 2012 was 91 050. This reflected an increase of 26.4 per cent compared with the same date in the previous year. Compared with 31 May 2012, the number of onshore subclass 457 primary visa holders was 0.9 per cent higher on 30 June 2012.



### Flow of subclass 457 visa holders to permanent residence

In 2011-12, the number of subclass 457 visa holders granted a permanent residence visa was 2.9 per cent lower than the same period last program year.



Compared with the previous month, the number of subclass 457 visa holders who were granted a permanent residence visa in June 2012 was 28.2 per cent lower.

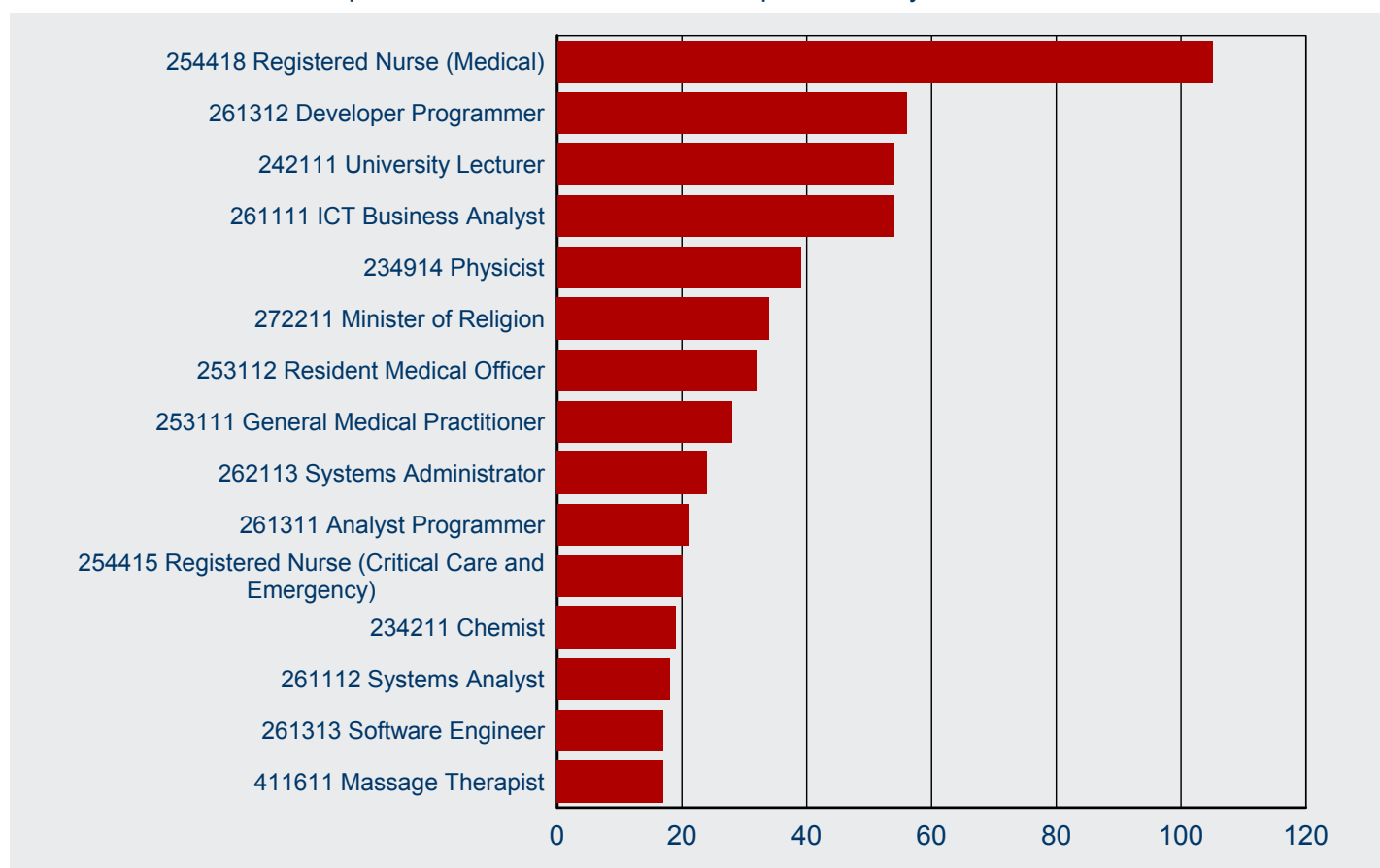

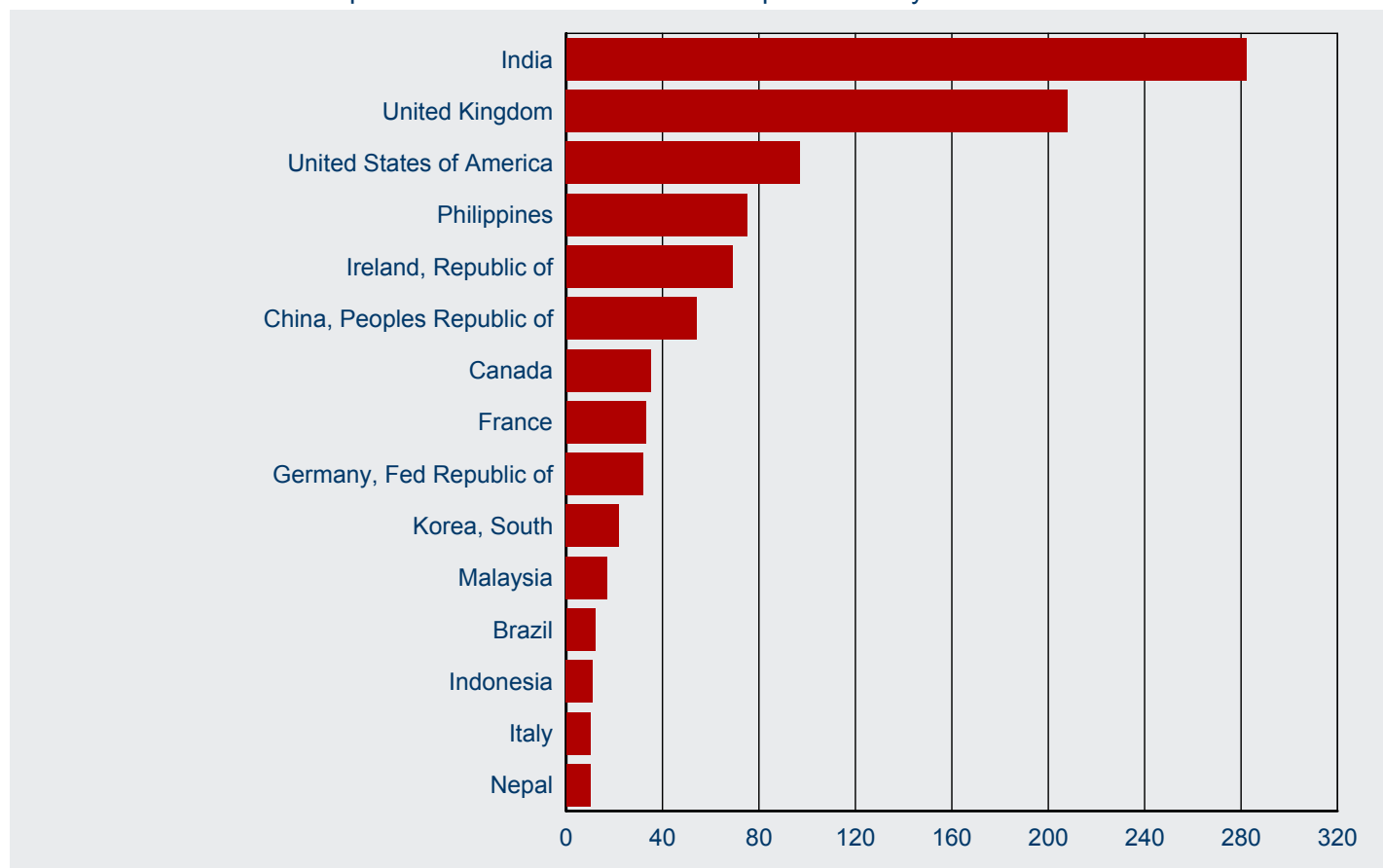

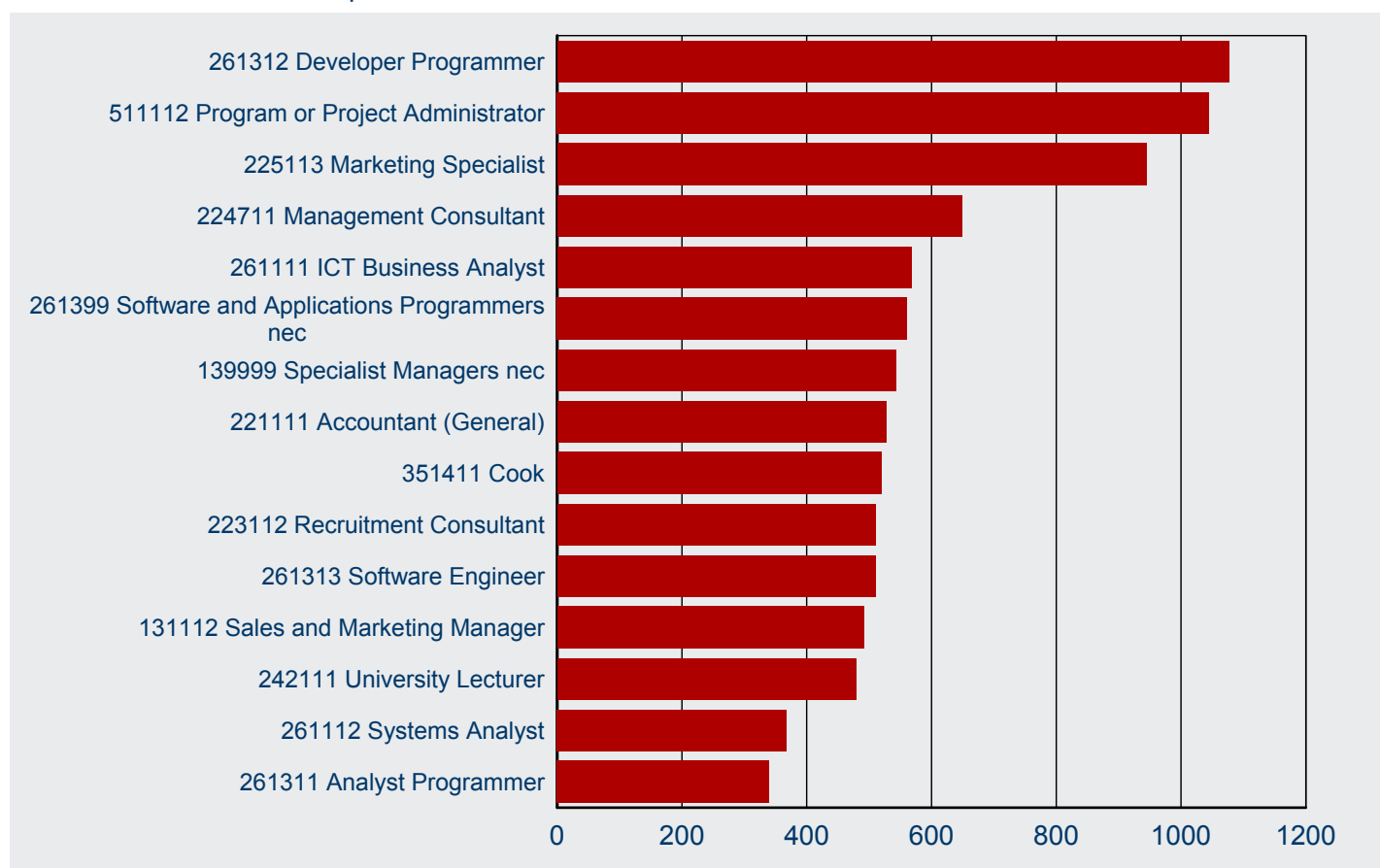

Graph 3.04 Top 15 Nominated occupations for primary applications granted in 2011-12 to 30 June 2012 - nominated positions located in New South Wales

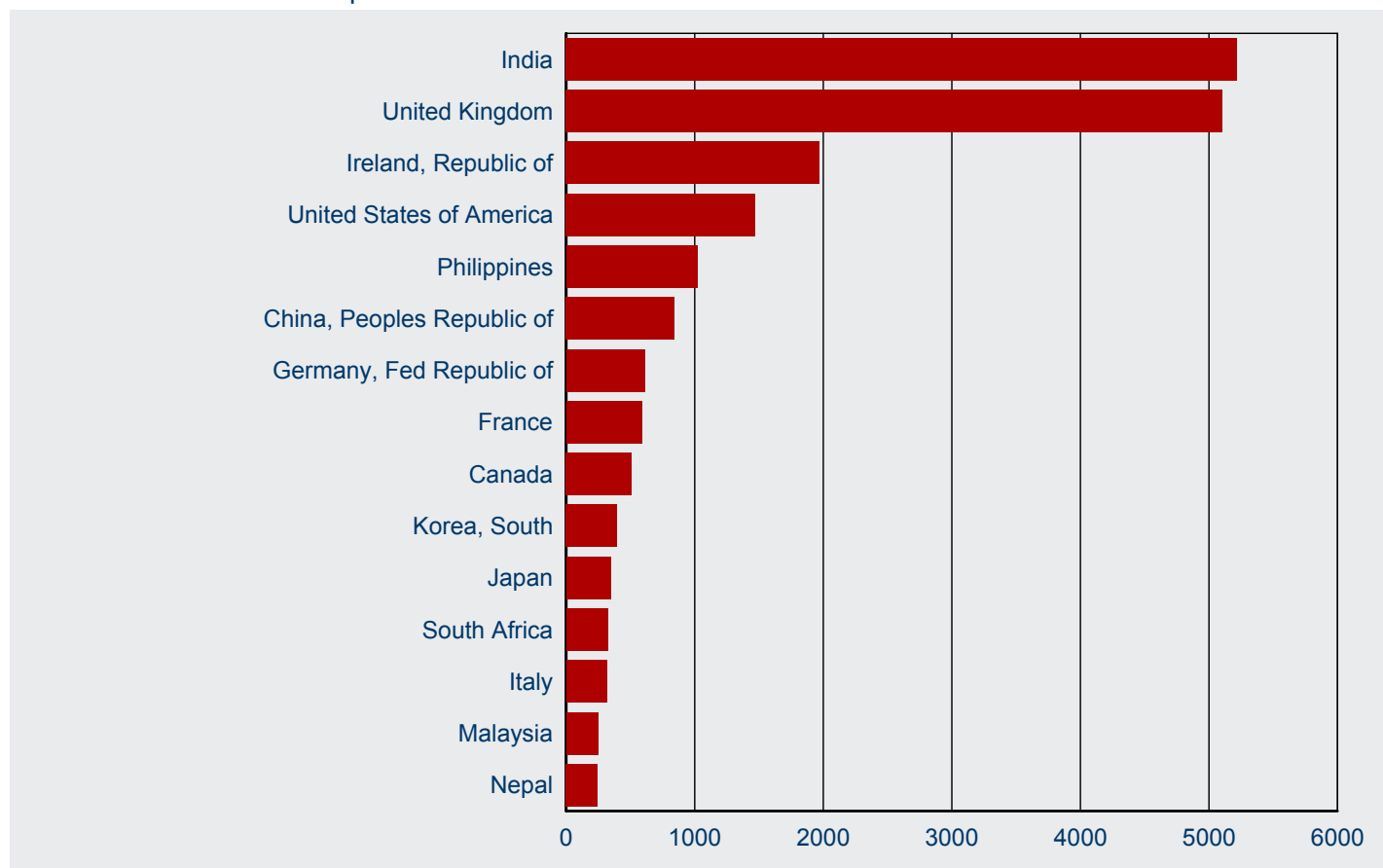

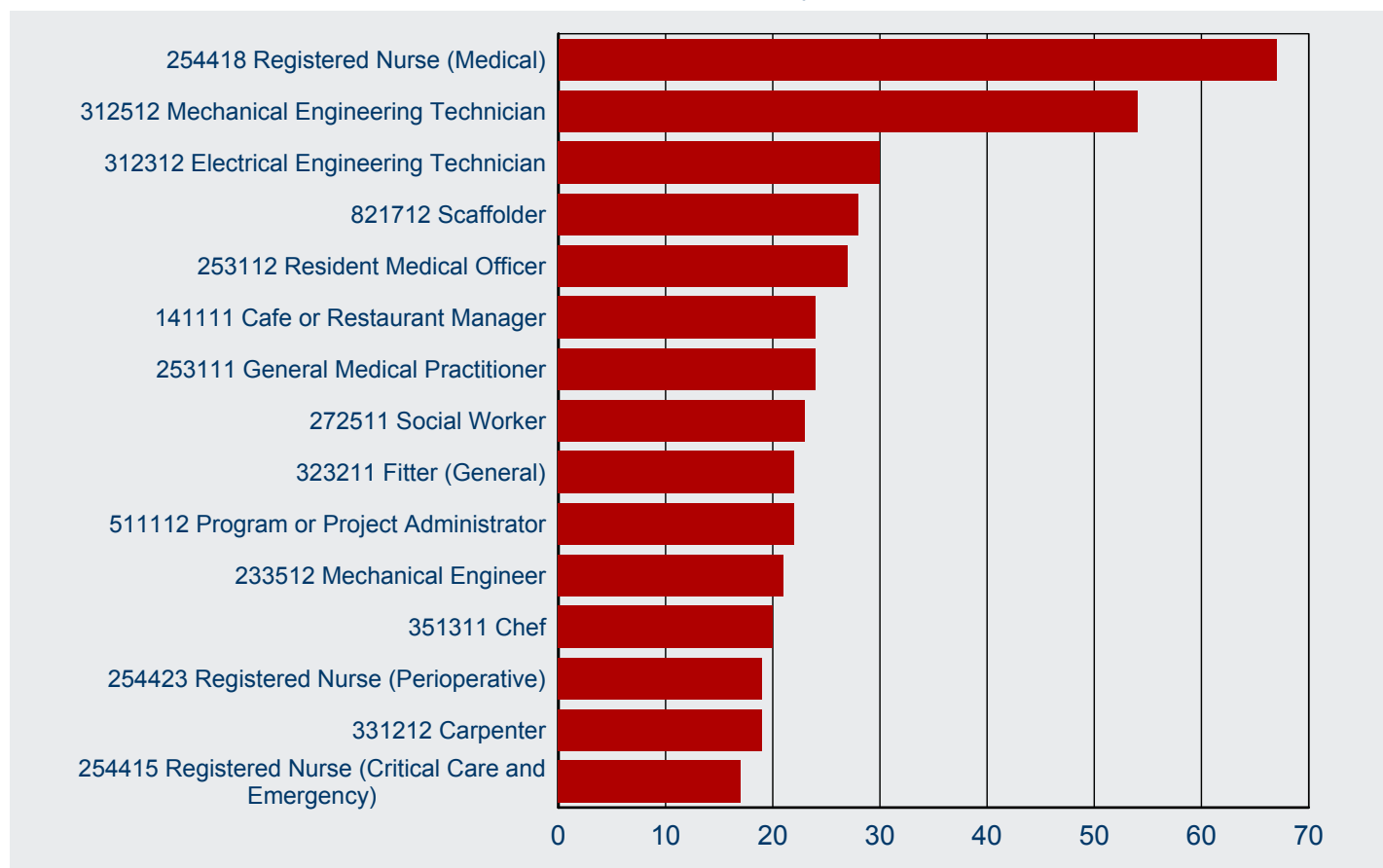

Graph 4.04 Top 15 Nominated occupations for primary applications granted in 2011-12 to 30 June 2012 - nominated positions located in Northern Territory

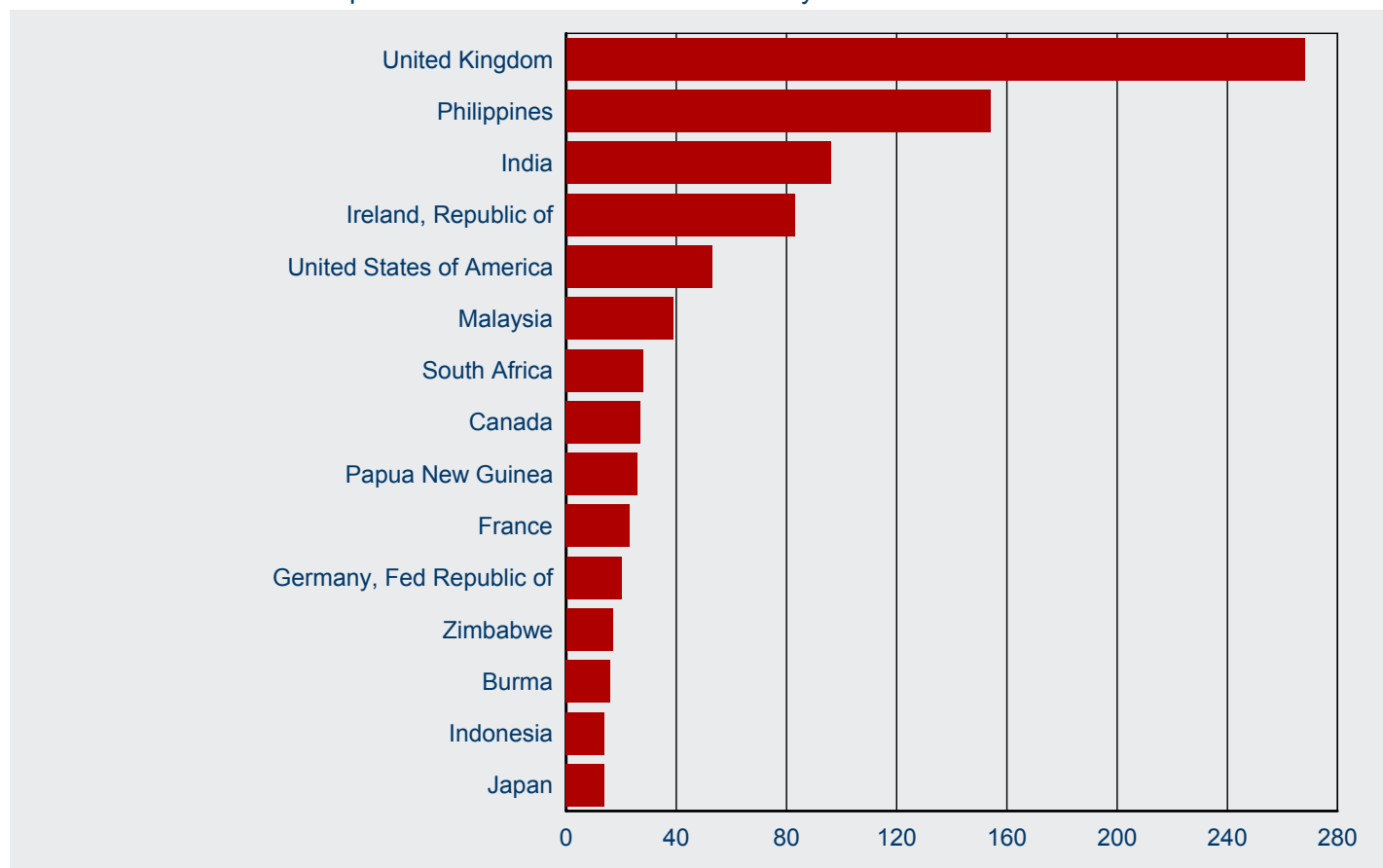

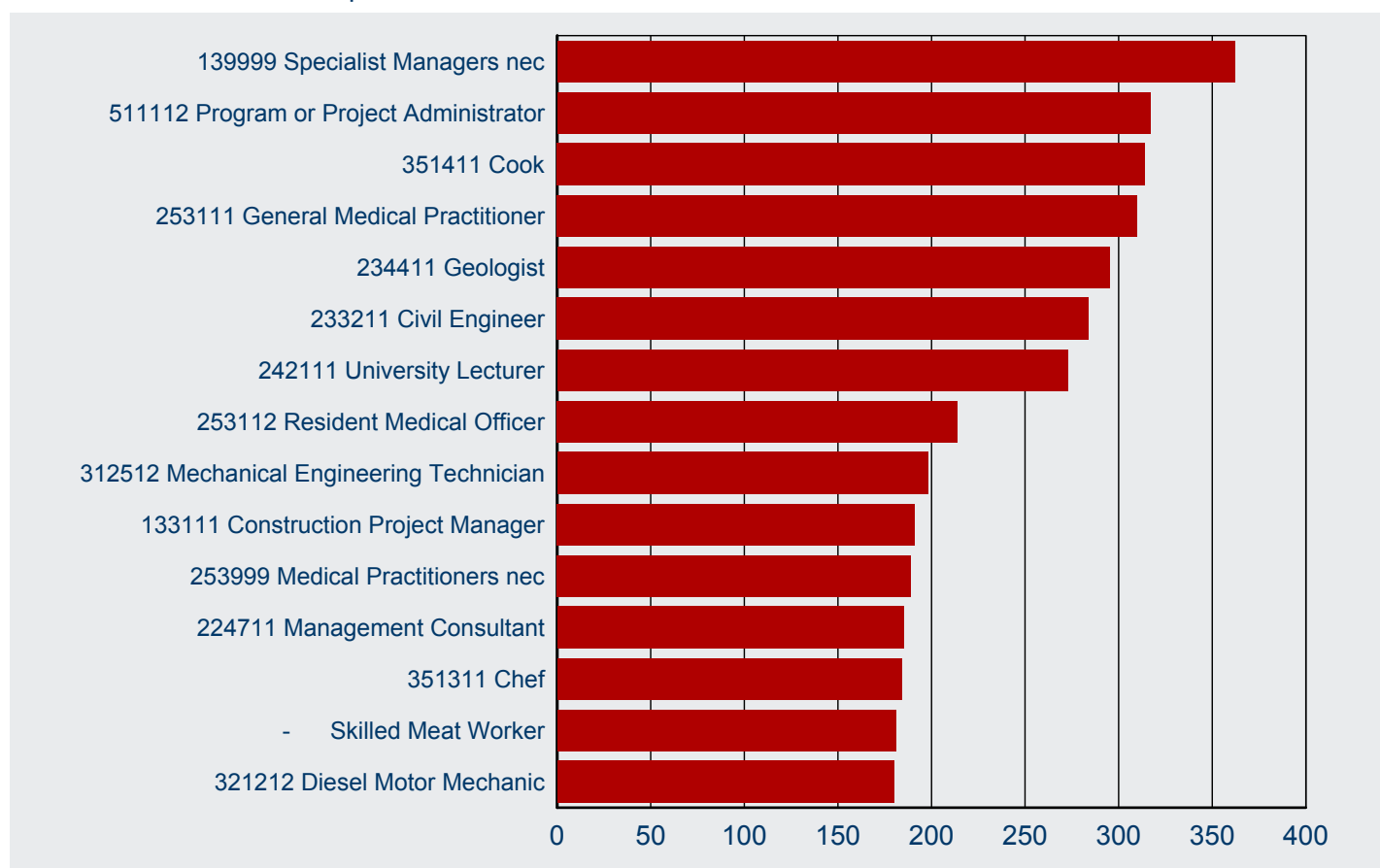

Graph 5.04 Top 15 Nominated occupations for primary applications granted in 2011-12 to 30 June 2012 - nominated positions located in Queensland

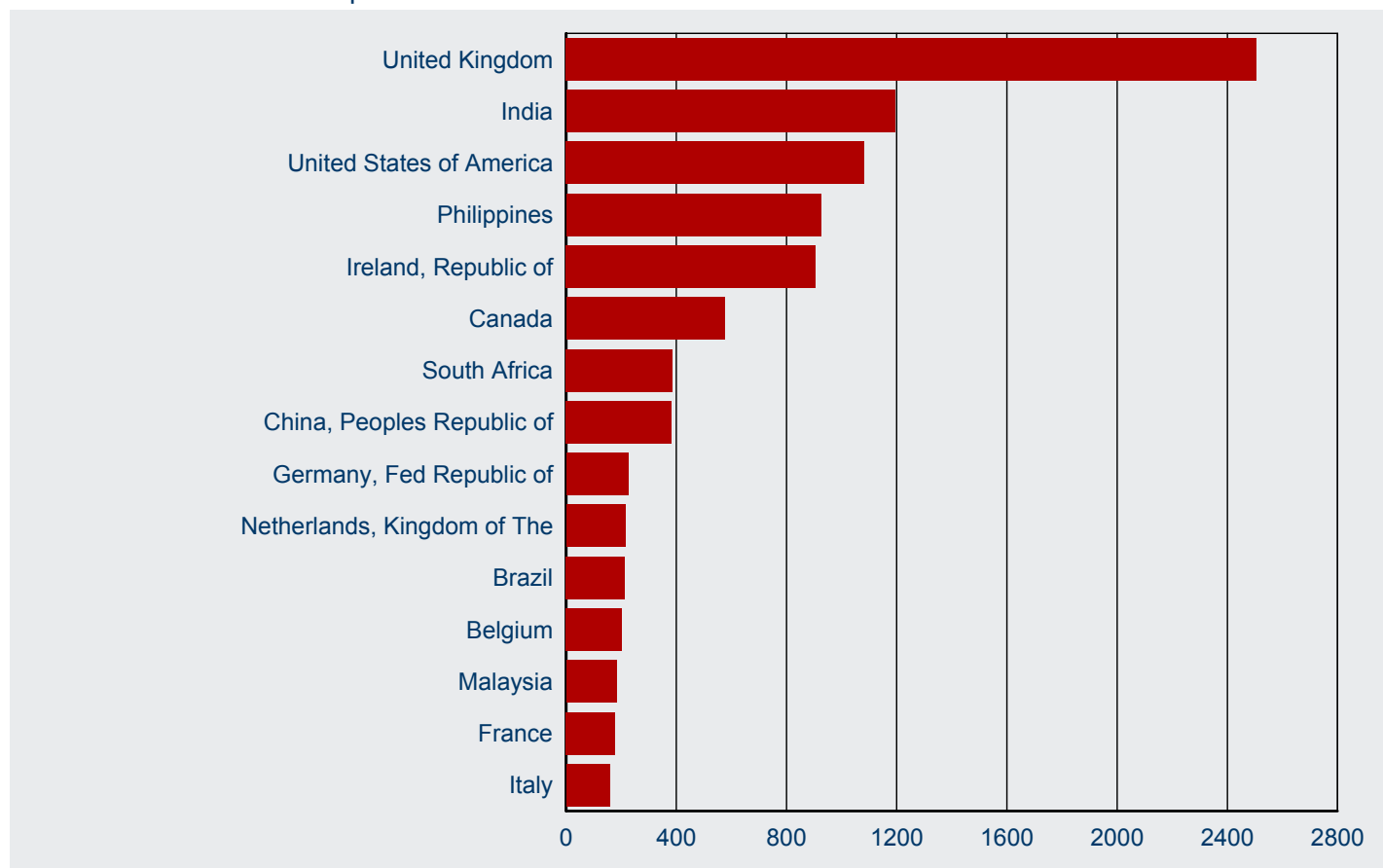

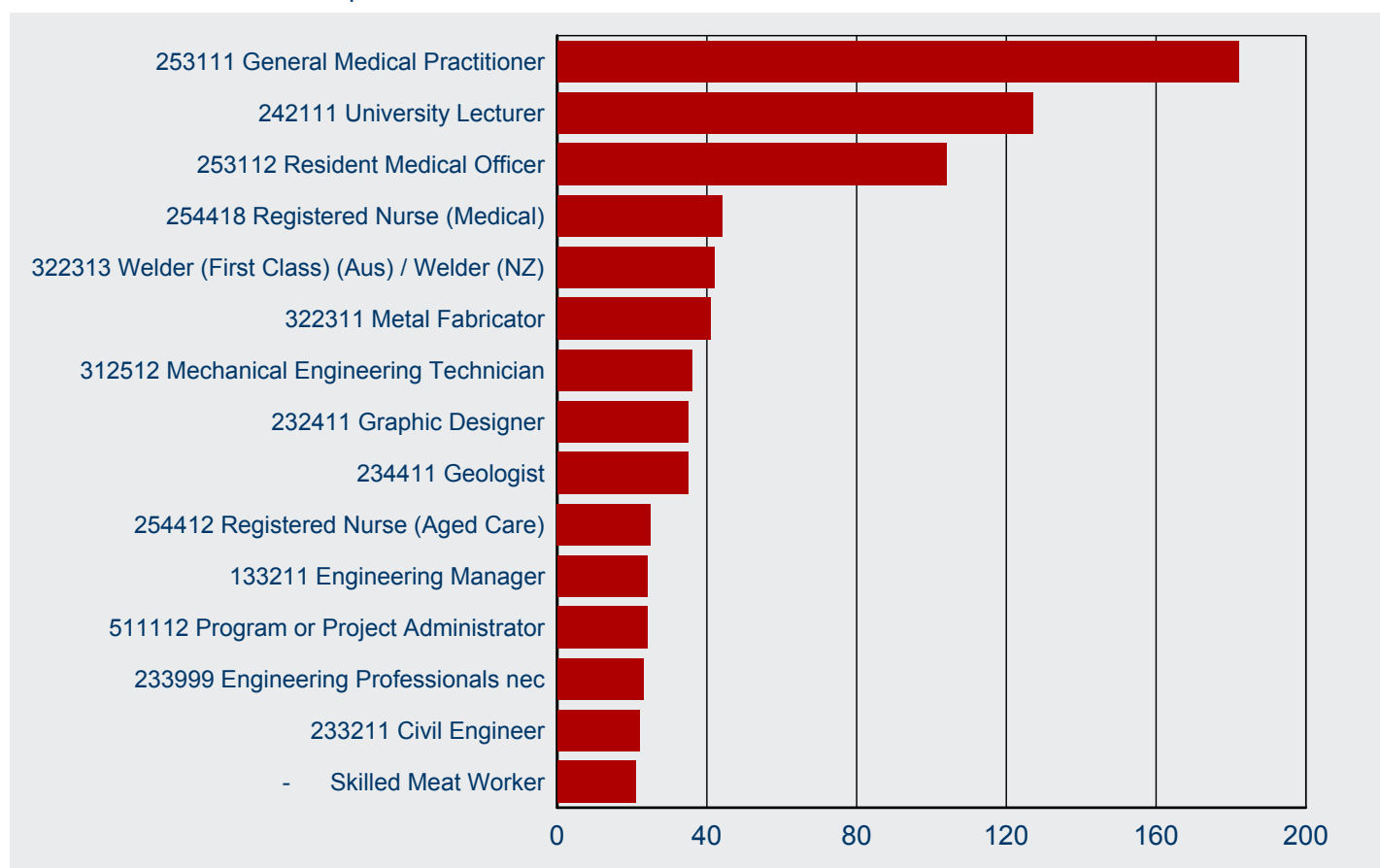

Graph 6.04 Top 15 Nominated occupations for primary applications granted in 2011-12 to 30 June 2012 - nominated positions located in South Australia

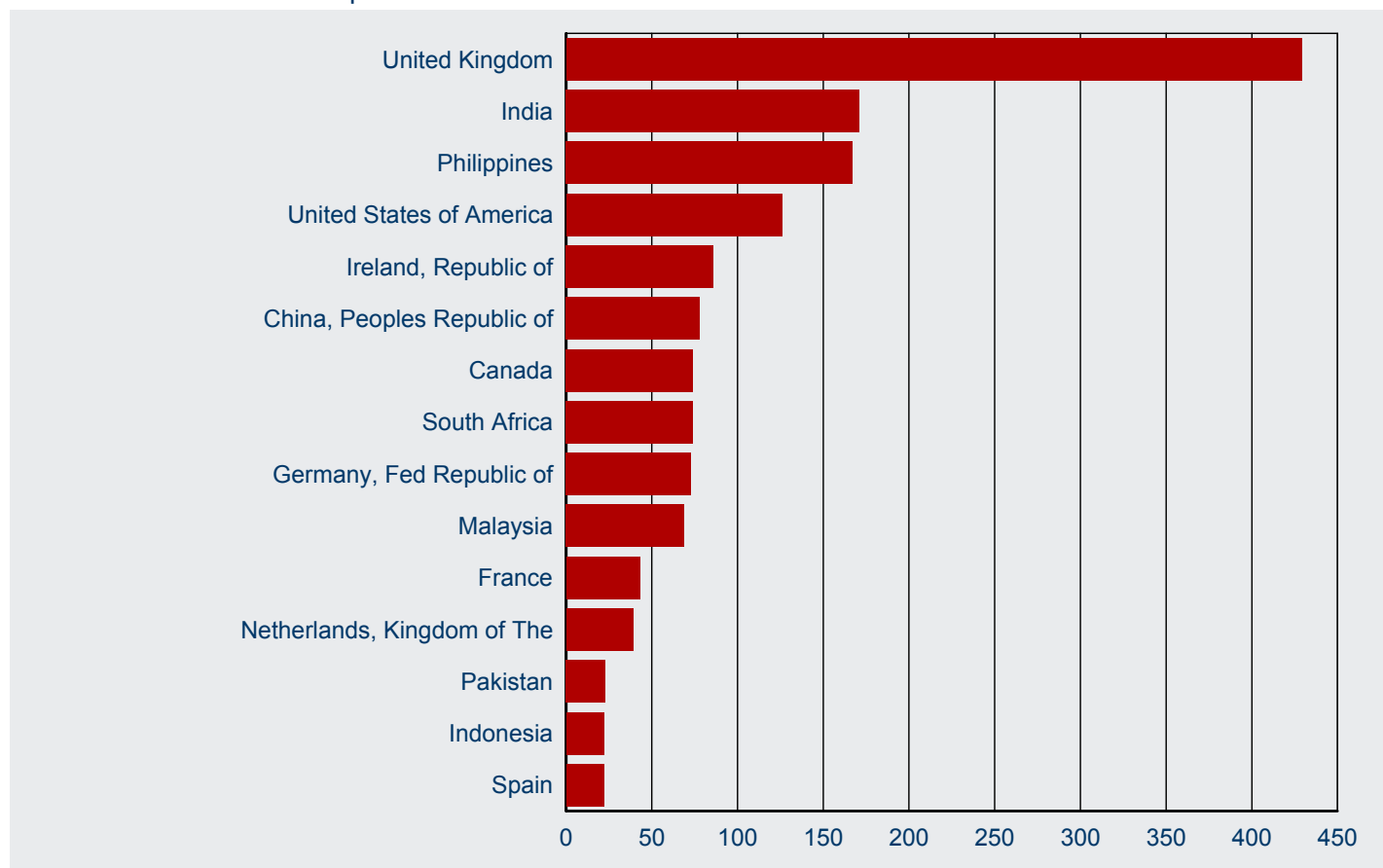

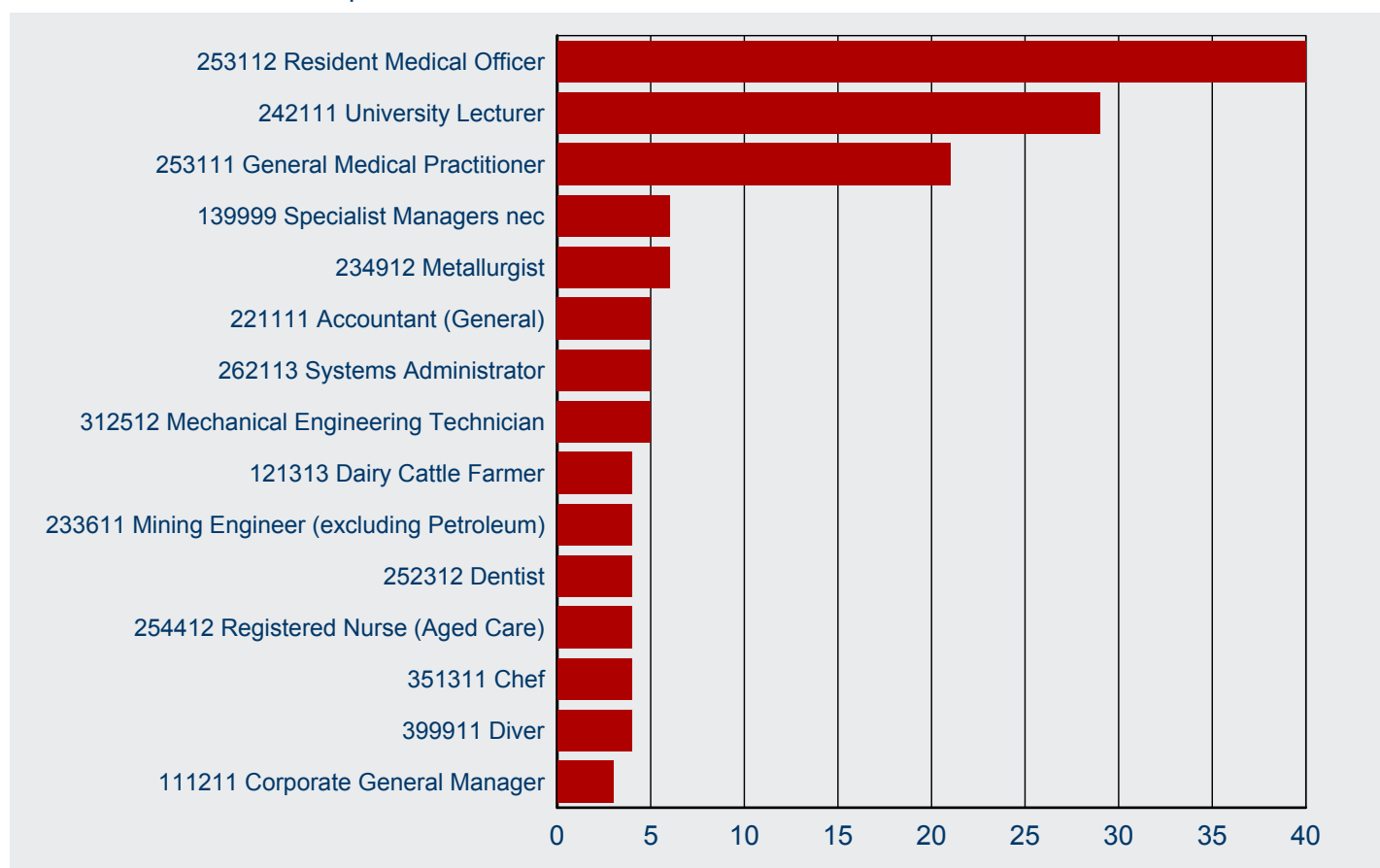

Graph 7.04 Top 15 Nominated occupations for primary applications granted in 2011-12 to 30 June 2012 - nominated positions located in Tasmania

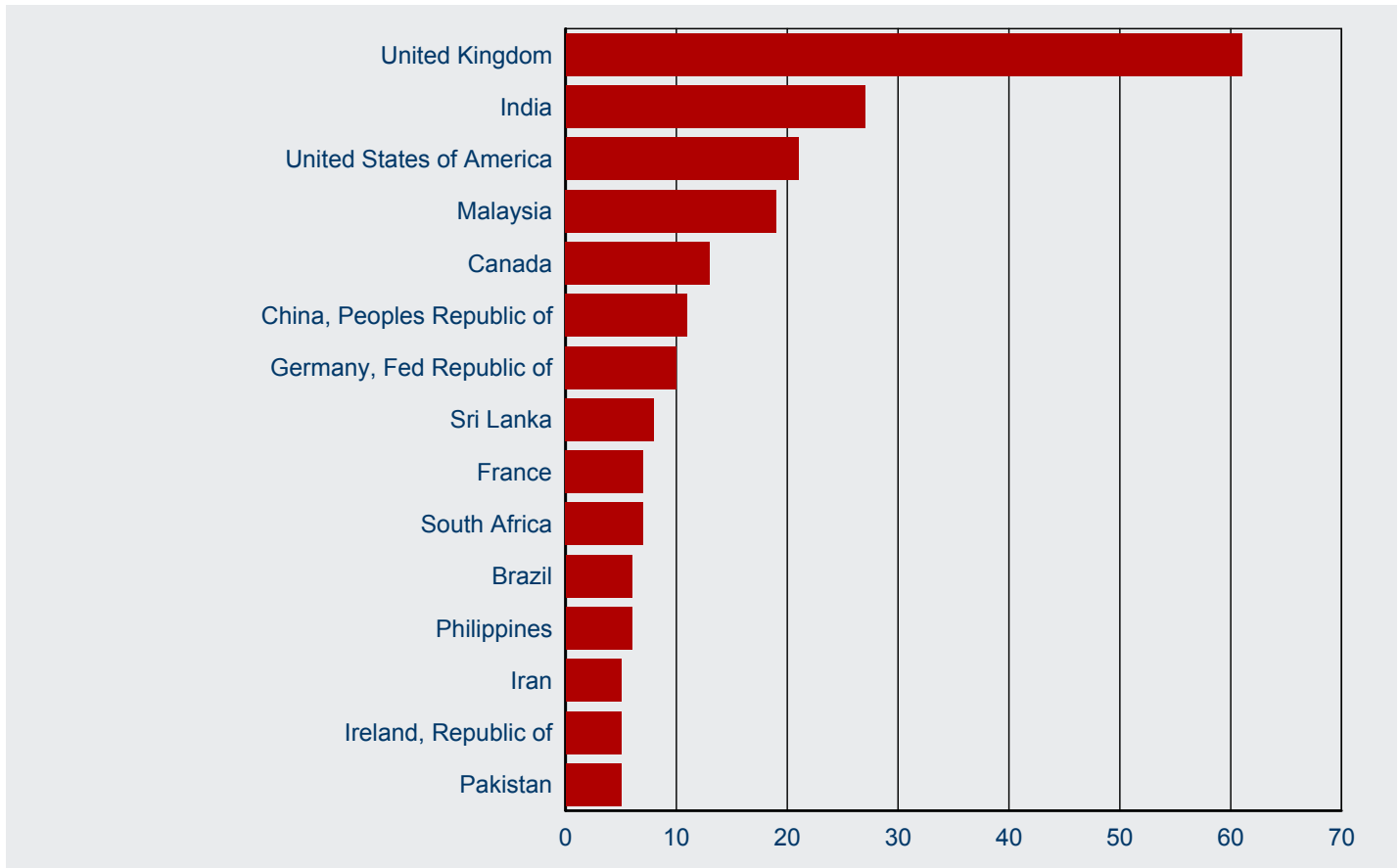

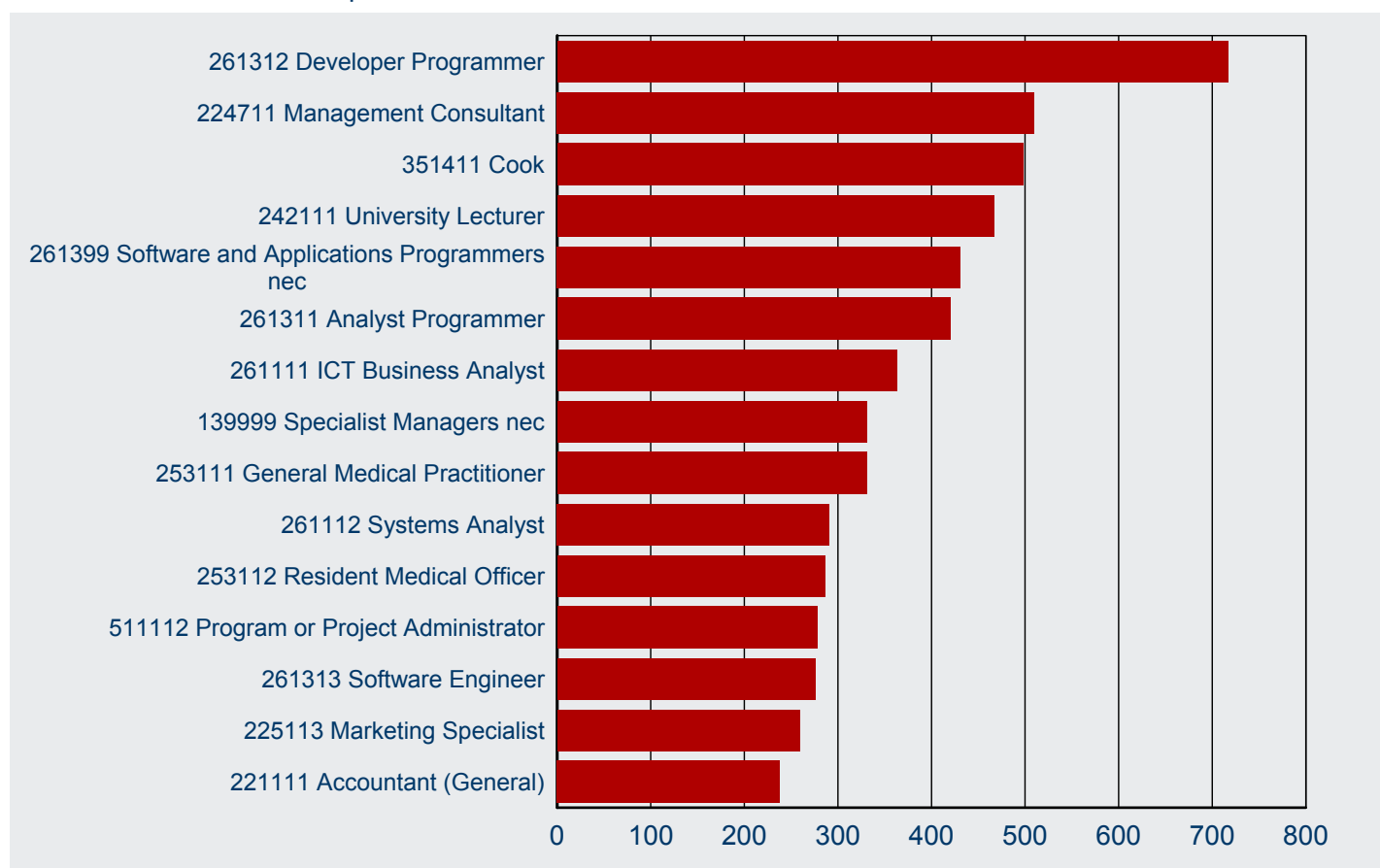

Graph 8.04 Top 15 Nominated occupations for primary applications granted in 2011-12 to 30 June 2012 - nominated positions located in Victoria

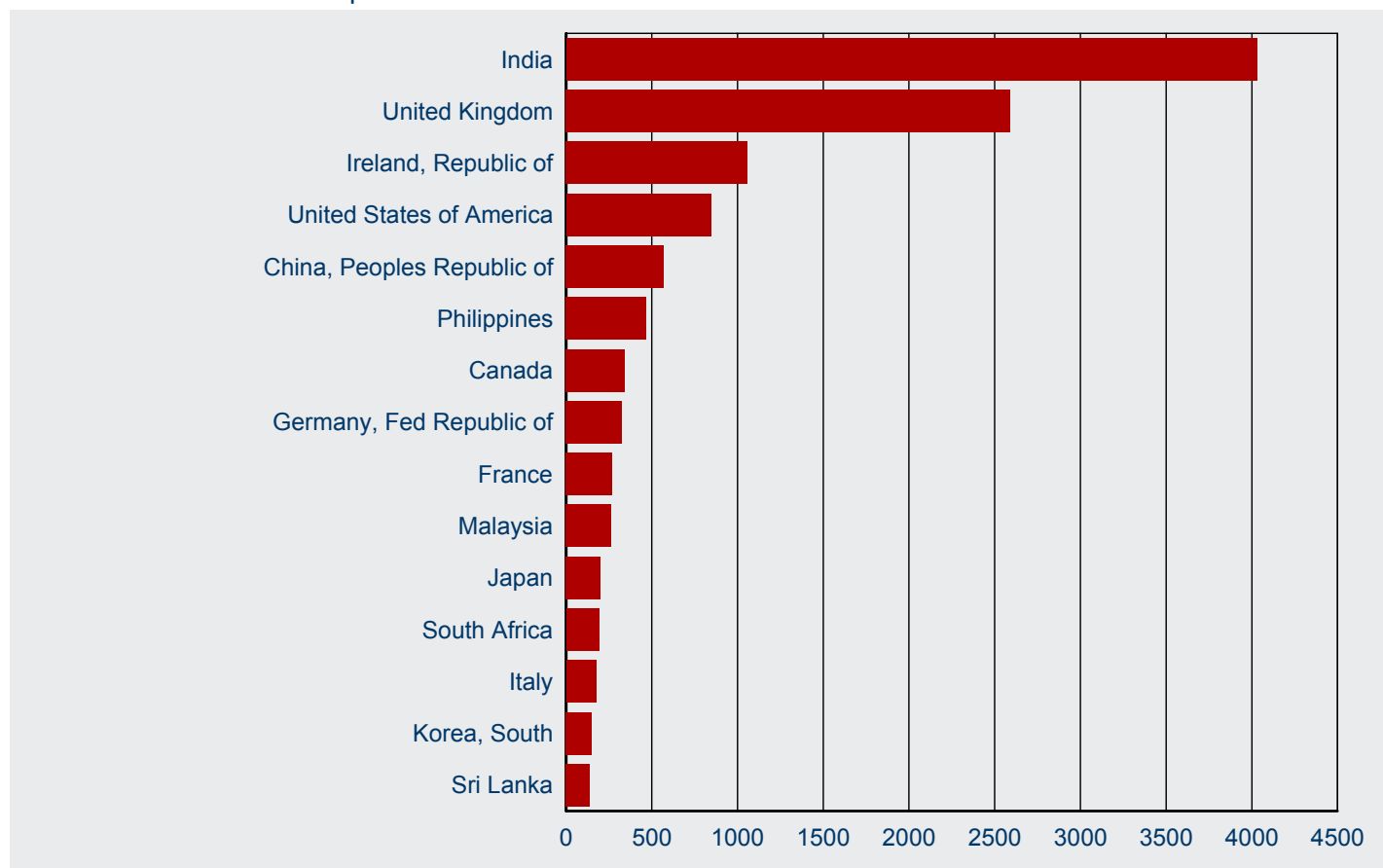

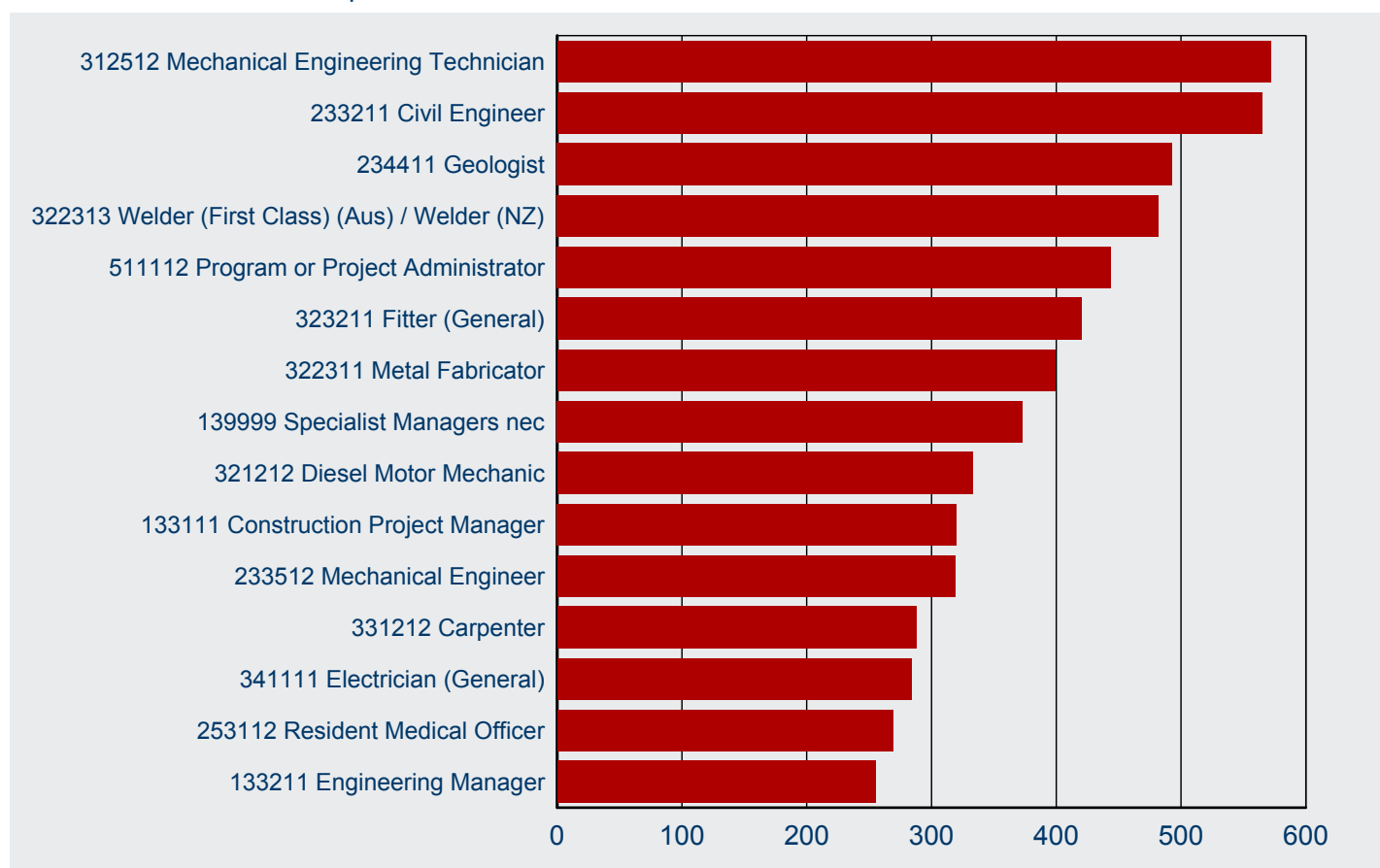
