


Character (s501) and general cancellation statistics

All statistics in this document are for the financial years 2018-19 to 2023-24 (as at 31 December 2023)

As data has been drawn from a dynamic system environment, the information is correct at the time of publication and figures may differ slightly from previous or future reporting.

Character cancellations and refusals

Figure 1: s501 cancellations and refusals, 1 July 2018 to 31 December 2023



Data does not include 19 ministerial cancellations made for non-citizens subsequently released from detention with a reinstated visa following the Full Federal Court judgment in *Pearson v Minister for Home Affairs* [2022] FCAFC 203 on 22 December 2022. On 13 February 2023, the *Migration Amendment* (Aggregate Sentences) Act 2023 validated the first cancellation decisions made for this cohort, resulting in the subsequent ministerial cancellations decisions now considered a nullity at law.



Figure 3: s501 cancellations with breakdown of the nationality of the person subject to cancellation, 1 July 2018 to 31 December 2023



Figure 4: s501 cancellations by primary category of offending, 1 July 2018 to 31 December 2023



Figure 5: s501 cancellations by subclass of the visa cancelled, 1 July 2018 to 31 December 2023



Figure 6: Proportion of revoked and not revoked decisions for revocation requests, 1 July 2018 to 31 December 2023




Figure 8: General cancellations with breakdown of the nationality of the person subject to cancellation, 1 July 2018 to 31 December 2023



Figure 9: General cancellations by category of the visa cancelled**, 1 July 2018 to 31 December 2023


