From July 2020, detainees residing in APODs are reported under 'APODs' rather than under the IDC that had responsibility for their management and care. APODs include hospitals, aged-care facilities, mental health inpatient facilities, as well as hotel and apartment style accommodation. The number of individuals in APODs is provided by the State and Territory of the APODs.

Important Notice on ITAs

For reports released from July 2023 onwards, detainees residing within Immigration Transit Accommodation (ITA) facilities are reported under Immigration Detention Centres (IDCs). There is no change to the management and care of detainees within the affected ITAs.

Immigration Detention and Community Statistics Summary

At 31 May 2023, there were 1110 people in immigration detention facilities.

Of the 1110 people in immigration detention facilities, 1014 (91.4 per cent) have a criminal history.

A further 288 people were living in the community after being approved for residence determination and 10,821 UMAs were living in the community after grant of a Bridging Visa E.

In Community under Residence Determination Population by State/Territory

Of the 288 people approved for a residence determination to live in the community, 57.6 per cent were in Victoria, 28.5 per cent in Queensland, 10.8 per cent in New South Wales and 3.1 per cent in Western Australia.

Immigration Detention Population

From January 1990 to Current

The overall number of people in immigration detention including in the community under residence determination has decreased by 573 to 1398 compared with 1971 at the end of May 2022. This number takes into account detainees in the community under residence determination and detainees who were held in immigration detention facilities as at 31 May 2023.

Figure 1 – Population in Immigration Detention




Figure 1 above, shows the number of people in immigration detention from 1990 to 2023.

People In Immigration Detention Facilities

Arrival Type

There were 191 people who arrived unlawfully by air or by boat, in held immigration detention facilities at 31 May 2023 representing 17.2 per cent of the total immigration detention population.

There were also 919 people (82.8 per cent of the total immigration detention population) who arrived in Australia lawfully and were subsequently taken into immigration detention for either overstaying or having their visas cancelled for reasons including failing the character test, breaching their visa conditions or presenting a risk to the safety, health or good order of the community.

Figure 2 – People in Held Immigration Detention Facilities by Detention Group




Figure 2 above, shows the number of people in held immigration detention facilities at 31 May 2023 by detention group, including Overstayers, S501 and Other Visa Cancellations, Unauthorised Maritime Arrivals, Unauthorised Air Arrivals, and if applicable – Illegal Foreign Fishers and Others such as stowaways and ship deserters.

People In Immigration Detention

Nationality

At 31 May 2023, there were 1110 people in held immigration detention facilities. Of these 1110 people, 16.6 per cent were from New Zealand, 8.8 per cent were from Iran, 6.0 per cent were from Vietnam, 5.5 per cent were from India and 5.0 per cent were from Sudan.

At 31 May 2023, 288 were people living in the community after being approved for a residence determination. Of these 288 people, 46.5 per cent were from Iran, 9.0 per cent were Stateless, 6.9 per cent were from Sri Lanka, 6.9 per cent were from Somalia and 5.9 per cent were from Iraq.

Children In Immigration Detention

At 31 May 2023 there were no children (aged less than 18 years) in Immigration Detention Facilities and Alternative Places of Detention.

Figure 3 - Children in Immigration Detention Facilities and Alternative Places of Detention




Figure 3 above, shows the number of children in IDFs and APODs from January 2013 to the date of this report. The continuous increase in the number of children in IDFs from April 2013 to Aug 2013 was due to a rapid increase in UMAs during this period. The number of children in IDFs continued to decline during the late 2013 and 2014, with further reduction in January 2015.

At 31 May 2023, the number of children living in the community after being approved for a residence determination has decreased by 12 to 83 from 95 since the previous report.






Figure 4 above, shows the number of children in the community under residence determination from January 2013 to the date of this report. The number of children in the community under residence determination, has levelled off at its lowest number since the peak in November 2013, as a result of releases into the community on Bridging E visas.

Time In Immigration Detention Facilities

At 31 May 2023, there were 1110 people in immigration detention facilities.

Of these 1110 people, 24.5 per cent had been detained for 91 days or less and 48.7 per cent had been detained for 365 days or less.

At 31 May 2023, the average period of time for people held in detention facilities was 727 days.

Figure 5 – Average Number of Days of People in Held Immigration Detention Facilities only




Figure 5 above, shows the average days in held immigration detention at the end of each month from January 2013 to the date of this report. The average period of time for people held in detention facilities steadily increased from July 2013 to January 2015. Between November 2018 and December 2019 the average number of days remained at around 500. Since January 2020 the average period of time for people held in detention facilities has steadily increased until January 2023, after which there has been an overall moderate decrease.

The time an individual spends in immigration detention depends on a range of factors, including the complexity of their case, the legal processes they pursue and whether they voluntarily choose to leave Australia.

Time In Community Under Residence Determination

Of the 288 people in the community under residence determination, as at 31 May 2023, 6.9 per cent had been in the community for 91 days or less and 19.4 per cent had been in the community for 365 days or less.
