### **About this report**

This report provides data about the permanent Migration Program administered by the Department of Home Affairs (the Department). This report does not include data on the permanent Humanitarian Program.

This report is published annually.

Data is sourced from several departmental visa processing and recording systems.

For privacy reasons, <5 has been used where a number in a table is between 1 and 4. In instances where this figure is deducible from a provided total, the next lowest number is masked accordingly to maintain privacy.

### **Definition of terms**

Activity: For the purposes of Migration Program reporting, this refers to visa processing

activity status and includes counts of lodgements, finalisation types (grant, refusal, withdrawal) and applications onhand. Activity data may also include second stage

permanent applications that do not count toward the Migration Program.

ANZSCO: Occupation data in this report utilises the Australian and New Zealand Standard

Classification of Occupations (ANZSCO). ANZSCO is a standardised classification

framework for collection, publication and analysis of occupation data.

Further information on ANZSCO is available on the Australian Bureau of Statistics

website (https://www.abs.gov.au).

Citizenship country: The country of citizenship of the visa applicant or visa holder. Where a visa applicant

or visa holder has more than one citizenship country, either the citizenship of the

travel document or the citizenship nominated by the visa applicant is used.

Decisions: A visa processing activity outcome where a decision-maker (including system-

generated decision-making) grants or refuses a visa application.

Finalisations: A visa processing activity outcome where a decision-maker grants or refuses a visa

application, or the application is otherwise finalised by client withdrawal.

In Australia: In this report, this term refers to the location of the client at the time the application

was lodged. An applicant in Australia may already hold a visa of the same kind or

may be applying for another type of visa.

Lodged: Lodged is the count of applications receipted in a departmental office or submitted

electronically.

Onhand: A visa application that has been lodged but has not been finalised at a point in time.

An application that is onhand may also be referred to as 'in the pipeline'.

Outside Australia: In this report, this term refers to the location of the client at the time of lodging the

application.

Outcome: For the purposes of Migration Program reporting, outcome refers to the number of

visas granted that count toward the Migration Program. Outcome includes primary

applicants as well as secondary/dependant applicants.

Where a visa has a permanent residence pathway, eg from a provisional or 'first stage' visa to a permanent or 'second stage' visa, the applicant is counted to the

Migration Program at grant of the provisional visa.

Some visas granted during a program year may not count toward the Migration

Program, for example:

If a person has been previously granted a visa which counted toward the

Migration Program, that person will not be counted again.

When a visa is granted and subsequently cancelled in the same program year,

the grant is excluded for the purposes of Migration Program outcome reporting.

When a Partner visa applicant does not progress to the second stage

(permanent) visa, a place is returned to the program.

If a Business Innovation and Investment visa (granted in an earlier year) is

cancelled, a place is returned to the program in the year of cancellation.

Places: In this report, each grant that counts toward the Migration Program outcome is a

place delivered against the Migration Program places for the year. Where referring to Migration Program *outcomes* within the report, the terms 'grant' and 'place' may be

used interchangeably.

Primary applicant: The primary applicant is the person who must satisfy the primary criteria for the grant

of a visa under the Migration Regulations. Also known as the principal applicant.

Secondary applicant: Secondary applicants must satisfy the secondary criteria for the grant of a visa under

the Migration Regulations. A secondary applicant is generally a dependant of the

primary applicant.

Region (major): The major geographical region in which the country of citizenship of the applicant is

located. Region groupings are determined based on the Australian Bureau of

Statistics Standard Classification of Countries (SACC), 2016.

Region (minor): The minor geographical region in which the country of citizenship of the applicant is

located. Region groupings are determined based on the Australian Bureau of

Statistics Standard Classification of Countries (SACC), 2016.

### **Background to the Migration Program**

Australia's Migration Program is set annually, and runs from 1 July to 30 June of each financial year. The size and composition of the Migration Program is set each year through the Australian Government's Budget process.

There are three streams in the Migration Program:

- The **Skill stream** is designed to improve the productive capacity of the economy and fill skill shortages in the labour market, including those in regional Australia.
- The Family stream enables Australian citizens and permanent residents to reunite with family members from overseas. The Family stream includes the Partner and Child visa categories, which are demand driven.
- The **Special Eligibility stream** covers visas for those in special circumstances that do not fit into the other streams. This can include permanent residents returning to the country after a period away.

### **Calculating the Migration Program Outcome**

The Skill and Family streams include 'two-stage' visas, which provide a permanent residence pathway for visa holders from a provisional or 'first stage' visa to a permanent or 'second stage' visa. While such pathways involve the grant of two visas, to avoid double counting, the visa holder is counted to the Migration Program at grant of the provisional or 'first stage' visa only.

In addition to 'second stage' visas, some other visas granted may not count toward the Migration Program outcome in the following circumstances:

- if a person has been previously granted a visa which counted toward the Migration Program, that person will not be counted again.
- when a visa is granted and subsequently cancelled in the same program year.
- when a Partner visa applicant does not progress to the second stage (permanent) visa, a place is returned to the program.
- if a Business Innovation and Investment visa (granted in an earlier year) is cancelled under certain powers, a place is returned to the program in the year of cancellation.

### **Executive Summary**

The total permanent Migration Program outcome for 2022-23 was 195,004 places.

The breakdown for each of the streams within the Migration Program was as follows:

- 142,344 places were delivered in the Skill stream;
- 52,500 places were delivered in the Family stream; and
- 160 places were delivered in the Special Eligibility stream.

Almost all visa categories were delivered to their exact planning level. The Special Eligibility category slightly exceeded its original published planning level due to the Minister for Immigration, Citizenship, and Multicultural Affairs choosing to make greater use of the Former Resident (subclass 151) visa in Ministerial Intervention decisions than originally anticipated. The additional places needed in this program were drawn from the Regional Skilled category, leading to a commensurate under-delivery against the original planning level in that category.

2022-23 saw an uplift in activity after Australia's international border restrictions were lifted. In September 2022, the permanent Migration Program planning level was lifted from 160,000 to 195,000 places, to ease workforce and skill shortages and support economic recovery from COVID-19. This increase was primarily in the Regional and State and Territory nominated categories of the Skill stream.

To support delivery of an increased Migration Program without compromising ongoing efforts to reduce onhand numbers across other visa caseloads, the Government provided additional funding of \$36.1 million over a nine month period to 30 June 2023, to allow the Department to recruit and train staff to increase its processing capacity. In 2022-23 the Department recruited 593 additional staff to support temporary and permanent visa delivery.

While COVID-19 continued to impact the visa processing network, outcomes across the Migration Program were supported by a range of additional measures, including systems improvements and legislative changes.

Healthy pipelines and strong lodgement rates also supported delivery of the 2022-23 permanent Migration Program across streams, with increased demand for skilled migration in particular. Overall Migration Program lodgements increased by 63.5 per cent from 185,030 in 2021-22, to 302,434 in 2022-23.

#### **Skill Stream**

2022-23 saw the delivery of the largest permanent skilled migration program in Australia's history.

The Skill stream outcome was 142,344 places, which accounted for 73.0 per cent of the total 2022-23 Migration Program outcome (excluding the Special Eligibility Stream).

#### Within the Skill stream:

- The Employer Sponsored category had an outcome of 35,000 places. Employer Sponsored visas comprised 24.6 per cent of the Skill stream outcome in 2022–23;
- The Skilled Independent category had an outcome of 32,100 places (22.6 per cent);
- The Regional category had an outcome of 33,944 (23.8 per cent of Skill outcome). Of this:
  - o 26,707 places were delivered in Skilled Work Regional;
  - o 7,004 places in Skilled Employer Sponsored Regional; and
  - o 233 places in Skilled Regional.
- The State/Territory Nominated category had an outcome of 31,000 places (21.8 per cent);
- The Business Innovation and Investment Program (BIIP) had an outcome of 5,000 places (3.5 per cent);
- The Global Talent Independent had an outcome of 5,000 places (3.5 per cent); and
- The Distinguished Talent category had an outcome of 300 places (0.2 per cent).

#### Skilled visa processing priorities

On 28 October 2022, *Ministerial Direction no. 100 Order of Consideration - Certain Skilled visas* (Ministerial Direction 100) came into effect. In accordance with Ministerial Direction 100, the Department gives highest priorities to healthcare and teaching occupations, and applications where the applicant is offshore.

49,650 places in the Skill stream were delivered to applicants located offshore (at the time of lodging their application), an increase of 67.1 per cent on 2021-22 (29,708). As a proportion of the total Skill stream outcome, 34.9 per cent of outcomes were to offshore applicants, increasing from 33.3 per cent in 2021-22, and 28.8 per cent in 2020-21.

#### **Occupations**

The number of places delivered to Registered Nurses (10,181) was higher than any other occupation unit group across the Skill stream, with the highest number of places delivered in the Skilled Independent (5,360) and State/Territory Nominated (2,855) categories for this group.

In accordance with Ministerial Direction 100, visa applications relating to a healthcare or teaching occupation were given the highest priority, and consequently processed more quickly than published median processing times. In total, 20,633 places were delivered to primary applicants in Ministerial Direction 100-prioritised occupations.

- 3,572 places were delivered to applicants in teaching occupations delivered under Ministerial Direction 100, an increase of 551.8 per cent from 2021-22 (548).
- 17,061 places were delivered to applicants in healthcare occupations an increase of 108.2 per cent from 2021-22 (8,195).

#### State and Territory nominated outcomes

State and Territory Governments were able to nominate skilled migration applicants through three categories in 2022-23 – the State/Territory Nominated Category; the Business Innovation and Investment Category; and the Regional Category, through the Skilled Work Regional visa. Across these categories, Migration Program outcomes that involved a State or Territory Government nomination totalled 57,141 places, or 40.1 per cent of the Skill stream of the Migration Program, broken down as follows:

- State/Territory Nominated 31,000 places
- Business, Innovation and Investment Program 5,000 places
- Skilled Work Regional 21,141 places<sup>1</sup>

### Lodgements

The number of applications<sup>2</sup> received in the Skill stream increased by 84 per cent, from 118,273 applications in 2021-22 to 217,567 applications in 2022-23. The highest increases were in the Skilled Independent and State/Territory nominated categories.

Lodgement activity was supported by increased outreach and promotional activity to attract skilled workers to fill critical skills shortages in priority sectors. The Government committed \$6.2 million in the October 2022 Budget to fund an international marketing campaign and enhanced outreach and engagement activity. The campaign reached almost 205 million people and there were close to 16 million unique visits to the campaign website (www.smartmoveaustralia.gov.au).

Lodgements in Ministerial Direction 100 prioritised occupations increased from 2021-22, with the largest increase in the Skilled Independent category.

- Lodgements in teaching occupations increased 151.5 per cent when compared with 2021-22.
  - Teaching occupation lodgements increased most in the Skilled Independent category, increasing 3,519 per cent when compared with 2021-22.
- Lodgements in healthcare occupations increased 144.3 per cent when compared with 2021-22.
  - Healthcare occupation lodgements increased most in the Skilled Independent category, increasing 3,085.4 per cent when compared with 2021-22.

As at 30 June 2023, there were 184,879 Skill stream<sup>2</sup> applicants in the pipeline, an increase of 54.6 per cent compared to the pipeline of 119,857 applicants as at 30 June 2022.

#### **Family Stream**

The Family stream delivered 52,500 places, which accounted for 26.9 per cent of the total 2022-23 Migration Program outcome (excluding the Special Eligibility Stream).

Within the Family stream:

- The Partner category had an outcome of 40,500 places. It comprised 77.9 per cent of the 2022-23 Family stream outcome;
- The Contributory Parent and Non-Contributory Parent categories outcome was 6,800 places and 1,700 places, respectively, a total of 8,500 places (16.2 per cent);
- The Child category outcome was 3,000 places (5.7 per cent); and
- The Other Family outcome was 500 places.

All Family stream programs were fully delivered against their planning level. In 2022-23, the Partner and Child categories were demand driven programs, with nominal planning levels. The Department manages the allocation of resources to deliver the Family program in line with the planning levels and priorities, including allocating resources to address complex and older on-hand cases, and second stage applications (which do not count toward Migration Program outcomes).

#### Family visa processing priorities

On 9 February 2023, Ministerial Direction 80 was revoked and replaced with the new *Ministerial Direction No. 102 - Order for considering and disposing of Family visa applications under sections 47 and 51 of the Migration Act 1958* (Ministerial Direction 102). Ministerial Direction 102 sets out the Family Program processing priorities, and removes the lowest processing priority imposed under Ministerial Direction 80 for applications where the sponsor is a permanent visa holder who entered Australia as an unlawful maritime arrival.

#### Lodgements

Family visa application lodgements<sup>3</sup>, including the Child category<sup>4</sup>, increased by 27.3 per cent, from 66,527 in 2021-22 to 84,704 in 2022-23.

As at 30 June 2023, there were 213,993 Family visa applications<sup>3</sup> (including the Child category) onhand, an increase of 10.6 per cent compared to the 193,469 applications onhand as at 30 June 2022.

#### **Special Eligibility Stream**

The Special Eligibility stream outcome was 160 places, which accounted for 0.08 per cent of the total 2022-23 Migration Program outcome.

Special Eligibility includes Ministerial Intervention cases and Former Resident applicants. The planning level in this stream was exceeded due to the Minister for Immigration, Citizenship and Multicultural Affairs choosing to make greater use of the Former Resident (subclass 151) visa in Ministerial Intervention decisions than originally anticipated. The Minister is not required to strictly adhere to a planning level in this stream when exercising his personal power to intervene to grant Special Eligibility visas.


























