## Explanatory notes:

- Note 1** All numbers have been rounded to the nearest 10 and salaries to the nearest \$100. Therefore the sum of individual items in a table may not exactly match the total. Where a number in a table is between 1 and 4, the number has been masked with < 5 for privacy reasons.
- Note 2** This report is based on visa grant data recorded for visa subclass 457 in the current financial year and provides a comparison with the SAME PERIOD IN THE PREVIOUS YEAR. It excludes a small number of visa grants made to Independent Executives, who also used to enter on subclass 457 visa but are now included in the Business Skills categories.
- Note 3** The principal data collected on 457 visa holders comes from the visa application and grant process. The applicant and their sponsor provide a range of information to enable DIBP to assess the eligibility of the sponsor and the applicant for the visa. This is the most accurate and verifiable data that DIBP collects on 457 visa holders. It includes such information as the location of the nominated position, the nominated occupation, the nominated base salary and the citizenship country.
- Note 4** Unless otherwise stated, the tables in this report relate to primary applicants only.
- Note 5** Unless otherwise stated, the occupation shown in tables in this report is the nominated occupation. That is, the position that is being filled rather than the previous or usual occupation of the visa applicant.
- Note 6** Sponsors self-identify with an industry classification when lodging a nomination or sponsorship. The industry classification shown is based on what the sponsor has recorded. If a sponsor has notified more than one industry over time, the most recently recorded industry classification has been used in this report.
- Note 7** Up until 1 April 2005, medical practitioners applied for a visa in Visa Subclass 422 Medical Practitioner. From that date, medical practitioners have been encouraged to apply for a Subclass 457 visa.
- Note 8** In tables showing the top 15 citizenship countries, the figure for 'Unknown' is included in the total only.
- Note 9** In some tables, 'Not recorded' or 'Not specified' appears. This mainly relates to visa applications processed in the IRIS system. IRIS does not have the capacity to record comprehensive information about sponsors and nominations. Since 1 November 2003, the ICSE system has largely replaced IRIS for processing subclass 457 visas, but a small number of visas are still processed in IRIS.
- Note 10** From 14 September 2009, subclass 457 visa holders changing sponsor or nominated occupation do not need to lodge a new visa application if they held a valid subclass 457 visa. DIBP estimates that the number of visa applications lodged since 14 September 2009 has been reduced by 8 to 9 per cent below the level that would have occurred without the change.

## Definition of Terms:

ANZSCO Major Group:	Major Group is the highest level in the Australian and New Zealand Standard Classification of Occupations (ANZSCO) 1st Edition produced by the Australian Bureau of Statistics (ABS).
ANZSIC:	Australian and New Zealand Standard Industry Classification 2006 Edition produced by the Australian Bureau of Statistics (ABS). Prior to November 2008, ANZSIC 1993 was used to record industry. Data recorded using ANZSIC 1993 has been converted to ANZSIC 2006 using concordance tables provided by the ABS.
Applicant Type:	<p>Under the Migration Regulations 1994 (the Regulations), there are two types of applicants. These are primary applicants and secondary applicants. These terms are defined below.</p> <p>If the table or graph heading includes the word 'primary', such as 'primary applications' or 'primary visa holders', dependants (secondary applicants) are not included.</p>
Independent Executive:	Formerly, a group within subclass 457 who did not require a sponsor. They are now included in the Business Skills categories. A small number of visa applications for Independent Executives were finalised in the current year.
Last Visa Held:	This refers to the last substantive visa held by a visa holder (that is, the last visa other than a bridging visa) prior to a point in time. The last visa held may have expired or still be in effect.
Nominated Base Salary:	Represents the gross annual salary based on a 38 hour week that the employer has indicated they will pay to the primary visa holder. These amounts do not include the value of salary packaged items, bonuses, commissions or other payments listed in the schedule to the legislative instrument specifying Minimum Salary Levels for the Subclass 457 program.
Nominated Occupation:	The occupation of the nominated position that the primary visa holder will be filling in Australia while holding the Subclass 457 visa based on the Australian Standard Classification of Occupations (ANZSCO) 1st Edition.
Nominated Position Location:	The State or Territory where the visa holder will be working. This may be different from the business address of the sponsor and/or the visa processing office.
Nominated Total Remuneration:	The total value of the salary package including base salary, allowances, bonuses and superannuation.
Pathway:	A visa holder moving from one type of visa to another type of visa. Most commonly used in relation to visa applicants moving from a temporary visa to a permanent/provisional visa. The original visa is determined by the last visa held prior to permanent/provisional visa grant and the visa applicant may be onshore or offshore.
Permanent/provisional visa:	A visa subclass which is countable for the purposes of the migration program.
Primary Applicant:	The primary applicant is the person who must satisfy the primary criteria for the grant of a visa under the Migration Regulations.
Primary Application:	An application lodged by a primary applicant.
Secondary Applicant:	Secondary applicants must satisfy the secondary criteria for the grant of a visa under the Regulations. In this case, a secondary applicant is generally a dependant of the primary applicant.
Secondary Application:	A visa application lodged by a secondary applicant.
Sponsor Industry:	The industry self-identified by the sponsoring client using the Australian and New Zealand Standard Industry Classification (ANZSIC) 2006 edition.



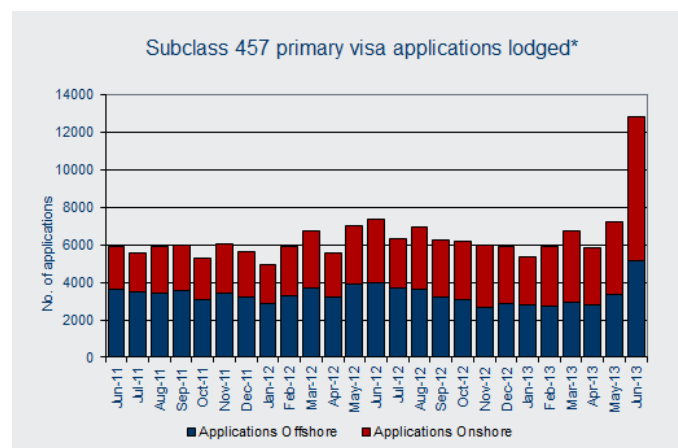
# Trends in the subclass 457 Temporary Work (Skilled) visa program in the 2012-13 program year<sup>1</sup> to 30 June 2013

## Key points

- The number of subclass 457 primary visa applications lodged in the 2012-13 program year was 13.5 per cent higher than the previous program year.
- The number of onshore primary visa lodgements in the 2012-13 program year increased 38.2 per cent compared with the previous program year.
- The number of subclass 457 primary visas granted in the 2012-13 program year was steady compared with the previous program year.
- The number of primary visa holders in Australia on 30 June 2013 was 18.6 per cent higher than in June 2012, and increased by 1.2 per cent from May 2013.

## Visa application trends

The number of subclass 457 primary visa applications lodged in 2012-13 was 81 550, an increase of 13.5 per cent compared with the previous program year which was 71 870. Compared with the previous month the number of primary applications lodged rose 77.2 per cent, from 7230 in May 2013 to 12 810 in June 2013. Many applicants took advantage of the lower application charges which applied prior to 1 July 2013.



In the 2012-13 program year the number of primary applications lodged offshore was 38 940, a decrease of 5.1 per cent compared to the previous program year, which was 41 050. The number of primary applications lodged offshore for June 2013 was 5160, 52.8 per cent higher compared to May 2013, which was 3380.

The number of primary applications lodged onshore in the 2012-13 program year was 42 610, which was 38.2 per cent higher compared to the previous program year. Primary applications lodged onshore for June 2013 was 7640, 98.6 per cent higher compared to May 2013, which was 3850.

The number of Australian and New Zealand Standard Classification of Occupations (ANZSCO)<sup>2</sup> Major Group 3 (Technicians and Trades Workers) primary applications lodged in the 2012-13 program year was 22 410, 20.8 per cent higher compared with the previous program year, which was 18 550.

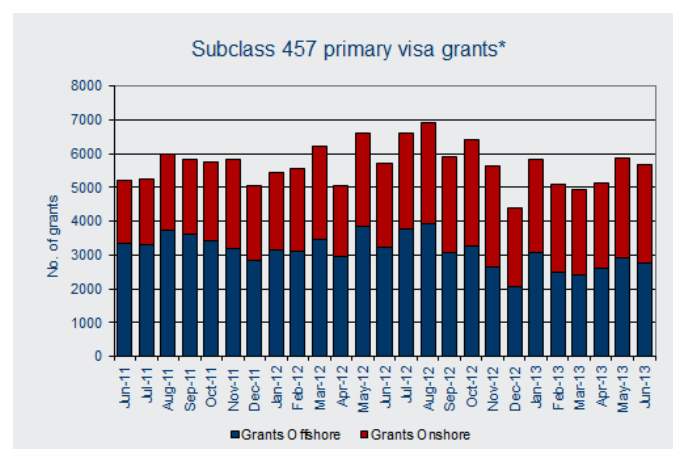
<sup>1</sup> Program year corresponds to financial year.

<sup>2</sup> The Department of Immigration and Citizenship replaced the Australian Standard Classification of Occupations (ASCO) with the Australian and New Zealand Standard Classification of Occupations (ANZSCO) from 1 July 2010. This will affect comparisons between the earlier period and the subsequent program years.

During the 2012-13 program year the number of ANZSCO Major Group 1 (Managers) primary applications lodged was 16 240, an increase of 56.6 per cent compared to the previous program year, which was 10 370. The number of ANZSCO Major Group 2 (Professionals) primary applications lodged was 35 350, a decrease of 6.1 per cent compared with the previous program year, which was 37 640.

## Visa grant trends<sup>3</sup>

The number of subclass 457 primary visas granted in 2012-13 was 68 480, which was steady compared with 68 310 primary visas granted in the previous program year. While there has been a general downward trend in visa grants since the peak in August 2012, the number of primary visas granted in June 2013 was 5670, 3.2 per cent lower than May 2013, which was 5860.



In the 2012-13 program year, offshore primary visa grants were 35 040, 12.2 per cent lower compared with the previous program year, which was 39 910. The number of offshore primary visas granted in June 2013 was 2770, a decrease of 4.5 per cent compared with May 2013, which was 2900.

In the 2012-13 program year, onshore primary visa grants were 33 440, an increase of 17.8 per cent compared with the previous program year, which was 28 400. The number of onshore primary visas granted in June 2013 was 2910, a decrease of 2.0 per cent compared with May 2013, which was 2970.

<sup>3</sup> The rate at which visa applications are processed is subject to a number of variables including: the number of working days in a month, the number of public holidays and the occurrence of school holidays.

In the 2012-13 program year, Managers and Professionals accounted for 66.0 per cent of total visa grants (recording 11 740 and 33 440 visa grants, respectively). Technician and Trades Workers was the next highest with 18 230 visa grants, which was 26.6 per cent of total grants.

In the 2012-13 program year the largest nominated position location for primary 457 visa grants was New South Wales (35.3 per cent). The next largest locations were Western Australia (21.4 per cent) and Victoria (21.0 per cent). These states were also the top three nominated position locations for primary subclass 457 visa grants in the previous program year.

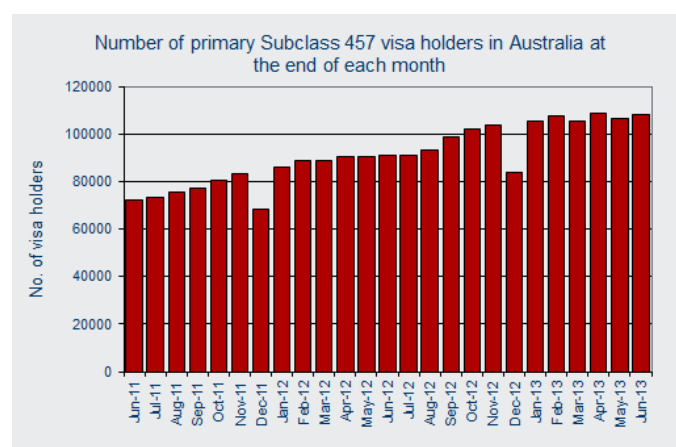
The top three industries for primary visa grants in the 2012-13 program year were Other Services (12.3 per cent), Construction (11.5 per cent) and Health Care and Social Assistance (10.9 per cent).

Primary subclass 457 visa grants to Cooks represented 4.4 per cent of total primary grants in the 2012-13 program year, compared to 2.3 per cent for the previous program year. Cooks were the largest occupation for primary visa grants in the 2012-13 program year. Program or Project Administrators recorded the second largest primary visa grants at 3.2 per cent of total primary visa grants. They were followed by Café or Restaurant Managers at 2.8 per cent of total primary visa grants.

The top three citizenship countries for primary visa grants in the 2012-13 program year were India (20.8 per cent), the United Kingdom (19.4 per cent) and the Republic of Ireland (9.6 per cent).

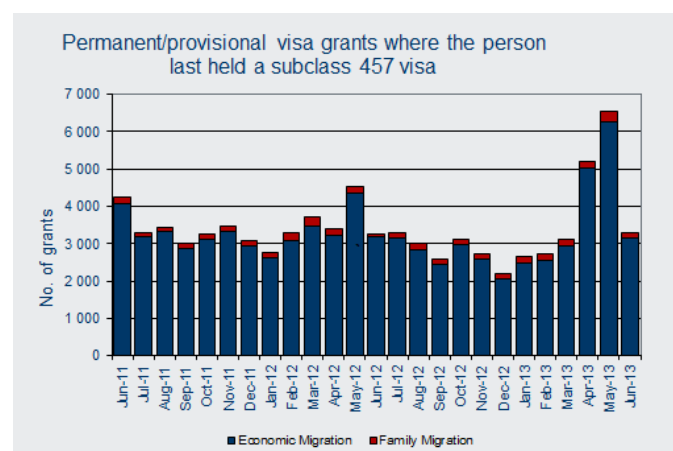
## Number of primary subclass 457 visa holders in Australia

The number of primary visa holders in Australia on 30 June 2013 was 107 970. This was an increase of 18.6 per cent compared with the previous program year, which was 91 050.



## Flow of subclass 457 visa holders to permanent residence

In the 2012-13 program year, the number of subclass 457 visa holders who were granted a permanent residence/provisional visa was steady at 40 450 compared with the previous program year, which was 40 490.



The number of subclass 457 visa holders who were granted a permanent residence/provisional visa in June 2013 was 3300, 49.6 per cent lower compared with May 2013 (which was 6540). The high number of subclass 457 visa holders who were granted a permanent residence/provisional visa in April 2013 (5190) and May 2013 (6540) reflected an increase in the processing of permanent ENS and RSMS visas, many of whom last held subclass 457 visas.

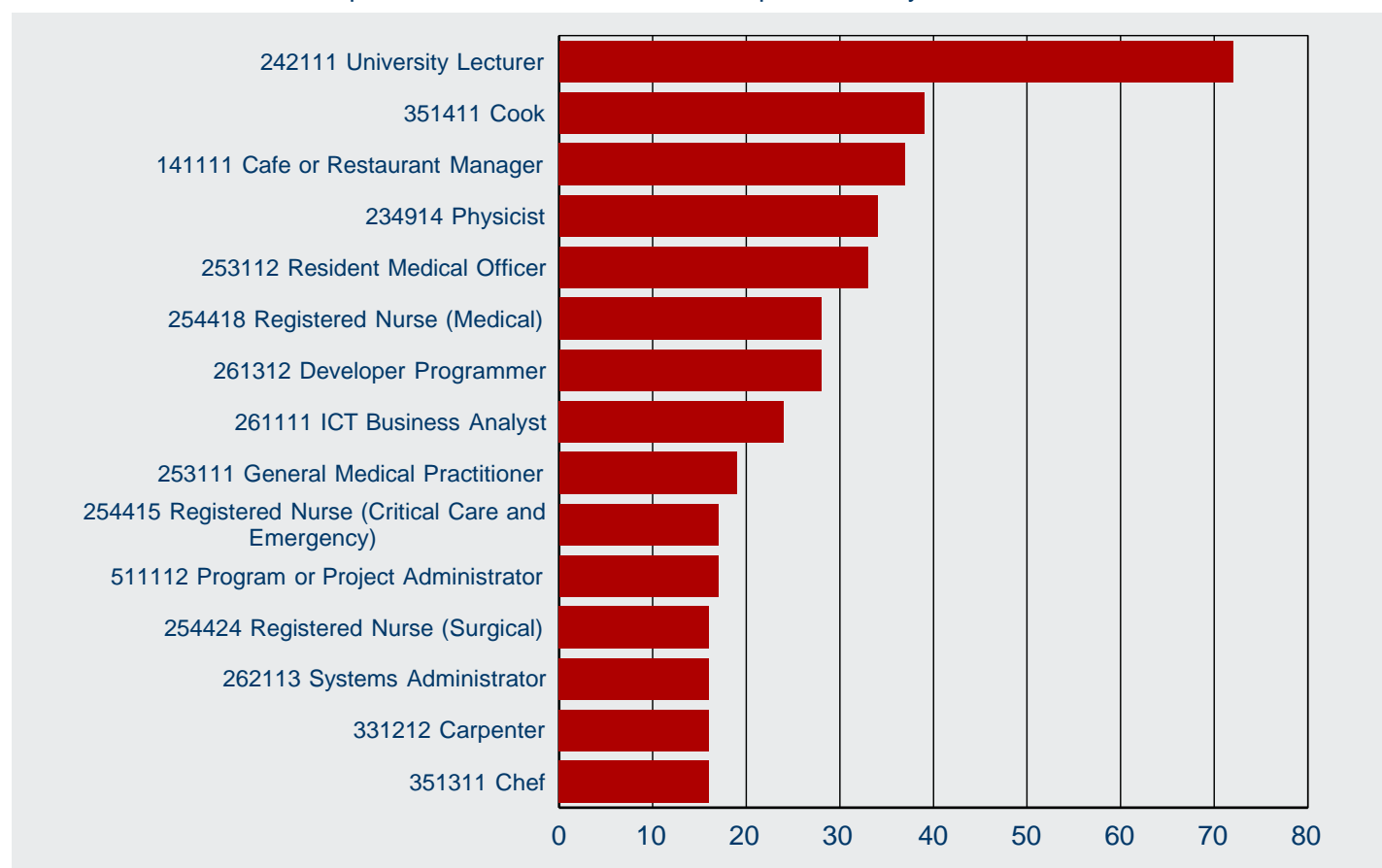

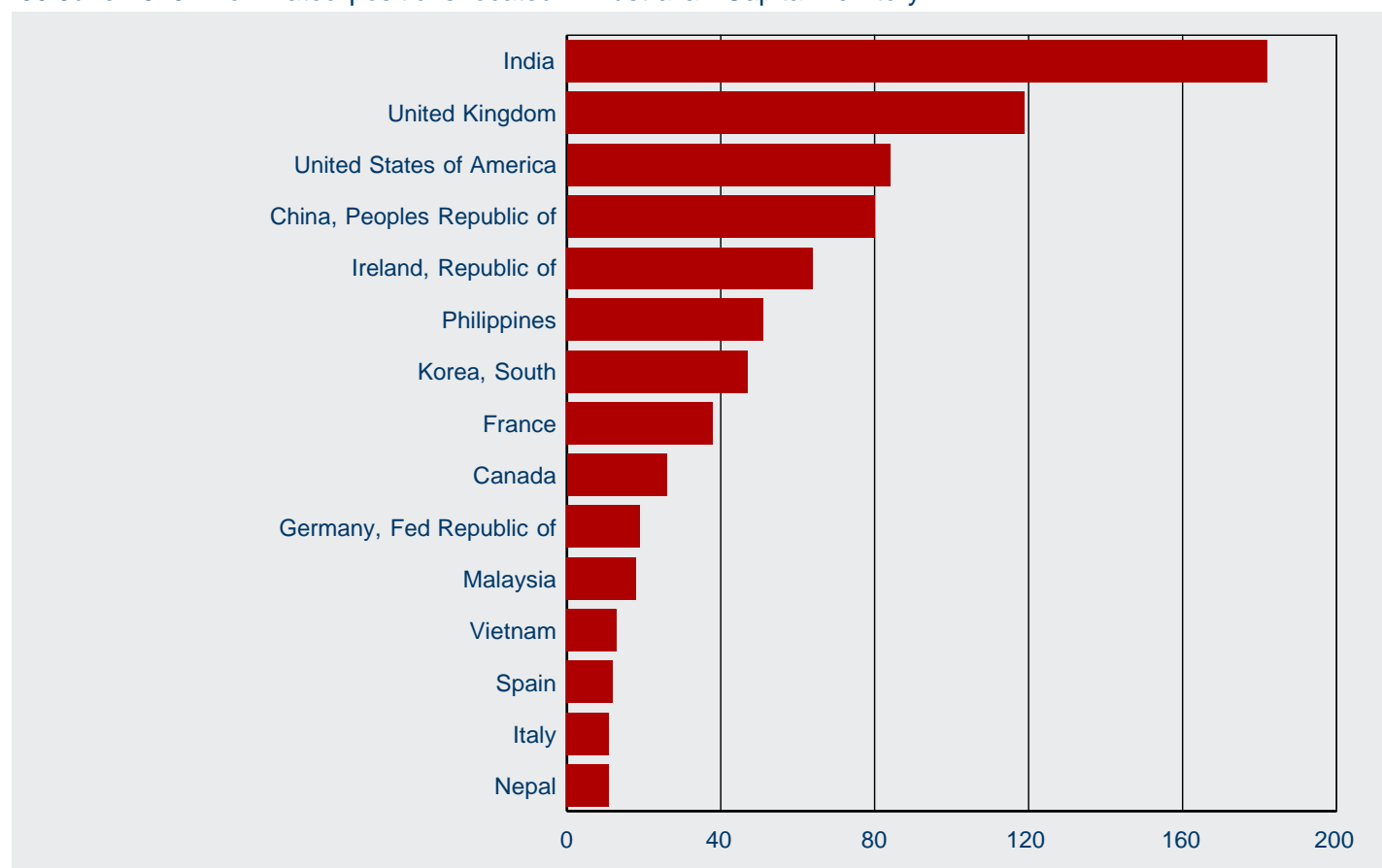

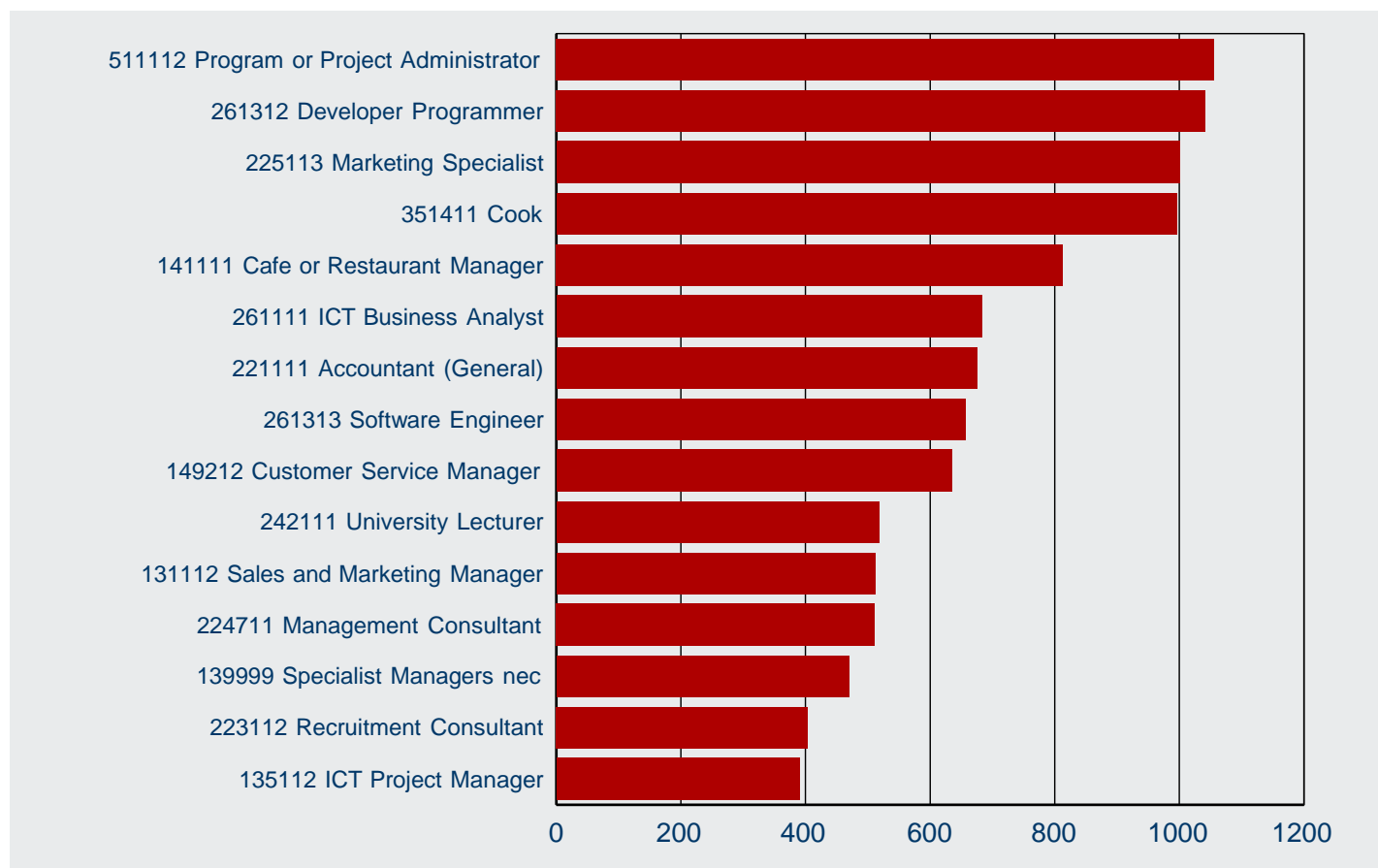

Graph 3.04 Top 15 Nominated occupations for primary applications granted in 2012-13 to 30 June 2013 - nominated positions located in New South Wales

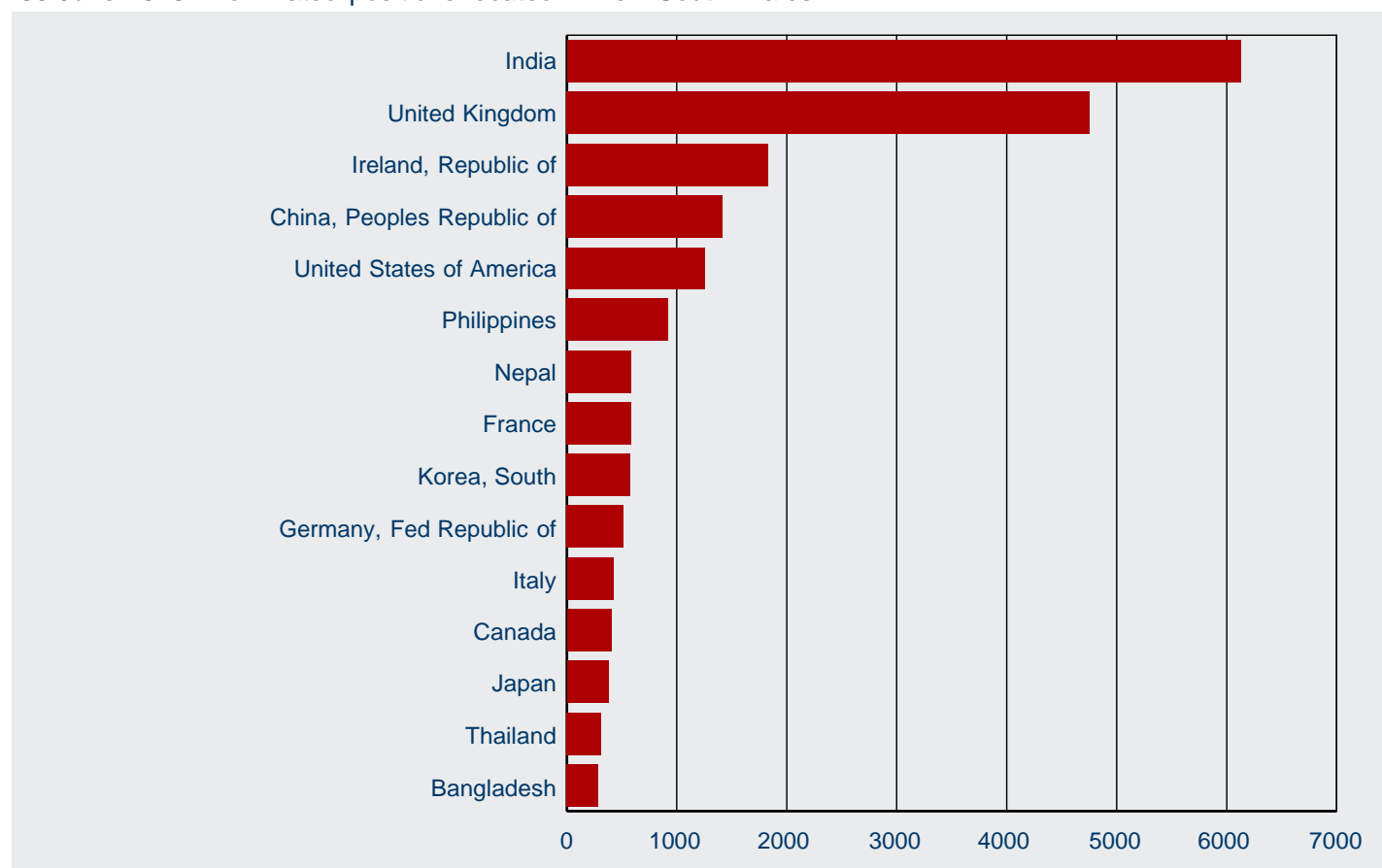

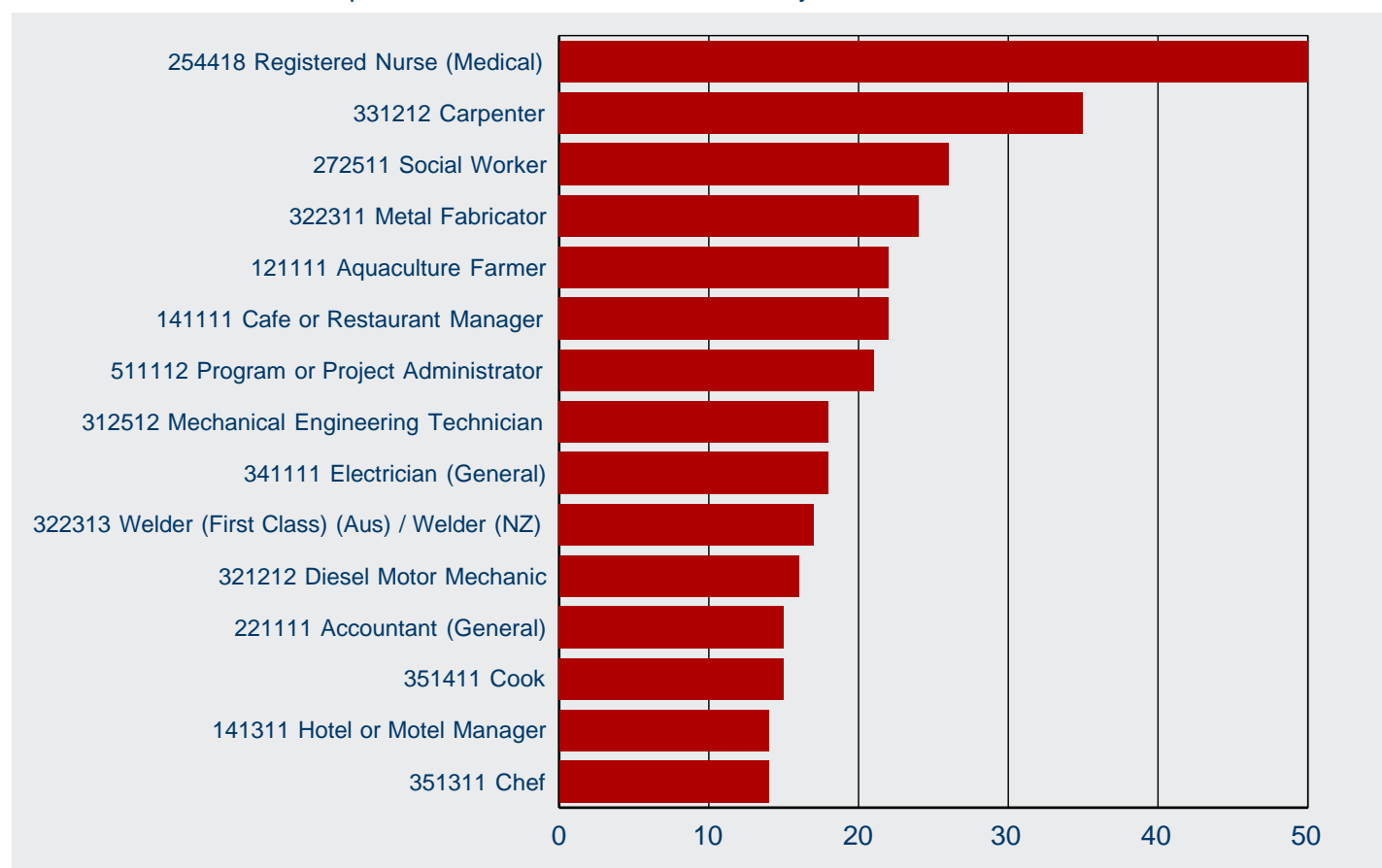

Graph 4.04 Top 15 Nominated occupations for primary applications granted in 2012-13 to 30 June 2013 - nominated positions located in Northern Territory

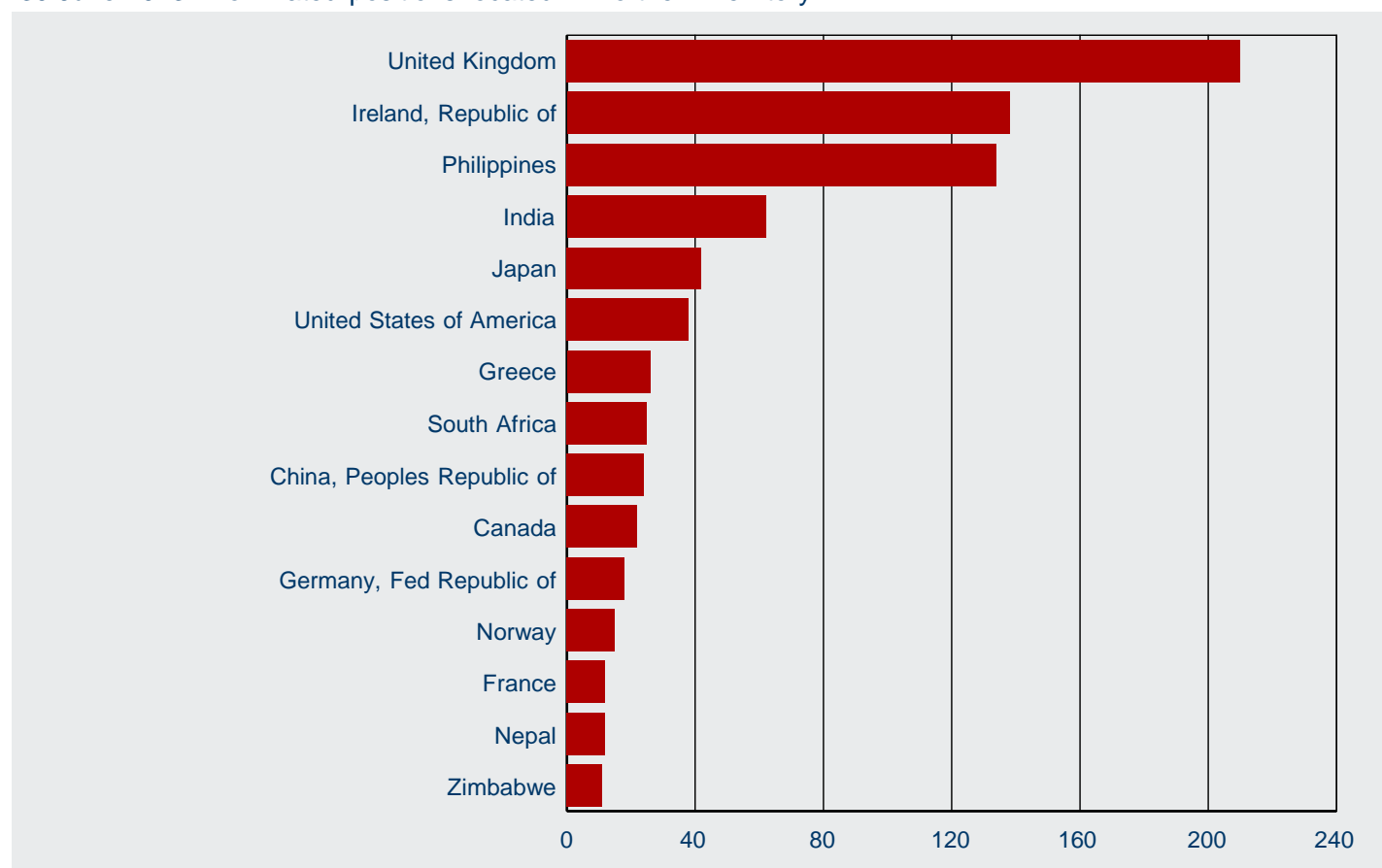

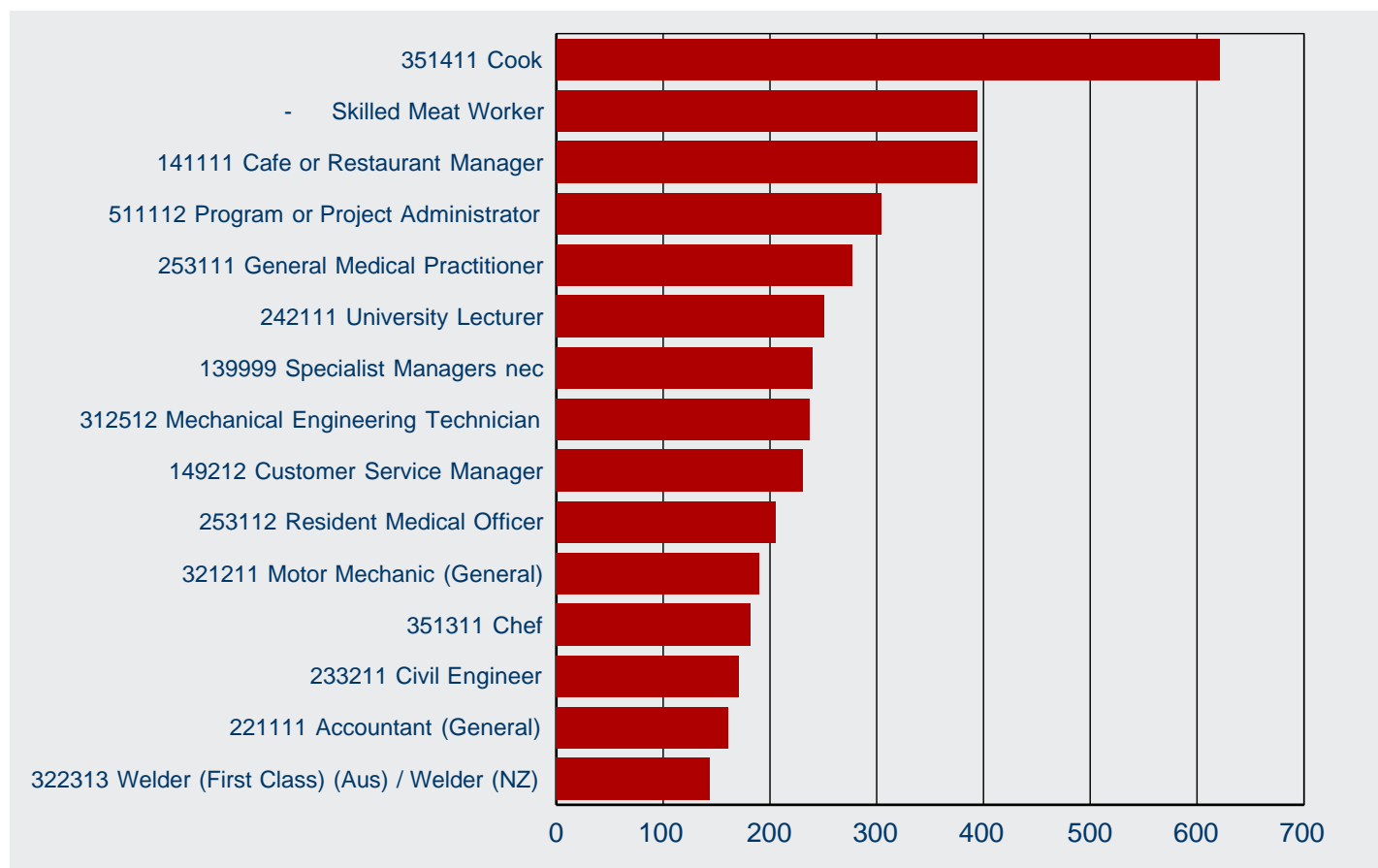

Graph 5.04 Top 15 Nominated occupations for primary applications granted in 2012-13 to 30 June 2013 - nominated positions located in Queensland

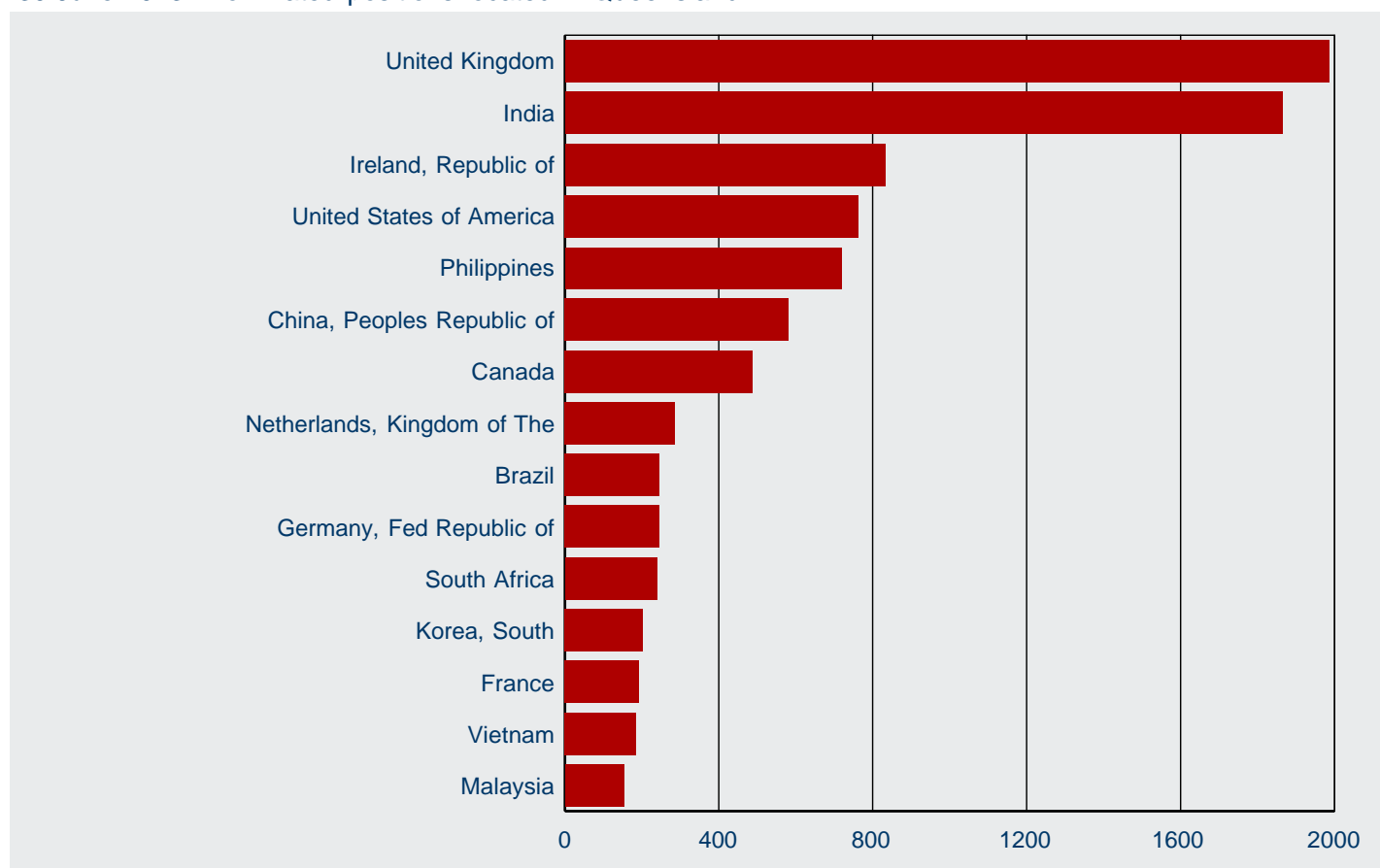

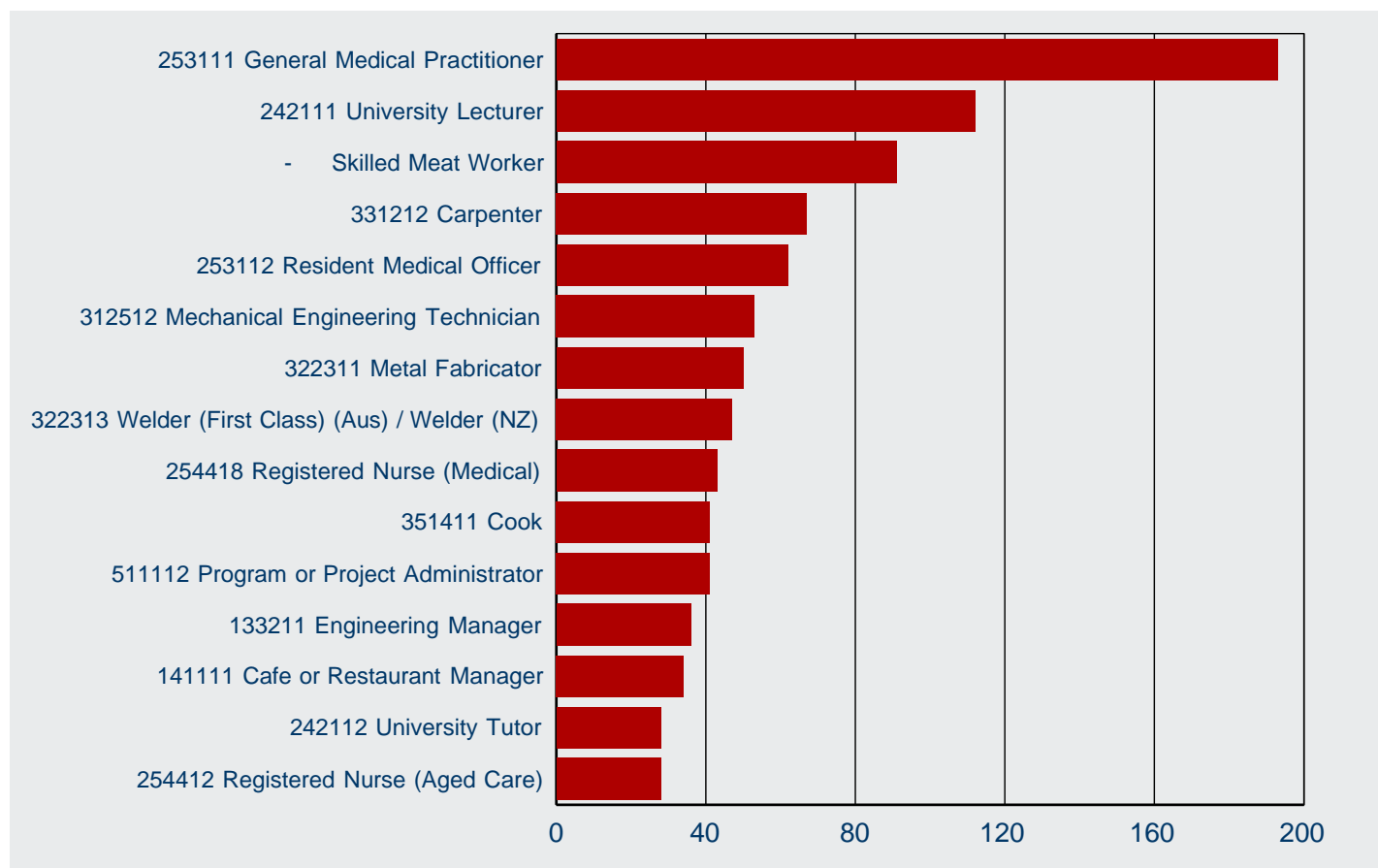

Graph 6.04 Top 15 Nominated occupations for primary applications granted in 2012-13 to 30 June 2013 - nominated positions located in South Australia

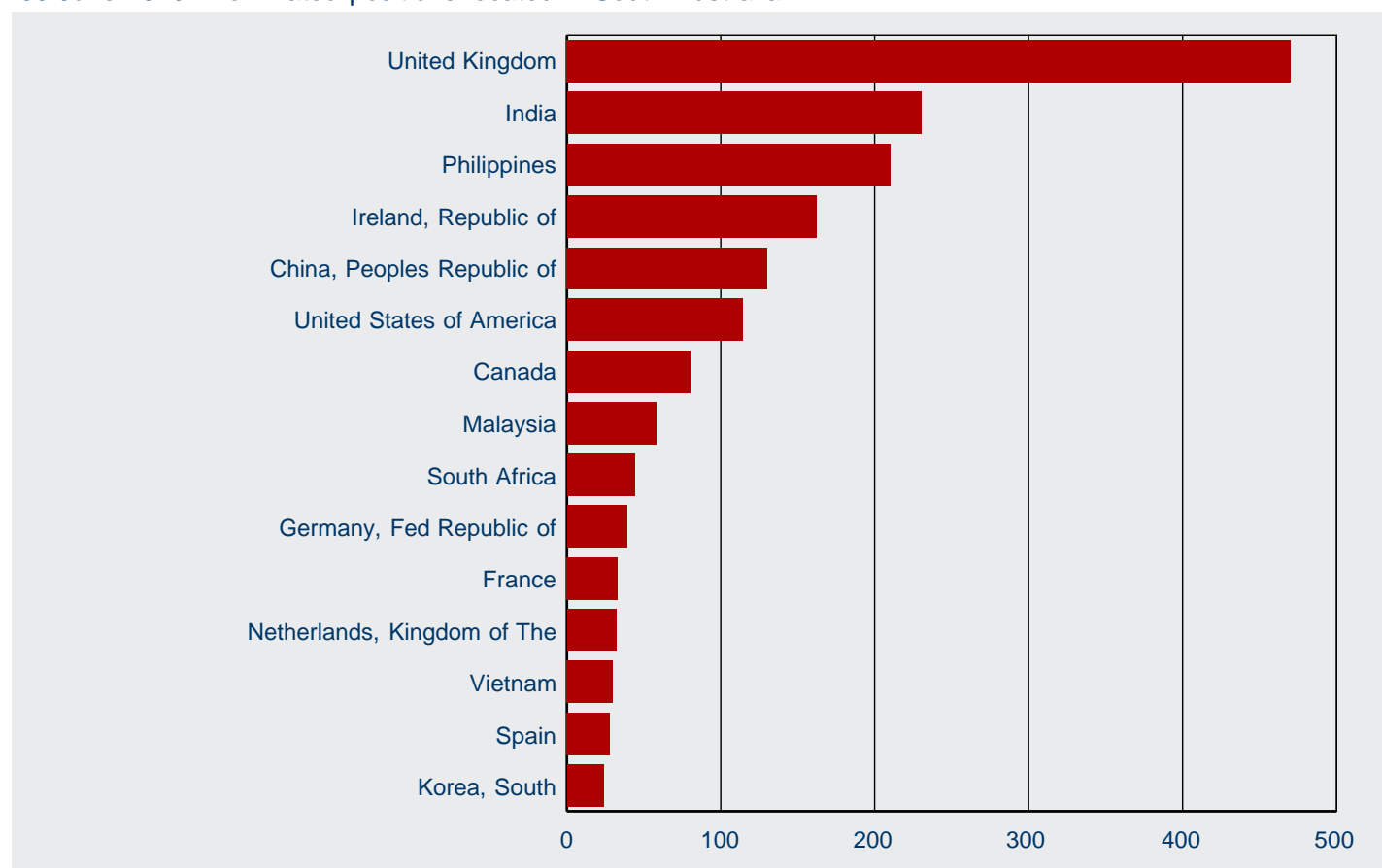

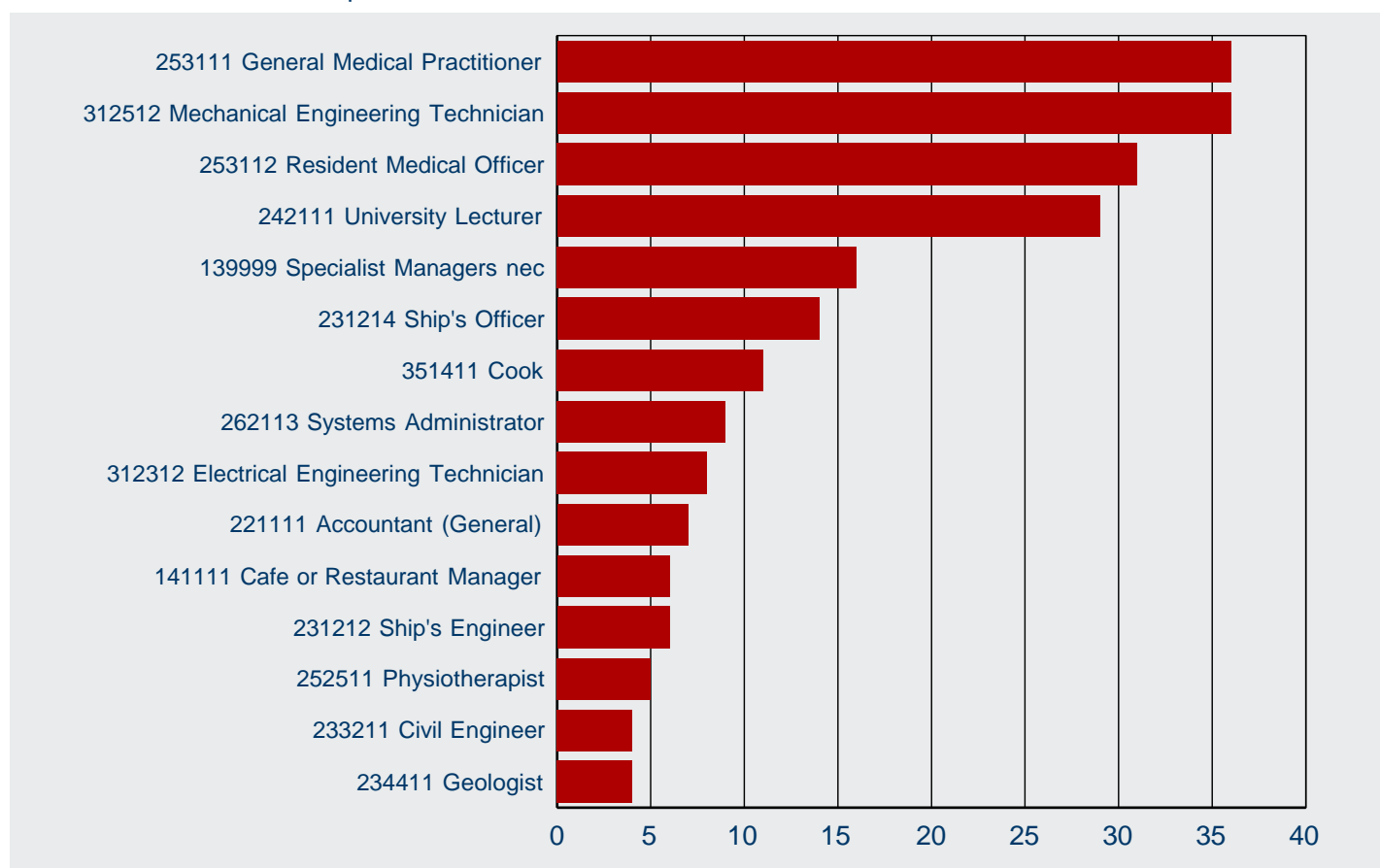

Graph 7.04 Top 15 Nominated occupations for primary applications granted in 2012-13 to 30 June 2013 - nominated positions located in Tasmania

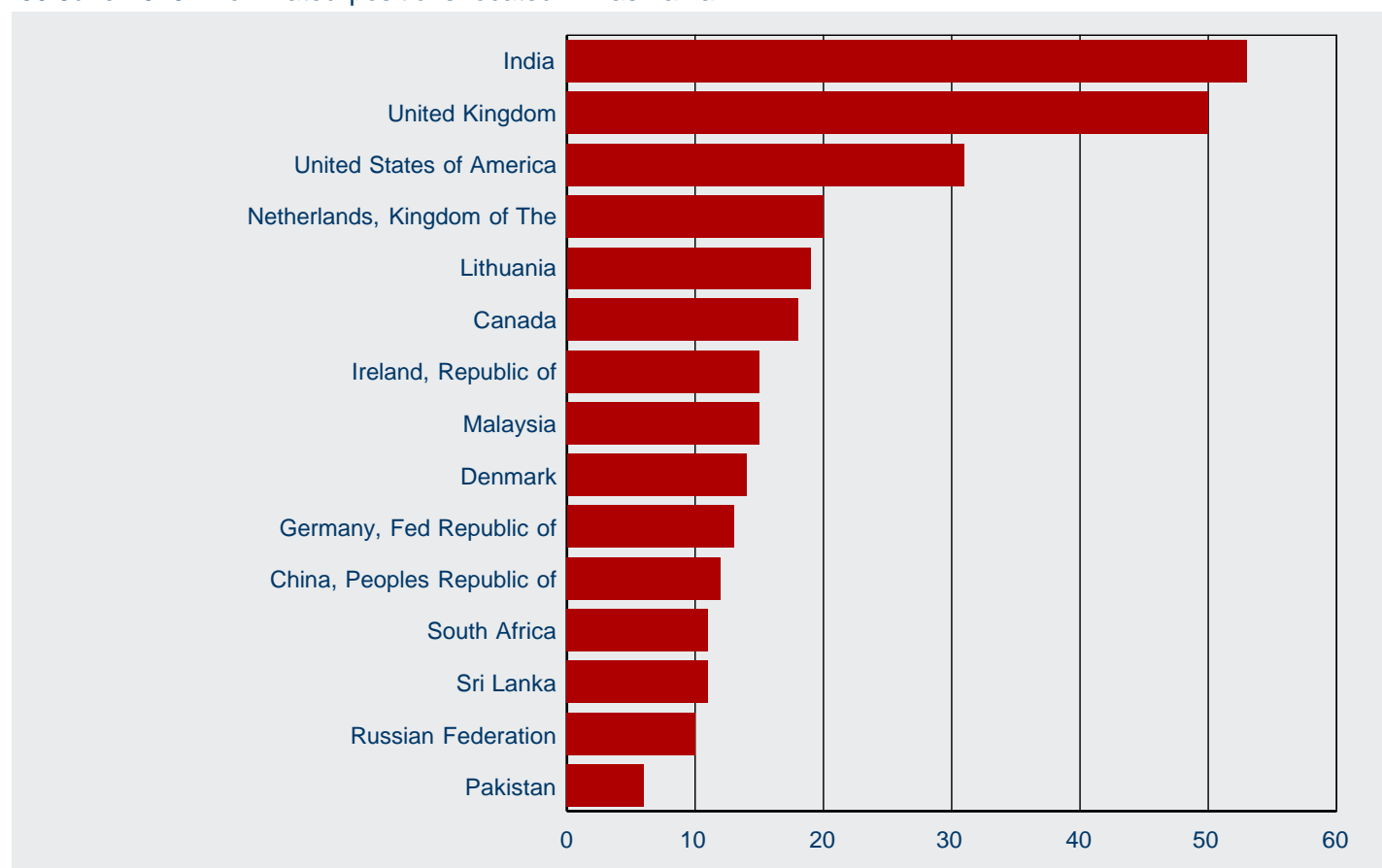

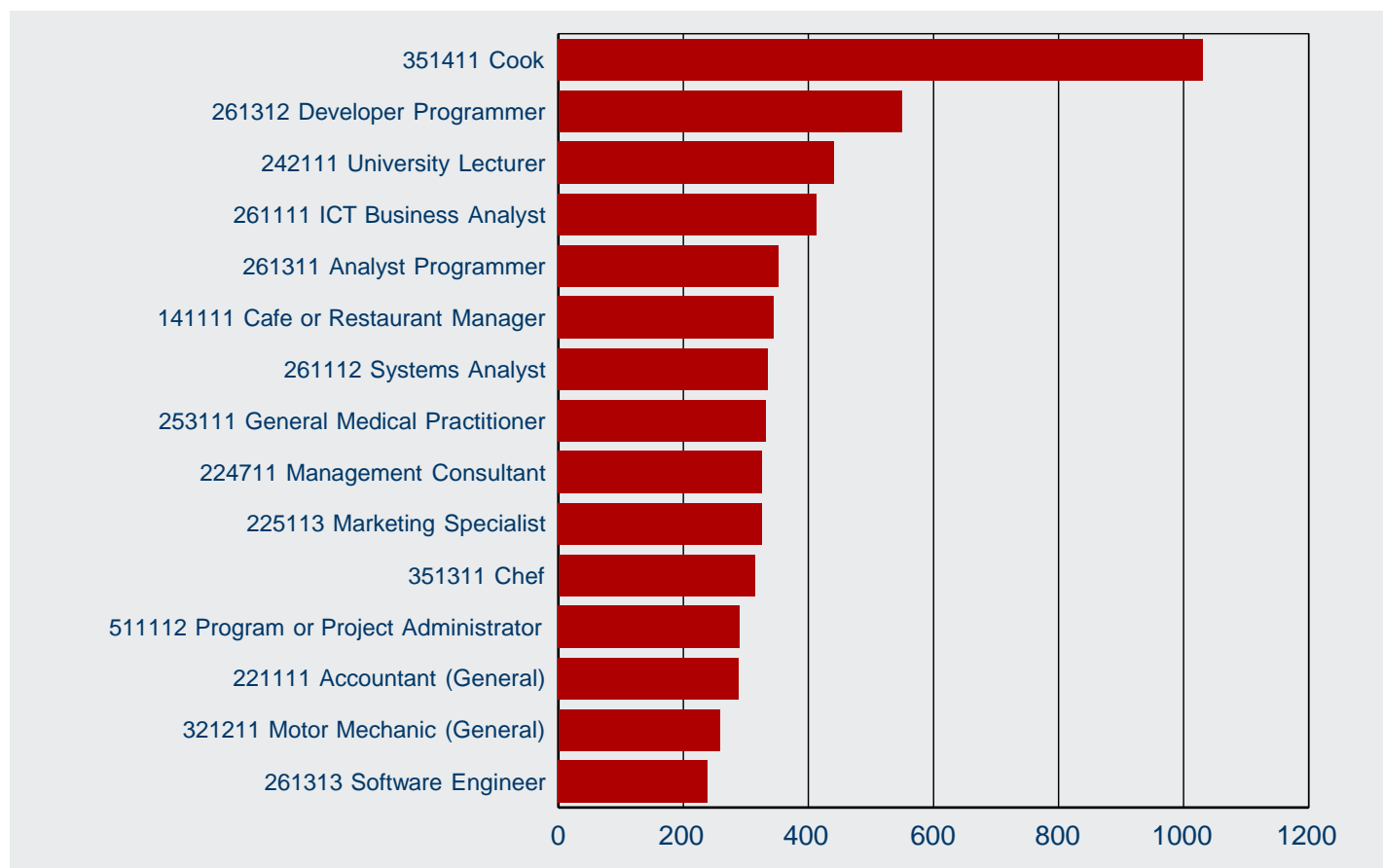

Graph 8.04 Top 15 Nominated occupations for primary applications granted in 2012-13 to 30 June 2013 - nominated positions located in Victoria

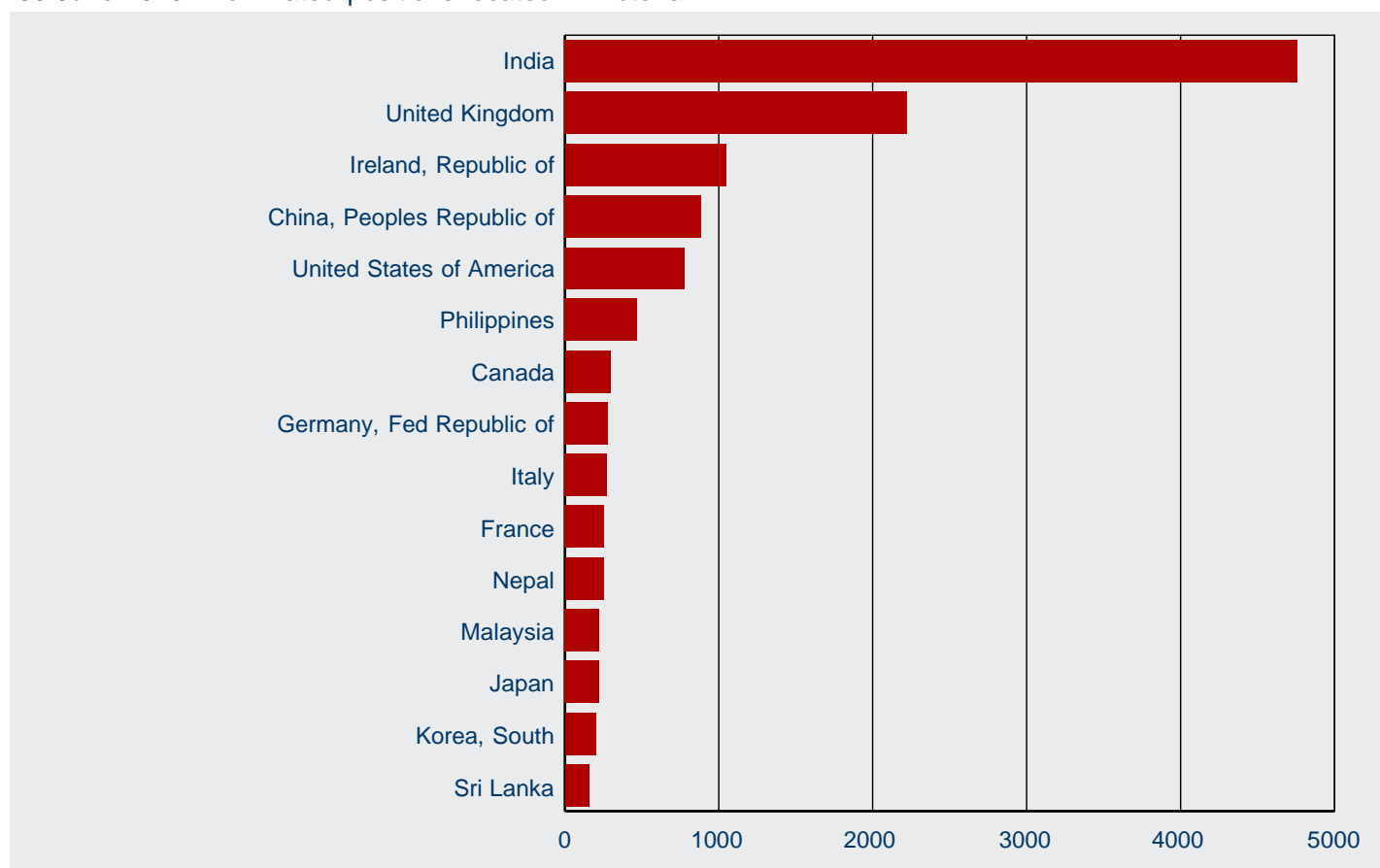

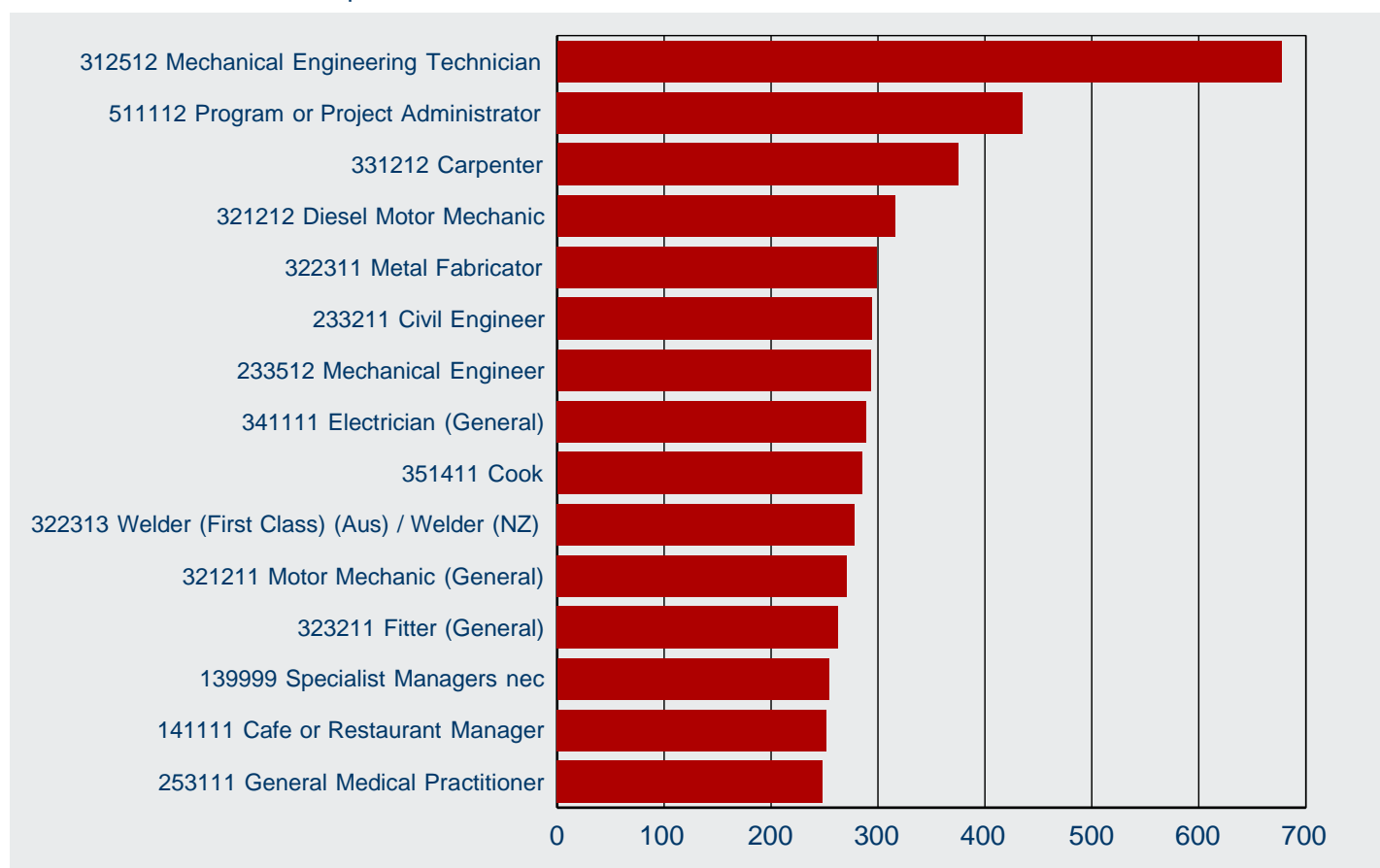
