Background

The number of temporary entrants and New Zealand citizens physically present in Australia is estimated every three months by identifying those persons who have entered Australia on temporary visas or as New Zealand citizens, and who have neither left Australia nor been granted permanent residence. This data provides useful point-in-time information on temporary entrants. It gives a more accurate picture of the population impact of Australia's temporary entry programs than data on the flow of temporary entrants in and out of Australia.

The number of temporary entrants in this report are broken down by the following categories:

Visitor visa holders

non-permanent entrants to Australia whose visa is for tourism, short stay business, visiting relatives or medical treatment:

Student visa holders

overseas students who undertake full-time study in registered courses. In this report, Student Guardian (subclass 580) visa holders are included in 'other temporary visa holders' and not in the 'student visa holders' category;

Working holiday maker visa holders

young adults from countries with reciprocal bilateral agreements with Australia who holiday in Australia and undertake short-term work and/or study and who hold a Working Holiday (subclass 417) or Work and Holiday (subclass 462) visa;

Temporary skilled visa holders

Temporary Work (Skilled) subclass 457 visa holders mostly recruited by Australian companies whose visa is valid for up to four years;

Temporary graduate visa holders

overseas students who wish to remain in Australia for up to 18 months to gain skilled work experience or improve their English language skills and who hold a Temporary Graduate (subclass 485) visa;

Bridging visa holders

non-citizens who are provided with lawful status while they have business with the government or the courts regarding immigration matters;

Other temporary visa holders

include holders of other temporary visas such as New Zealand Citizen Family Relationships (non-New Zealand citizens who are family members of a New Zealand citizen), social/cultural (Entertainment, Sport, Visiting Academic, Religious Worker, etc), international relations (Diplomatic, Exchange, Domestic Worker, etc), training (Occupational Trainee and Professional Development), Student Guardian and transit visas;

New Zealand visa holders

New Zealand citizens granted a Special Category Visa (subclass 444) on arrival in Australia. It should be noted that a small number of New Zealand citizens who were holding a temporary visa other than subclass 444 are included in the temporary visa category relating to the visa held.

Rounding in reported data

Figures given in this report are rounded to the nearest ten. Percentage changes are calculated from unrounded numbers. This may result in minor discrepancies from results calculated from rounded numbers.

Reporting of primary and secondary visa holders

Figures given in this report include both primary and secondary visa holders.

Executive summary

Total temporary entrants and New Zealand citizens snapshot

There were 1,864,730 temporary entrants and New Zealand citizens in Australia on 31 December 2014, compared with 1,821,930 on 31 December 2013 (an increase of 2.3 per cent).

Temporary visa holders

The number of temporary visa holders, that is excluding New Zealand citizens on Special Category (subclass 444) visas and bridging visa holders, was 1,151,300 on 31 December 2014 compared to 1,103,650 on 31 December 2013, an increase of 4.3 per cent.

Quarterly comparison

Compared with 30 September 2014, the end of the previous quarter, the number of temporary visa holders as at 31 December 2014 is an increase of 13.2 per cent from 1,017,440 to 1,151,300. The percentage change in major components is consistent with normal seasonal patterns.

The percentage change in the major components from 30 September 2014 to 31 December 2014 was:

- Visitor visa holders an increase of 107.3 per cent;
- Student visa holders a decrease of 21.8 per cent;
- Working holiday maker visa holders an increase of 6.4 per cent;
- Temporary skilled visa holders a decrease of 14.7 per cent;
- Temporary graduate visa holders a decrease of 11.2 per cent;
- Other temporary visa holders a decrease of 6.6 per cent.

Visitor visa holders

The number of visitor visa holders in Australia on 31 December 2014 was 468,480, an increase of 5.5 per cent compared with 444,140 on 31 December 2013.

The five countries with the largest number of visitor visa holders in Australia on 31 December 2014 were:

•	United Kingdom	82,370 visa holders, a decrease of 14.0 per cent from 31 December 2013
•	China (excl SARs)	51,110 visa holders, an increase of 30.4 per cent
•	India	38,450 visa holders, an increase of 23.0 per cent
•	United States of America	32,040 visa holders, an increase of 4.0 per cent
•	Germany	21,050 visa holders, an increase of 7.5 per cent

Student visa holders

The number of student visa holders in Australia on 31 December 2014 was 303,170, an increase of 17.6 per cent compared with 257,780 on 31 December 2013.

The five countries with the largest number of student visa holders in Australia on 31 December 2014 were:

•	China (excl SARs)	62,030 visa holders, an increase of 14.1 per cent from 31 December 2013
•	India	43,760 visa holders, an increase of 44.7 per cent
•	Vietnam	18,400 visa holders, an increase of 11.5 per cent
•	Nepal	15,710 visa holders, an increase of 26.9 per cent
•	South Korea	14,550 visa holders, an increase of 5.3 per cent

Working holiday maker visa holders

The number of working holiday maker visa holders in Australia on 31 December 2014 was 160,940, a decrease of 10.1 per cent compared with 178,980 on 31 December 2013.

The five countries with the largest number of working holiday maker visa holders in Australia on 31 December 2014 were:

•	United Kingdom	30,320 visa holders, a decrease of 1.8 per cent from 31 December 2013
•	Taiwan	23,270 visa holders, a decrease of 18.6 per cent
•	Germany	18,290 visa holders, a decrease of 5.1 per cent
•	South Korea	17,740 visa holders, a decrease of 23.1 per cent
•	France	15,680 visa holders, a decrease of 6.0 per cent

Temporary skilled visa holders

The number of temporary skilled (subclass 457) visa holders in Australia on 31 December 2014 was 167,910, a decrease of 0.7 per cent compared with 169 070 on 31 December 2013.

The five countries with the largest number of temporary skilled visa holders in Australia on 31 December 2014 were:

35,610 visa holders, an increase of 15.3 per cent from 31 December 2013 India 32,800 visa holders, a decrease of 15.6 per cent United Kingdom 10,660 visa holders, an increase of 3.8 per cent **Philippines** Ireland 10,490 visa holders, a decrease of 13.7 per cent China (excl SARs) 9580 visa holders, an increase of 21.0 per cent

Temporary graduate visa holders

The number of temporary graduate (subclass 485) visa holders in Australia on 31 December 2014 was 19,510, a decrease of 20.9 per cent compared with 24,660 on 31 December 2013.

The five countries with the largest number of temporary graduate visa holders in Australia on 31 December 2014 were:

China (excl SARs) 6250 visa holders, an increase of 7.7 per cent from 31 December 2013 3110 visa holders, a decrease of 49.5 per cent India 2220 visa holders, an increase of 10.4 per cent Nepal Pakistan 1070 visa holders, an increase of 16.6 per cent Vietnam 700 visa holders, a decrease of 15.4 per cent

Other temporary visa holders

The number of other temporary visa holders in Australia on 31 December 2014 was 31,300, an increase of 7.9 per cent compared with 29,010 on 31 December 2013.

The five countries with the largest number of other temporary visa holders in Australia on 31 December 2014 were:

United Kingdom 5060 visa holders, a decrease of 3.7 per cent from 31 December 2013 China (excl SARs) 3320 visa holders, an increase of 17.3 per cent 2470 visa holders, a decrease of 3.7 per cent United States of America India 1520 visa holders, an increase of 26.5 per cent South Korea 1170 visa holders, an increase of 2.5 per cent

Bridging visa holders

The number of bridging visa holders in Australia on 31 December 2014 was 89,980, a decrease of 3.1 per cent compared with 92,910 on 31 December 2013.

The five countries with the largest number of bridging visa holders in Australia on 31 December 2014 were:

India 12,060 visa holders, a decrease of 22.7 per cent from 31 December 2013 China (excl SARs) 7560 visa holders, an increase of 15.8 per cent Sri Lanka 6080 visa holders, an increase of 77.9 per cent **United Kingdom** 5580 visa holders, an increase of 7.2 per cent Iran 4780 visa holders, an increase of 209.9 per cent

New Zealand visa holders

The number of New Zealand (subclass 444) visa holders in Australia on 31 December 2014 was 623,440, a decrease of 0.3 per cent compared with 625.370 on 31 December 2013.

Total temporary entrants

Annual comparison

An estimated 1,864,730 temporary entrants were present in Australia on 31 December 2014, compared with 1,821,930 on 31 December 2013, an increase of 2.3 per cent over the period.


The three largest components in Australia on 31 December 2014 were New Zealand visa holders (623,440 visa holders and 33.4 per cent of the total), visitor visa holders (468,480 / 25.1 per cent) and student visa holders (303,170 / 16.3 per cent).

Of the major components, the number of student visa holders increased by 17.6 per cent from 31 December 2013, other temporary visa holders increased by 7.9 per cent and visitor visa holders increased by 5.5 per cent.

Total temporary entrants - continued

Quarterly comparison




Figure 2: Temporary entrants in Australia - quarterly historical series

The total number of temporary entrants in Australia on 31 December 2014 was 1,864,730, an increase of 5.4 per cent compared with 1,769,490 on 30 September 2014 (Figure 2). Of the major components, the number of New Zealand visa holders decreased by 5.1 per cent from 30 September 2014, visitor visa holders increased by 107.3 per cent and student visa holders decreased by 21.8 per cent.





Figure 3: Temporary entrants in Australia - percentage of top five citizenship countries

The top source citizenship country for temporary entrants in Australia on 31 December 2014 was New Zealand (623,650 visa holders), followed by United Kingdom (159,200), China (excl SARs) (139,840), India (134,510) and South Korea (51,740) (Figure 3).

Total temporary entrants - continued

When comparing the number of temporary entrants in Australia on 31 December 2014 with earlier years, Figure 4 shows that over the past five years, the number of temporary entrants from New Zealand increased by 18.2 per cent from 31 December 2009, United Kingdom increased by 5.2 per cent, China (excl SARs) increased by 36.4 per cent, India decreased by 0.6 per cent and South Korea decreased by 9.3 per cent.

Visitor visa holders




Figure 5: Visitor visa holders in Australia - annual historical series




Figure 6: Visitor visa holders in Australia - quarterly historical series

There were 468,480 visitor visa holders in Australia on 31 December 2014. This represents an increase of 5.5 per cent when compared with 444,140 on 31 December 2013 (Figures 5 and 6).

In the past five years, the quarter with the highest number of visitor visa holders in Australia was 31 December 2014 with 468,480 visa holders (Figure 6).




Figure 7: Visitor visa holders in Australia - percentage of top five citizenship countries

The top source citizenship country for visitor visa holders in Australia on 31 December 2014 was United Kingdom (82,370 visa holders), followed by China (excl SARs) (51,110), India (38 450), United States of America (32,040) and Germany (21,050) (Figure 7).




Figure 8: Visitor visa holders in Australia - top five citizenship countries trend

When comparing the number of visitor visa holders in Australia on 31 December 2014 with earlier years, Figure 8 shows that over the past five years, the number of visitor visa holders from United Kingdom decreased by 6.4 per cent from 31 December 2009, China (excl SARs) increased by 152.7 per cent, India increased by 127.8 per cent, United States of America increased by 18.8 per cent and Germany increased by 11.4 per cent.

Student visa holders

There were 303,170 student visa holders in Australia on 31 December 2014. This represents an increase of 17.6 per cent when compared with 257,780 on 31 December 2013 (Figure 9).




Figure 10: Student visa holders in Australia - quarterly historical series

In the past five years, the guarter with the highest number of student visa holders in Australia was 31 March 2010 with 425,880 visa holders (Figure 10).

The top source citizenship country for student visa holders in Australia on 31 December 2014 was China (excl SARs) (62,030 visa holders), followed by India (43,760), Vietnam (18 400), Nepal (15,710) and South Korea (14,550) (Figure 11).




Figure 12: Student visa holders in Australia - top five citizenship countries trend

When comparing the number of student visa holders in Australia on 31 December 2014 with earlier years, Figure 12 shows that over the past five years, the number of student visa holders from China (excl SARs) increased by 0.5 per cent from 31 December 2009, India decreased by 48.9 per cent, Vietnam increased by 39.4 per cent, Nepal decreased by 21.0 per cent and South Korea decreased by 18.7 per cent.

Working holiday maker visa holders




Figure 13: Working holiday maker visa holders in Australia - annual historical series

There were 160,940 working holiday maker visa holders in Australia on 31 December 2014. This represents a decrease of 10.1 per cent when compared with 178,980 on 31 December 2013 (Figure 13).




Figure 14: Working holiday maker visa holders in Australia - quarterly historical series

In the past five years, the quarter with the highest number of working holiday maker visa holders in Australia was 31 December 2013 with 178,980 visa holders (Figure 14).




Figure 15: Working Holiday Maker visa holders in Australia - percentage of top five citizenship countries

The top source citizenship country for working holiday maker visa holders in Australia on 31 December 2014 was United Kingdom (30,320 visa holders), followed by Taiwan (23,270), Germany (18,290), South Korea (17,740) and France (15,680) (Figure 15).




Figure 16: Working Holiday Maker visa holders in Australia - top five citizenship countries trend

When comparing the number of working holiday maker visa holders in Australia on 31 December 2014 with earlier years, Figure 16 shows that over the past five years, the number of working holiday maker visa holders from United Kingdom increased by 25.1 per cent from 31 December 2009, Taiwan increased by 238.3 per cent, Germany increased by 31.0 per cent, South Korea decreased by 28.0 per cent and France increased by 43.7 per cent.

Temporary skilled visa holders

There were 167,910 temporary skilled visa holders in Australia on 31 December 2014. This represents a decrease of 0.7 per cent when compared with 169,070 on 31 December 2013 (Figure 17).




Figure 18: Temporary skilled visa holders in Australia - quarterly historical series

In the past five years, the quarter with the highest number of temporary skilled visa holders in Australia was 31 March 2014 with 201,560 visa holders (Figure 18).




Figure 20: Temporary skilled visa holders in Australia - top five citizenship countries trend

When comparing the number of temporary skilled visa holders in Australia on 31 December 2014 with earlier years, Figure 20 shows that over the past five years, the number of temporary skilled visa holders from India increased by 177.3 per cent from 31 December 2009, United Kingdom increased by 19.2 per cent, Philippines decreased by 4.9 per cent, Ireland increased by 175.2 per cent and China (excl SARs) increased by 27.7 per cent.

Temporary graduate visa holders




Figure 21: Temporary graduate visa holders in Australia - annual historical series

There were 19,510 temporary graduate visa holders in Australia on 31 December 2014. This represents a decrease of 20.9 per cent when compared with 24,660 on 31 December 2013 (Figure 21).





Figure 22: Temporary graduate visa holders in Australia - quarterly historical series

In the past five years, the quarter with the highest number of temporary graduate visa holders in Australia was 31 March 2013 with 41,090 visa holders (Figure 22).



When comparing the number of temporary graduate visa holders in Australia on 31 December 2014 with earlier years, Figure 24 shows that over the past two years, the number of temporary graduate visa holders from China (excl SARs) increased by 14.6 per cent from 31 December 2012, India decreased by 80.0 per cent, Nepal decreased by 25.7 per cent, Pakistan increased by 0.5 per cent and Vietnam decreased by 10.2 per cent.

Figure 24: Temporary graduate visa holders in Australia - top five citizenship countries trend




Other temporary visa holders






Figure 27: Other temporary visa holders in Australia - percentage of top five citizenship countries

When comparing the number of other temporary visa holders in Australia on 31 December 2014 with earlier years. Figure 24 shows that over the past five years, the number of other temporary visa holders from United Kingdom decreased by 9.0 per cent from 31 December 2009, China (excl SARs) increased by 59.0 per cent, United States of America increased by 15.4 per cent, India increased by 66.5 per cent and South Korea decreased by 8.3 per cent.




Figure 28: Other temporary visa holders in Australia - top five citizenship countries trend

Bridging visa holders

Bridging visas provide lawful status to certain non-citizens who would otherwise be unlawful and therefore liable to be detained under the Migration Act 1958. Bridging visa A is granted to non-citizens who have had a substantive visa and who have made a valid application for a further substantive visa. Bridging visa B is granted to Bridging visa A holders who demonstrate substantial reasons for travel. Bridging visa C is granted to applicants who do not hold a substantive visa when they apply for a substantive visa while in Australia. Bridging visa E is granted to certain unlawful non-citizens in circumstances of compliance interest, including those who are making arrangements to depart Australia. Other Bridging visa classes are granted to non-citizens under other specific circumstances.




Figure 29: Bridging visa holders in Australia - annual historical series

There were 89,980 bridging visa holders in Australia on 31 December 2014. This represents a decrease of 3.1 per cent when compared with 92,910 on 31 December 2013 (Figure 29).




Figure 30: Bridging visa holders in Australia - quarterly historical series

In the past five years, the guarter with the highest number of bridging visa holders in Australia was 31 March 2012 with 132,320 visa holders (Figure 30).




Figure 31: Bridging visa holders in Australia - percentage of top five citizenship countries

The top source citizenship country for bridging visa holders in Australia on 31 December 2014 was India (12.060 visa holders), followed by China (excl SARs) (7560), Sri Lanka (6080), United Kingdom (5580) and Iran (4780) (Figure 31).




Figure 32: Bridging visa holders in Australia - top five citizenship countries trend

When comparing the number of bridging visa holders in Australia on 31 December 2014 with earlier years, Figure 32 shows that over the past five years, the number of bridging visa holders from India decreased by 18.0 per cent from 31 December 2009, China (excl SARs) increased by 4.6 per cent, Sri Lanka increased by 417.0 per cent, United Kingdom increased by 141.9 per cent and Iran increased by a significant percentage.




Figure 34: New Zealand subclass 444 visa holders in Australia - quarterly historical series
