## Background

The number of temporary entrants and New Zealand citizens physically present in Australia is estimated every three months by identifying those persons who have entered Australia on temporary visas or as New Zealand citizens, and who have neither left Australia nor been granted permanent residence. This data provides useful point-in-time information on temporary entrants. It gives a more accurate picture of the population impact of Australia's temporary entry programs than data on the flow of temporary entrants in and out of Australia.

The number of temporary entrants in this report are broken down by the following categories:

#### Visitor visa holders

non-permanent entrants to Australia whose visa is for tourism, short stay business, visiting relatives or medical treatment:

#### Student visa holders

overseas students who undertake full-time study in registered courses. In this report, Student Guardian (subclass 580) visa holders are included in 'other temporary visa holders' and not in the 'student visa holders' category;

#### Working Holiday Maker visa holders

young adults from countries with reciprocal bilateral agreements with Australia who holiday in Australia and undertake short-term work and/or study and who hold a Working Holiday (subclass 417) or Work and Holiday (subclass 462) visa;

#### Temporary Skilled (subclass 457) visa holders

Temporary Work (Skilled) subclass 457 visa holders mostly recruited by Australian companies whose visa is valid for up to four years;

#### Temporary Graduate (subclass 485) visa holders

overseas students who wish to remain in Australia for up to 18 months to gain skilled work experience or improve their English language skills and who hold a Temporary Graduate (subclass 485) visa;

#### Bridging visa holders

non-citizens who are provided with lawful status while they have business with the government or the courts regarding immigration matters;

#### Other Temporary visa holders

include holders of other temporary visas such as New Zealand Citizen Family Relationships (non-New Zealand citizens who are family members of a New Zealand citizen), social/cultural (Entertainment, Sport, Visiting Academic, Religious Worker, etc), international relations (Diplomatic, Exchange, Domestic Worker, etc), training (Occupational Trainee and Professional Development), Student Guardian, transit, Maritime Crew visas and Criminal Justice;

#### New Zealand visa holders

New Zealand citizens granted a Special Category Visa (subclass 444) on arrival in Australia. It should be noted that a small number of New Zealand citizens who were holding a temporary visa other than subclass 444 are included in the temporary visa category relating to the visa held.

#### Rounding in reported data

Figures given in this report are rounded to the nearest ten. Percentage changes are calculated from unrounded numbers. This may result in minor discrepancies from results calculated from rounded numbers.

#### Reporting of primary and secondary visa holders

Figures given in this report include both primary and secondary visa holders.

## **Executive summary**

#### Total temporary entrants and New Zealand citizens snapshot

There were 1,869,550 temporary entrants and New Zealand citizens in Australia on 30 September 2015, compared with 1,783,190 on 30 September 2014 (an increase of 4.8 per cent).

#### Temporary visa holders

The number of temporary visa holders, that is excluding New Zealand citizens on Special Category (subclass 444) visas and bridging visa holders, was 1,093,610 on 30 September 2015 compared to 1,031,140 on 30 September 2014, an increase of 6.1 per cent.

#### Quarterly comparison

Compared with 30 June 2015, the end of the previous quarter, the number of temporary visa holders as at 30 September 2015 is an increase of 8.4 per cent from 1,009,220 to 1,093,610.

The percentage change in the major components from 30 June 2015 to 30 September 2015 was:

- Visitor visa holders an increase of 14.0 per cent;
- Student visa holders an increase of 13.7 per cent;
- Working Holiday Maker visa holders an increase of 0.4 per cent;
- Temporary Skilled (subclass 457) visa holders a decrease of 0.6 per cent;
- Temporary Graduate (subclass 485) visa holders a decrease of 2.8 per cent;
- · Other Temporary visa holders an increase of 5.8 per cent.

These changes are in line with usual seasonal patterns.

#### Visitor visa holders

The number of Visitor visa holders in Australia on 30 September 2015 was 258,910, an increase of 14.6 per cent compared with 226,010 on 30 September 2014.

The number of Temporary Skilled (subclass 457) visa holders in Australia on 30 September 2015 was 186,810, a decrease of 5.1 per cent compared with 196,930 on 30 September 2014.

#### New Zealand visa holders

The number of New Zealand (subclass 444) visa holders in Australia on 30 September 2015 was 661,550, an increase of 0.7 per cent compared with 657,210 on 30 September 2014.

## Total temporary entrants

#### Annual comparison

An estimated 1,869,550 temporary entrants were present in Australia on 30 September 2015, compared with 1,783,190 on 30 September 2014, an increase of 4.8 per cent over the period.

The three largest components in Australia on 30 September 2015 were New Zealand visa holders (661,550 visa holders and 35.4 per cent of the total), Student visa holders (425,740 / 22.8 per cent) and visitor visa holders (258,910 / 13.8 per cent).



Of the major components, the number of bridging visa holders increased by 20.6 per cent from 30 September 2014, Temporary Graduate (subclass 485) visa holders increased by 16.2 per cent and Visitor visa holders increased by 14.6 per cent.

## Total temporary entrants - continued

#### Quarterly comparison




Figure 2: Temporary entrants in Australia - quarterly historical series

The total number of temporary entrants in Australia on 30 September 2015 was 1,869,550, an increase of 5.9 per cent compared with 1,765,270 on 30 June 2015 (Figure 2). Of the major components, the number of New Zealand visa holders increased by 1.2 per cent from 30 June 2015, Student visa holders increased by 13.7 per cent and Visitor visa holders increased by 14.0 per cent.




Figure 3: Temporary entrants in Australia - percentage of top five citizenship countries

The top source citizenship country for temporary entrants in Australia on 30 September 2015 was New Zealand (661,770 visa holders), followed by China (excl SARs) (207,200), India (148,180), United Kingdom (102,590) and South Korea (51,000) (Figure 3).

## Total temporary entrants - continued

When comparing the number of temporary entrants in Australia on 30 September 2015 with earlier years, Figure 4 shows that over the past five years, the number of temporary entrants from New Zealand increased by 15.3 per cent from 30 September 2010, China (excl SARs) increased by 45.8 per cent, India increased by 8.4 per cent, United Kingdom increased by 12.3 per cent and South Korea decreased by 7.8 per cent.

## Visitor visa holders




Figure 5: Visitor visa holders in Australia - annual historical series




Figure 6: Visitor visa holders in Australia - quarterly historical series

There were 258,910 Visitor visa holders in Australia on 30 September 2015. This represents an increase of 14.6 per cent when compared with 226,010 on 30 September 2014 (Figures 5 and 6).

In the past five years, the quarter with the highest number of Visitor visa holders in Australia was 31 December 2014 with 468,480 visa holders (Figure 6).

## Visitor visa holders - continued




Figure 7: Visitor visa holders in Australia - percentage of top five citizenship countries

The top source citizenship country for Visitor visa holders in Australia on 30 September 2015 was China (excl SARs) (62,060 visa holders), followed by India (35,260), United Kingdom (25,230), United States of America (13,070) and Malaysia (11,800) (Figure 7).




Figure 8: Visitor visa holders in Australia - top five citizenship countries trend

When comparing the number of Visitor visa holders in Australia on 30 September 2015 with earlier years, Figure 8 shows that over the past five years, the number of Visitor visa holders from China (excl SARs) increased by 158.2 per cent from 30 September 2010, India increased by 131.3 per cent, United Kingdom decreased by 6.1 per cent, United States of America decreased by 1.6 per cent and Malaysia increased by 55.5 per cent.

## Student visa holders




Figure 9: Student visa holders in Australia - annual historical series

There were 425,740 Student visa holders in Australia on 30 September 2015. This represents an increase of 9.8 per cent when compared with 387,800 on 30 September 2014 (Figure 9).




Figure 10: Student visa holders in Australia - quarterly historical series

In the past five years, the guarter with the highest number of Student visa holders in Australia was 30 September 2015 with 425,740 visa holders (Figure 10).




Figure 11: Student visa holders in Australia - percentage of top five citizenship countries

The top source citizenship country for Student visa holders in Australia on 30 September 2015 was China (excl SARs) (108,140 visa holders), followed by India (51,350), Vietnam (21,550), Malaysia (17,720) and South Korea (17,580) (Figure 11).




Figure 12: Student visa holders in Australia - top five citizenship countries trend

When comparing the number of Student visa holders in Australia on 30 September 2015 with earlier years, Figure 12 shows that over the past five years, the number of Student visa holders from China (excl SARs) increased by 13.4 per cent from 30 September 2010, India decreased by 26.6 per cent, Vietnam increased by 21.8 per cent, Malaysia decreased by 8.1 per cent and South Korea decreased by 19.5 per cent.

## Working Holiday Maker visa holders

There were 144,450 Working Holiday Maker visa holders in Australia on 30 September 2015. This represents a decrease of 4.5 per cent when compared with 151,220 on 30 September 2014 (Figure 13).




Figure 14: Working Holiday Maker visa holders in Australia - quarterly historical series

In the past five years, the quarter with the highest number of Working Holiday Maker visa holders in Australia was 31 December 2013 with 178,980 visa holders (Figure 14).




Figure 15: Working Holiday Maker visa holders in Australia - percentage of top five citizenship countries

The top source citizenship country for Working Holiday Maker visa holders in Australia on 30 September 2015 was United Kingdom (28,540 visa holders), followed by Taiwan (20,150), South Korea (18,100), Germany (13,770) and France (13,020) (Figure 15).




Figure 16: Working Holiday Maker visa holders in Australia - top five citizenship countries trend

When comparing the number of Working Holiday Maker visa holders in Australia on 30 September 2015 with earlier years, Figure 16 shows that over the past five years, the number of Working Holiday Maker visa holders from United Kingdom increased by 34.8 per cent from 30 September 2010, Taiwan increased by 167.4 per cent, South Korea decreased by 16.3 per cent, Germany increased by 26.9 per cent and France increased by 55.8 per cent.

## Temporary Skilled (subclass 457) visa holders

There were 186,810 Temporary Skilled (subclass 457) visa holders in Australia on 30 September 2015. This represents a decrease of 5.1 per cent when compared with 196,930 on 30 September 2014 (Figure 17).




Figure 18: Temporary Skilled (subclass 457) visa holders in Australia - quarterly historical series




Figure 20: Temporary Skilled (subclass 457) visa holders in Australia - top five citizenship countries trend

When comparing the number of Temporary Skilled (subclass 457) visa holders in Australia on 30 September 2015 with earlier years, Figure 20 shows that over the past five years, the number of Temporary Skilled (subclass 457) visa holders from India increased by 168.3 per cent from 30 September 2010, United Kingdom increased by 6.7 per cent, Philippines decreased by 2.7 per cent, China (excl SARs) increased by 101.3 per cent and Ireland increased by 87.7 per cent.

## Temporary Graduate (subclass 485) visa holders

There were 25,520 Temporary Graduate (subclass 485) visa holders in Australia on 30 September 2015. This represents an increase of 16.2 per cent when compared with 21,970 on 30 September 2014 (Figure 21).





Figure 22: Temporary Graduate (subclass 485) visa holders in Australia - quarterly historical series



When comparing the number of Temporary Graduate (subclass 485) visa holders in Australia on 30 September 2015 with earlier years. Figure 24 shows that over the past two years, the number of Temporary Graduate (subclass 485) visa holders from China (excl SARs) increased by 42.5 per cent from 30 September 2013, India decreased by 50.3 per cent. Nepal increased by 7.9 per cent. Pakistan increased by 14.9 per cent and Vietnam increased by 6.5 per cent.

Figure 24: Temporary Graduate (subclass 485) visa holders in Australia - top five citizenship countries trend










Figure 27: Other Temporary visa holders in Australia - percentage of top five citizenship countries

When comparing the number of Other Temporary visa holders in Australia on 30 September 2015 with earlier years, Figure 24 shows that over the past five years, the number of Other Temporary visa holders from Philippines increased by 39.4 per cent from 30 September 2010, China (excl SARs) increased by 86.2 per cent, United Kingdom decreased by 3.3 per cent, India increased by 56.5 per cent and United States of America increased by 34.2 per cent.




Figure 28: Other temporary visa holders in Australia - top five citizenship countries trend

## Bridging visa holders

Bridging visas provide lawful status to certain non-citizens who would otherwise be unlawful and therefore liable to be detained under the Migration Act 1958. Bridging visa A is granted to non-citizens who have had a substantive visa and who have made a valid application for a further substantive visa. Bridging visa B is granted to Bridging visa A holders who demonstrate substantial reasons for travel. Bridging visa C is granted to applicants who do not hold a substantive visa when they apply for a substantive visa while in Australia. Bridging visa E is granted to certain unlawful non-citizens in circumstances of compliance interest, including those who are making arrangements to depart Australia. Other Bridging visa classes are granted to non-citizens under other specific circumstances.




Figure 29: Bridging visa holders in Australia - annual historical series

There were 114,390 Bridging visa holders in Australia on 30 September 2015. This represents an increase of 20.6 per cent when compared with 94.840 on 30 September 2014 (Figure 29).




Figure 30: Bridging visa holders in Australia - quarterly historical series




Figure 31: Bridging visa holders in Australia - percentage of top five citizenship countries




Figure 32: Bridging visa holders in Australia - top five citizenship countries trend




Figure 34: New Zealand (Special Category 444) visa holders in Australia - quarterly historical series
