In the 2018-19 program year to 30 June 2019:

• 43,650 temporary resident (skilled) visa holders were granted permanent residence or a provisional visa, an increase of 9.7 per cent compared with the same period in the previous program year (39,810);

the vast majority of permanent visa grants to TSS and subclass 457 visa holders were in the economic migration stream (96.9 per cent), with the remaining permanent visa grant
