Pathways to permanent residence

In the 2022-23 program year to 30 September 2022:

- 6,060 temporary resident (skilled) visa holders were granted permanent residence or a provisional visa, an increase of 9.3 per cent compared with the same period in the previous program year (5,550);
- the majority of permanent visa grants, 65.7 per cent, were to visa holders in the employer sponsored stream.
